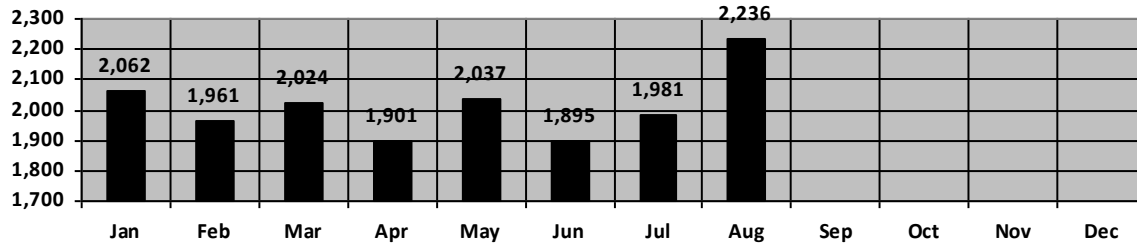
ITEMS OF INTEREST

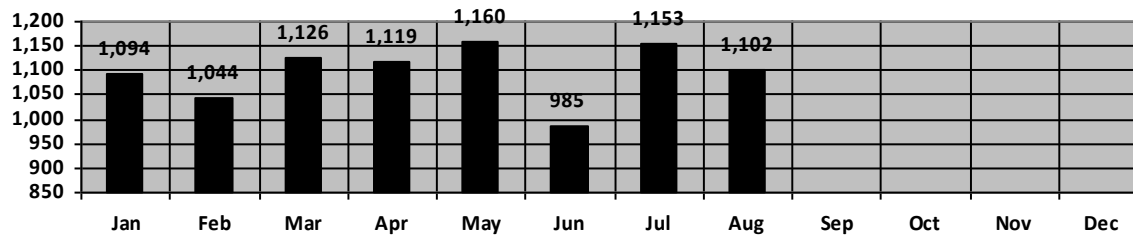

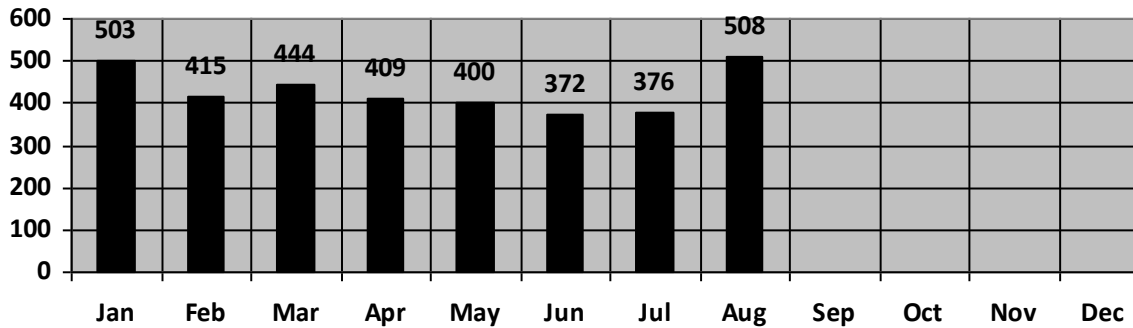
Police Dispatched Calls



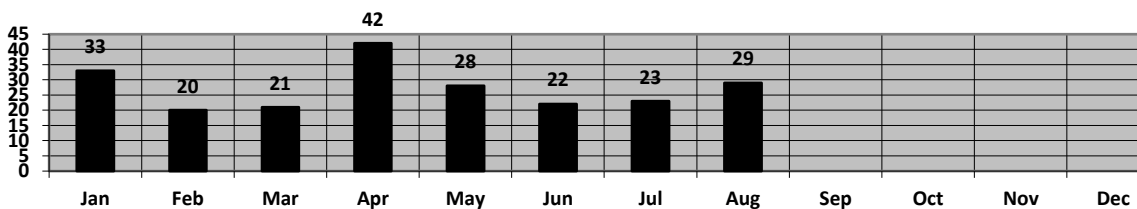
All Fire Dispatched Calls

COMMUNICATIONS DIVISION

Together as One

Our communications division was audited by representatives from Texas DPS. All issues were resolved in accordance with their request.

Socorro, Clint, Horizon, San Elizario and Ysleta Del Sur Tribal Fire Departments responded to a structure fire involving a large recreational vehicle. The recreational vehicle was located under a fully engulfed carport. The fire spread to a building where forklifts, tractors, trucks, and all-terrain vehicles were being stored. Several propane tanks were also inside the building causing explosions. The fire was extinguished approximately three hours later. The scene was turned over to the Fire Marshals for further investigation. No injuries were reported.

The Fabens Fire Department responded to a vehicle fire involving a commercial truck. The vehicle was fully engulfed. The driver was transported to a local hospital by Life Ambulance immediately. The fire was extinguished approximately forty minutes later.

Horizon, Clint, Socorro, and Montana Vista Fire Departments responded to a structure fire involving a mobile home fully engulfed. The American Red Cross, Life Ambulance and a Fire Marshal from El Paso Fire Department were requested to the scene. The fire was extinguished approximately three hours later.

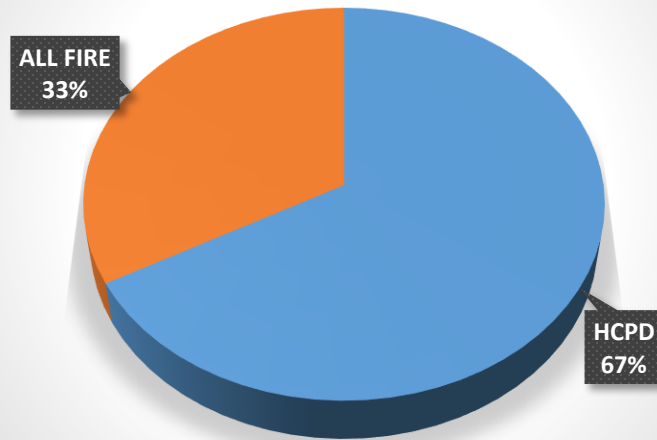
The Clint Fire Department responded to a fully engulfed vehicle fire in Clint. No injuries were reported. The fire was extinguished and the vehicle was removed by a wrecking service.

Montana Vista and Horizon Fire Departments responded to a structure fire at the Dollar General. Prior to the fire departments arrival, the building was evacuated. Upon investigation, a freezer inside the retail store was sparking and releasing smoke. The freezer was unplugged and removed.

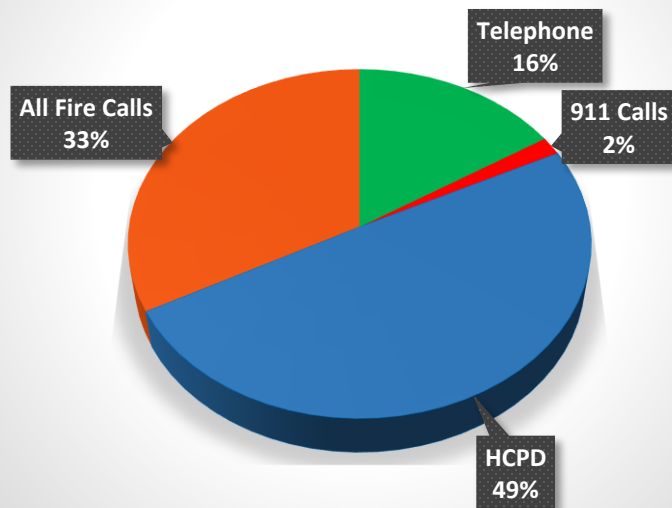
West Valley Fire Department responded to a structure fire in Canutillo. Upon arrival, the fire department reported a vehicle was on fire underneath a porch attached to the residence. The West Valley Fire Department had the fire under control within minutes. A Fire Marshal was requested for further investigation.

WARRANTS DIVISION & FLEET OPERATIONS

The Warrants Officer received 50 summons for service. Forty-eight summons were executed and two were returned to the courts unserved. Ten people were arrested for traffic warrants and booked in the El Paso County Jail. Collections were made on several traffic warrants. The Warrants Officer reviewed 11 Child Protective Services cases. The cases were reviewed and closed, or filed with the corresponding case due to allegations of neglect. The Warrants Officer took four vehicles to the shop for oil changes and repairs. Bailiff duties were conducted during court proceedings.

CRIMINAL INVESTIGATIONS/EVIDENCE

During the month of August, Detective Nunez and Detective Labrado investigated cases ranging from criminal mischief to fraud. The detectives are investigating an aggravated robbery case and are currently working on leads to identify the suspect. Additional information is being obtained for the case to make an arrest. An unattended death of an elderly person was investigated by the detectives. The case was ruled out as accidental. Lieutenant Ortega attended monthly meetings with the JOIC, STARS, Gang, and SHOCAP.

FORENSICS UNIT

The evidence technician conducted nine open records requests for video from the officer's body cameras. The District Attorney's Office submitted three requests for videos for cases ranging from DWI to assaults. Twenty-two items of evidence were submitted to the Texas Department of Public Safety for drug analysis.

CRIME PREVENTION ACTIVITIES

Community Activities

El Paso County Sheriff's Office National Night Out Event- On August 7, 2018 Horizon City officers and explorers participated in the National Night Out held by the El Paso County Sheriff's Office at the EPCSO headquarters. During this event, our agency displayed three vehicles, a marked Ford F250, an All-Terrain Vehicle, and our evidence collection vehicle. Officers were accompanied by members of the HCPD explorer program who displayed a weapons and contraband case as well as firearms and tactical vest used by our police officers.

Socorro Independent School District School Safety Summit Event- On August 18, 2018 Horizon City Officers and explorers participated in a School Safety Summit organized by the Socorro Independent School District Police Department. Officers of the SISD presented the community with information regarding campus incident preparation and the HCPD and explorers presented the community with information regarding our TIP 411 services as well as information on the HCPD explorer program.

Eastlake High School Falconpalooza Football Booster Event- Officers of the HCPD attended this event which was coordinated by the Eastlake High School band boosters.
