




ITEMS OF INTEREST


- A new 911 voice logging recorder was installed for dispatch. This recorder replaces a similar device that was at end-of-life.

- Chief McConnell met with members of Ysleta Border Patrol to review the Operation Stonegarden Grant.

















COMMUNICATIONS DIVISION Together as One

The West Valley Fire Department responded to a structure fire in New Mexico. The



Mesilla Valley Regional Dispatch Authority requested assistance from the West Valley Fire Department to extinguish a mobile home on fire. Once on the scene, the fire department advised of a double-wide trailer on fire. The fire went across the attic from one side to the other. The fire was extinguished, and the West Valley Fire Department cleared the scene.

The Socorro, Horizon, Clint, and the Fabens Fire Departments responded to a vehicle fire on the Gateway. Multiple callers

advised of flames and smoke coming from a semi-truck fully engulfed. An El Paso County Sheriff's Deputy reported the flames were in the rear end of the semi-truck. Several units responded along with Socorro Police Department officers. The East and Westbound lanes on the I-10 were shut down for traffic control. Crews cleared after extinguishing the fire. The scene was turned over to law enforcement on the scene.

The San Elizario Fire Department responded to a motor vehicle accident with possible injuries. Multiple callers witnessed the vehicle ran into a gas meter and rolled over into a front yard. One caller mentioned a loud explosion and the smell of gas. The Ysleta Del Sur Pueblo Fire Department and Texas Gas were requested to the scene for assistance. Both lanes on Socorro Road were closed off for traffic control. Fire crews cleared, and the location was turned over to the El Paso Sherriff's Office.

The Montana Vista Fire Department responded to an injured hiker at the Hueco Tanks State Park & Historic Site. While the injury was reportedly non-life-threatening, it left the hiker immobilized and stranded in the middle of the park. The Search and Rescue Team was activated, and Native Air was requested to be on standby. The Department of Public Safety arrived on the scene to assist with air support. Two Parks and Wild Life Rangers responded to the scene to assist. The patient was transported down from the mountain and transported to a local hospital by Life Ambulance.

The Fabens Fire Department responded to a multi-vehicle accident on I-10 westbound in Tornillo. Multiple callers advised of the accident involving three tractor-trailers and two passenger vehicles. Upon arrival, the Fabens Fire Department advised of a tractortrailer on fire. Fire crews worked quickly to extinguish the fire and tend to multiple patients on the scene. The El Paso Sheriff's Office deputies assisted in diverting traffic off the interstate at the Tornillo exit ramp. Fire crews cleared, and the scene was referred to the El Paso Sheriff's Office.

The San Elizario and Clint Fire Departments responded to a vehicle fire in San Elizario. Several callers advised of visible flames and smoke coming from vehicles at an automotive shop. The owner of the business advised of at least three vehicles on fire with multiple explosions heard. The business occupants evacuated to the rear of the building and had to wait for fire crews to extinguish the fire to exit the property due to the nearby building's immediate threat. The El Paso Electric responded about a damaged electrical line. A fire investigator was requested to the scene, and all fire units cleared.

INFORMATION TECHNOLOGY

Twenty-six support tickets were submitted, completed and closed, including three major projects. The major projects included:

- Portable network wiring
- iPads updating and configuring
- Courts Scanner setup

In addition to the major projects above, IT staff responded to various tech support requests.

WARRANTS DIVISION & FLEET OPERATIONS

The warrants officer received five summonses from the court which were served. There were fifteen arrests for outstanding traffic warrants. The warrants officer reviewed ten Child Protective Services cases. The cases were reviewed and closed, or filed with the corresponding case due to allegations of neglect. Bailiff duties were conducted during court proceedings via zoom. The bailiff also helped by maintaining the six-foot distance while people entered the court for payment services.

CRIMINAL INVESTIGATIONS/EVIDENCE

Detectives Rodriguez and Labrado investigated cases ranging from criminal mischief fraud, accidents involving property damage, and coercion. Detectives continue working on leads in an attempt to locate suspect(s) involved in a criminal mischief at the golf course. Detectives also took an online training from the child advocacy center. Ten criminal cases were presented to the District Attorney's Office for prosecution. Lieutenant Ortega signed 40-cases at the District Attorney's Office. All the cases were accepted for prosecution. Lieutenant Ortega attended several meetings via zoom as well as in person. Some of the sessions were with Sheriff's Office, STARS, and Border Patrol for Operation Stonegarden.

FORENSICS UNIT

The evidence technician conducted eight open records requests for video from the officer's body cameras. The District Attorney's Office submitted ten requests for videos for cases ranging from DWI to assaults. Three evidence items were submitted to the Texas Department of Public Safety crime lab. These items included drugs and blood kits submitted for analysis. The Forensic Technician assisted with fingerprinting nine people that came into the station.

CRIME PREVENTION/COMMUNITY SERVICES

Coffee With A Cop

Resulting from the ongoing COVID-19 pandemic, the police department has had to find alternatives to meeting with community members in person. Sergeant Mitre has responded to several community issues reported via Tip411, Facebook Messenger, and via telephone. Such concerns and complaints included:

- "Abandoned" vehicles in the Nazareno/ Maravillas neighborhoods
- "Abandoned" vehicles in the Desert Fire/ Desert Sage neighborhoods
- "Abandoned" vehicles in the Lago Grande/ Lago Seco neighborhoods

Red parking violation tags were placed on illegally parked vehicles. Over 32 vehicles are now in compliance with parking regulations. Only two vehicles had to be impounded.

Child Passenger Seat Inspections

There were no requests for child passenger seat inspections.

Community Partnerships

Aliviane- Sergeant Mitre attended a virtual meeting with the Aliviane Advocates for Prevention Coalition on September 10, 2020. Sean Semko hosted the meeting and the purpose of the meeting was to develop ideas for the distribution of Deterra prescription medication disposal pouches.

COVID-19 Modified Work Assignments

Sergeant Mitre was assigned to the patrol division. She is assigned to work various shifts to provide sufficient coverage. In addition, she was given the task of addressing common community complaints such as speeders in certain areas and neighborhood traffic issues.

Food Pantry Traffic Control

For the last few months, police officers assisted the Manantial Church on Nunda Drive to coordinate traffic flow during their weekly food pantry giveaway events. With numerous volunteers, the church manages hundreds of vehicles through a route designed to minimize traffic in Breaux Street, Catham Circle, and Nunda Drive. Officers direct traffic entering and exiting the church parking lot to reduce hazards to community members walking, jogging, and biking in the area, as well as vehicles driving through to enter the adjacent neighborhoods.

New features coming to HCPD website

Sergeant Mitre has been editing the department's website to allow users to access city ordinance parking enforcement information more simplistically. The website will work in conjunction with the department's new parking enforcement warning decals. The warning decals will feature a QR code that will direct a user to a web page pertaining to the department's city ordinances.
