Introduction

- **Fairness:** We are committed to equal application of the law to offenders and members of the public as well as the equal application of rules and regulations to all members of the department.
- **Courage:** We are dedicated to meeting all challenges with the courage needed to accomplish our mission.
- **Compassion:** We understand our role as community caretakers and temper our application of the law with compassion and empathy.

GOALS

- Decrease NIBRS Crimes by 10 percent.
- Increase public awareness of our department through transparency through in-person and media communication.
- Assist in developing our staff professionally by increasing training hours by 25%
- Achieve Commission on Accreditation for Law Enforcement Agencies Certification for Communications
- Add additional grant funding to supplement Department operations.

- Ensure requests for service from citizens are dispatched promptly
- Ensure public safety responders are provided with the necessary tactical and operational equipment and support to carry out their assigned duties
- Provide informational presentations to community members on crime related topics.

DEMOGRAPHICS

The Horizon City Police Department is comprised of 34 officers and 18 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

STAFFING

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 3 Lieutenants.

The Patrol Lieutenant oversees the four Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- The Patrol Division is overseen by a Lieutenant.
- Criminal Investigations Division overseen by a Lieutenant.
- Support and Administrative Functions are overseen by a Lieutenant.
- Communications Division overseen by the Communications Manager.

PATROL DIVISION

The Patrol Division is commanded by Lieutenant John C. Rodriguez. Daily activity data is compiled and analyzed in conjunction with our Criminal Investigation Division. The patrol division is comprised of 1 Lieutenant, 4 Sergeants, 2 Corporals and 16 Patrol Officers. They operate 24 hours a day, 7 days a week on 12-hour shifts. The shifts and days off rotate every 56 days.

Our Data Driven Approach to Traffic and Crime Safety is our patrol strategy designed to focus on the hot spot areas for accidents and criminal incidents. Below you will find charts for our top five collision areas, traffic contacts throughout the year, calls for service, and arrests year to date.

OFFICER RECOGNITIONS

January Officer Recognitions

From Assistant Chief Kluge

Each month, we recognize the “Top 2” Officers in four key categories, **R**eports, Arrests, Traffic Contacts, and Citations. This recognition highlights both outstanding monthly performance and the consistency shown by officers who continue to lead by example as we move into the new year.

January Performance Highlights

Officer Mark Alva began 2026 with a strong showing, leading the department in Reports (11). His continued productivity in his field training reflects a solid growing confidence in his patrol duties.

Officer Ericka Garza earned second in Reports (9), continuing her pattern of consistent performance that carried through the latter part of 2025 and into the new year.

Officer Daniel Trevino led the department in Arrests (5), reinforcing his reputation for proactive enforcement and effective case work.

Officers Alejandro Retana and Gustavo Chavez tied for second in Arrests (4 each), demonstrating continued reliability and presence in enforcement activity.

Officer Marcos Calvillo once again stood out in Traffic Contacts, leading the department with 51, while Officer Jesus Venegas followed closely with 50, marking a strong debut on the 2026 "Top 2" list and emphasizing the department's continued focus on visibility and traffic safety.

In Citations, Officer Eric Delgadillo led the department with 21, while Officer Marcos Calvillo earned second with 19, further extending his long-standing consistency across multiple categories.

Historical Highlights & Continued Performers

- Officer Marcos Calvillo (#340) – Continues his long-running consistency from 2025 into 2026, appearing again in Traffic Contacts and Citations.
- Officer Ericka Garza (#289) – Sustained her strong performance from late 2025 with continued recognition in Reports.
- Officer Daniel Trevino (#310) – Returned to the "Top 2" list with a leading role in Arrests, maintaining his enforcement presence.
- Officer Gustavo Chavez (#257) – Continued to appear among top arrest producers, consistent with prior-year performance.

New & Notable Contributions

January marked a strong start to the year with Officer Jesus Venegas earning his first "Top 2" recognition in Traffic Contacts, highlighting the depth of proactive enforcement across the department as 2026 begins.

Officer Eric Delgadillo made a strong start to 2026 by leading the department in Citations (21). This proactive enforcement and attention to detail reflect a solid commitment to traffic safety and accountability, setting a positive tone for the new year and reinforcing the department's focus on consistent, high-quality enforcement.

Outstanding work by all officers recognized this month. Your professionalism, dedication, and consistency continue to set the tone for a strong year ahead.

TRAFFIC AND COMMERCIAL MOTOR VEHICLE SECTION

Motorcycle Traffic Enforcement

Officer Fernando Medina started with Horizon City Police Department in June 2025. He brings many years of experience being a retired Sheriff's Officer Motor Officer. The motorcycle's nimble mobility further enables the officer to swiftly traverse the city, providing valuable assistance to fellow officers during calls for service. This enhanced responsiveness and versatility contribute significantly to our overall law enforcement capabilities and community safety efforts. The addition of a motorcycle officer has proven to be an asset in addressing dynamic situations and optimizing our resources for effective public service. The Police Department hired a full-time motorcycle officer in May, bringing a much-needed resource to the community.

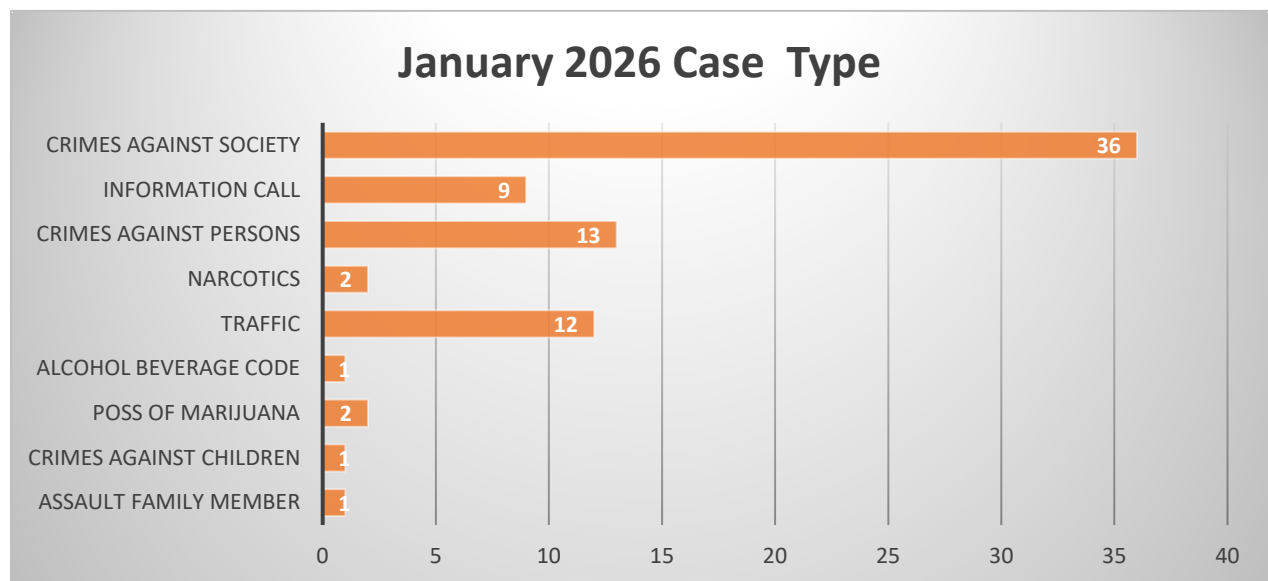

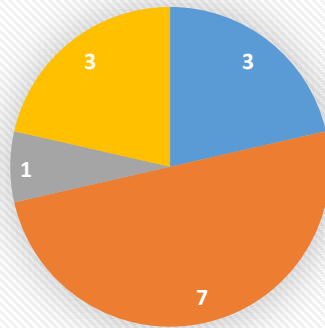

CASES BY TYPE, CASE RESOLUTION, AND CASELOAD

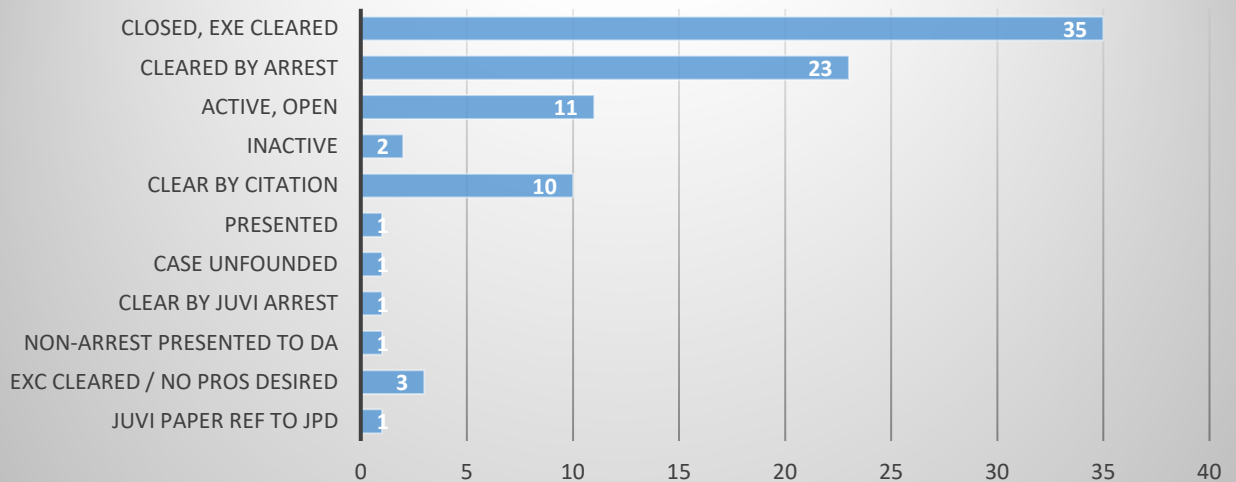


Caseload by Investigator

NOTABLE ACTIVITIES FOR CID

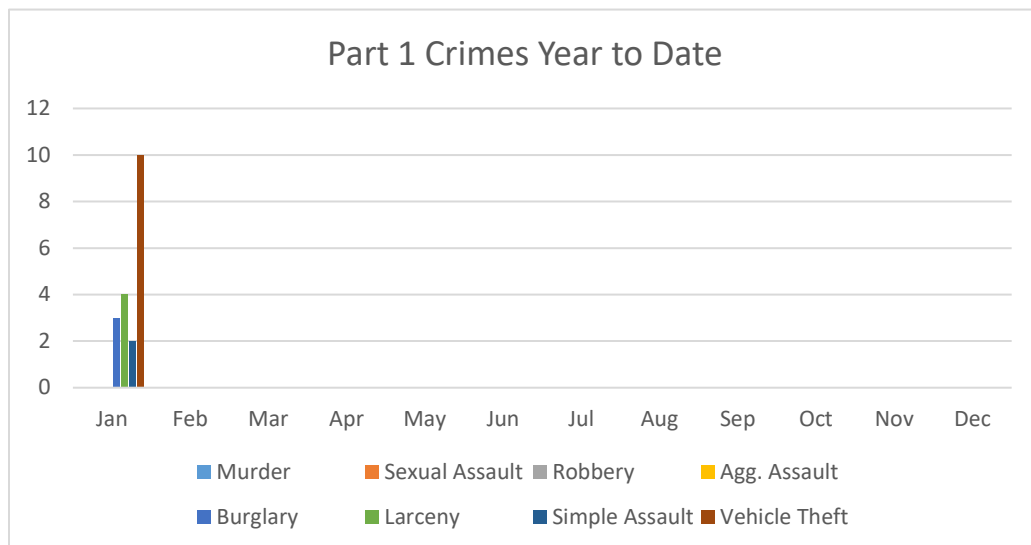
In January, HCPD's Criminal Investigations Division handled several high priority cases, one of which required immediate and sustained focus. Detectives were alerted to a situation involving a man accused of keeping his live-in girlfriend against her will and assaulting her over the course of several days.

With the victim's safety at the forefront, CID moved fast. The team and their supervisors worked through the night, following leads across the El Paso region. Hours of determined legwork led them to a Walmart in Northeast El Paso, where the suspect was located and taken into custody.

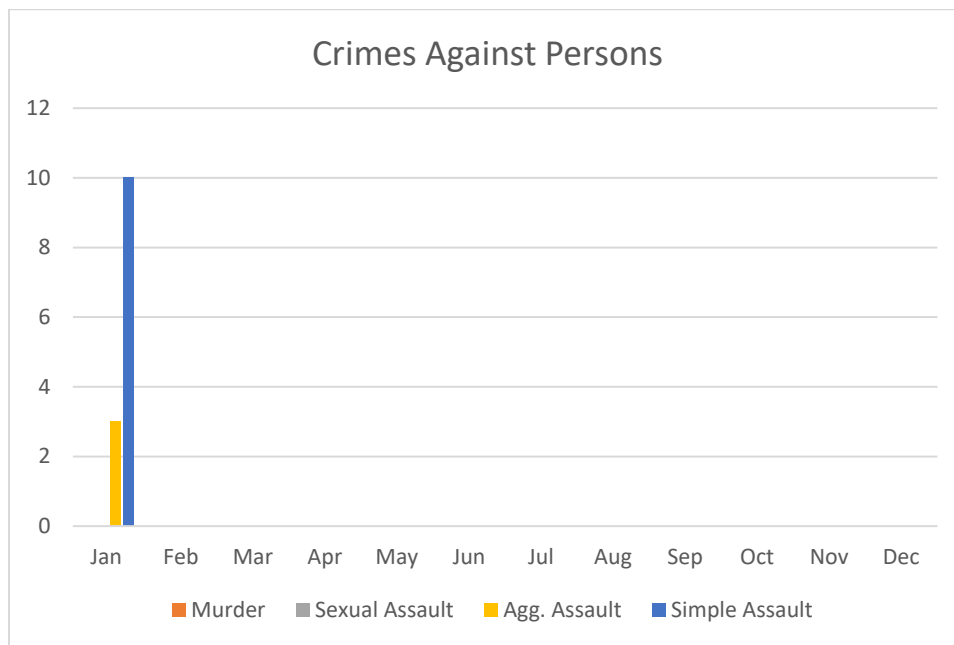

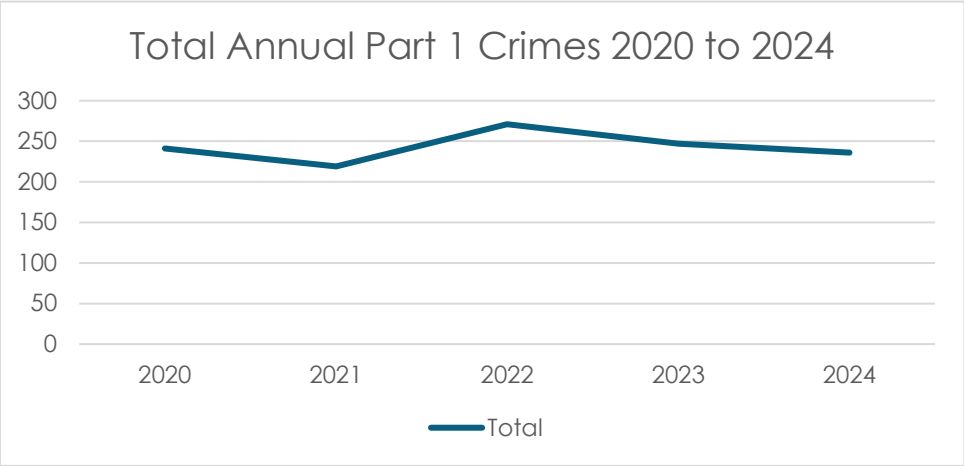
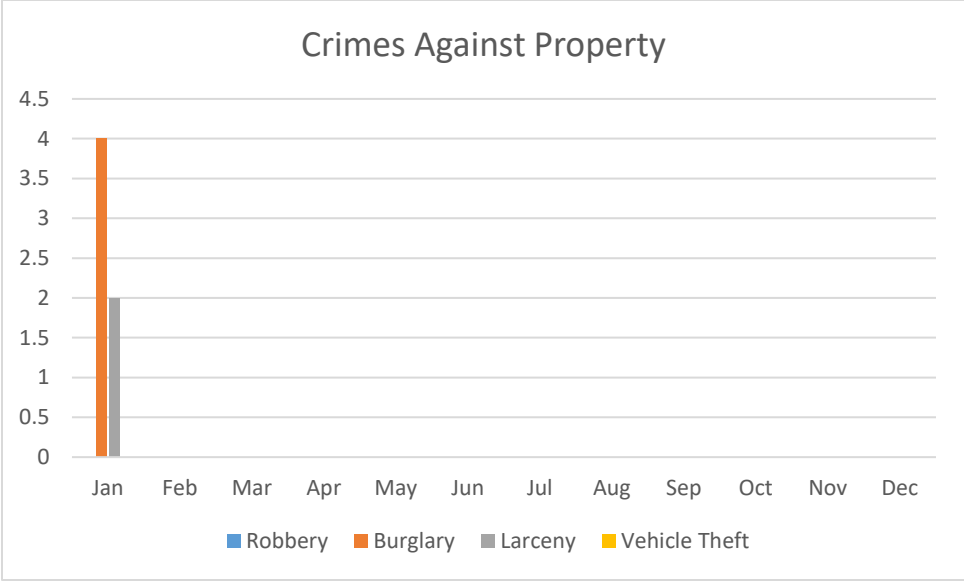

ADMINISTRATION DIVISION

WARRANTS DIVISION AND BAILIFF

Officers who take on the bailiff assignment perform a multifaceted role within the law enforcement department, serving as the Court Bailiff and the Warrants Officer. Their contributions make them an indispensable member of our law enforcement team. As the primary point of contact for matters pertaining to the municipal court, convened biweekly, the officers ensure the seamless functioning of court proceedings.

Executing traffic warrants and referring arrestees to the municipal court benefits the community by enhancing public safety and promoting legal compliance. Addressing outstanding warrants ensures that individuals who might be driving illegally are held accountable, reducing the risk of

traffic incidents and improving road safety. Additionally, this process encourages adherence to traffic laws, fostering a culture of lawfulness and responsibility among drivers.

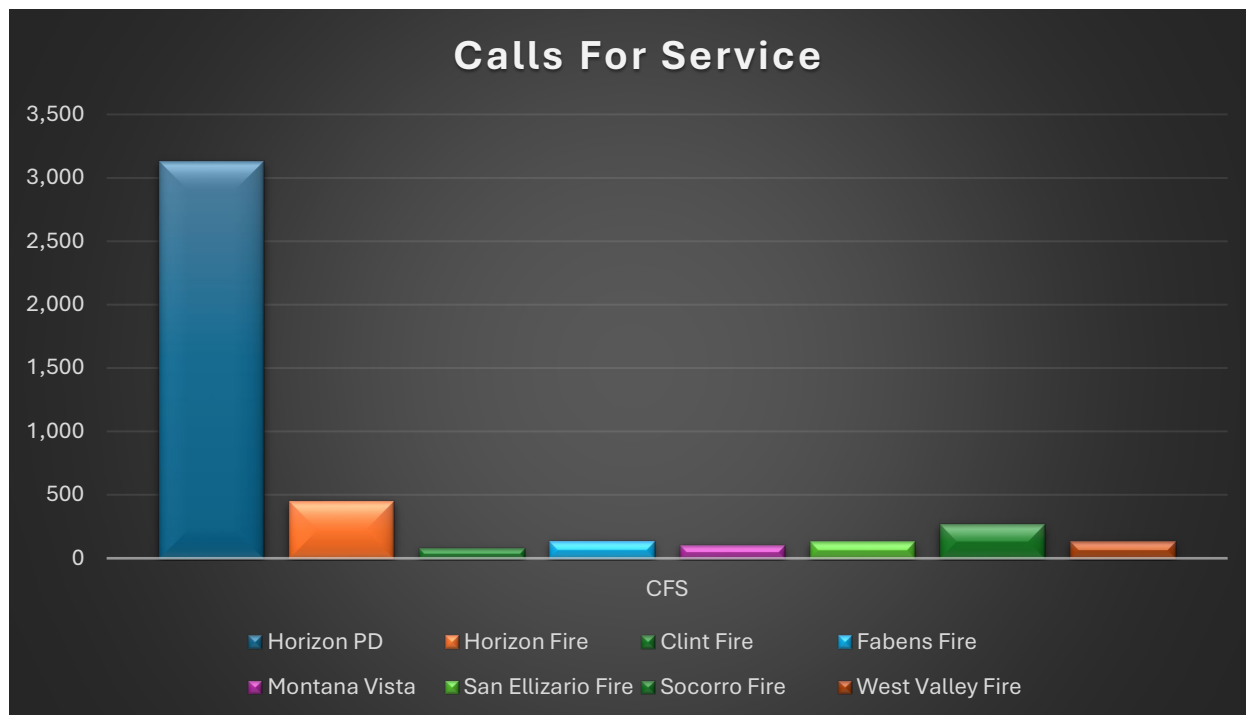
