## **Horizon City Police Department Monthly Report**

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

#### **Demographics**

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

#### **Staffing**

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Criminal Investigations Division overseen by the Assistant Chief
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police



## **Patrol Division**

The Patrol Division is commanded by Lieutenant Jesus Ortega. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 12 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.




## **Criminal Investigations Division**


#### **Investigations**


Lieutenant Kaycee Valdez oversees our Criminal Investigations Division, where a team of dedicated professionals is responsible for examining a broad array of criminal cases. This unit is comprised of three detectives who handle cases ranging from misdemeanors to more serious felony offenses.

Their job involves digging into these cases, collecting evidence, and working closely with various partners to bring investigations to a conclusion. Lieutenant Valdez and her team are committed to upholding the law and ensuring the safety of our community through their hard work and dedication.









#### **Notable Activities for CID, Traffic, Forensics & Warrants Section:**

Detective Labrado, a highly skilled and accomplished member of our investigations team was assigned to work alongside the FBI. This experience will prepare Detective Labrado to investigate major crimes in our community upon his return.

Bruce Campbell, a tried-and-true patrol officer with over a decade of experience was selected to join the detective squad. Officer Campbell has served our agency as a Field Training Officer and will be a truly valuable addition to the investigations team.

Our specialized traffic investigations team (STI) quickly and meticulously completed the investigation of a tragic traffic accident which claimed the life of a 17-year-old boy as he walked to work. The offending driver was found to have previous convictions of Driving While Intoxicated and was charged with Intoxication Manslaughter.

#### **Traffic Division**

Officer Eric Delgadillo assumes the responsibility of enforcing commercial vehicle regulations, conducting thorough inspections to address both minor administrative discrepancies, colloquially referred to as "paper" infractions, and more significant lapses in essential safety equipment maintenance.

His contribution is instrumental in mitigating potential risks that could result in severe accidents. Officer Delgadillo's efforts contribute significantly to upholding road safety standards and ensuring compliance within the commercial transportation sector, as evidenced by his commitment to addressing and rectifying regulatory violations.

Every detailed roadside inspection can take upwards of 2 hours to complete. During the month of February, Officer Eric Delgadillo conducted 13 inspections and found 13 commercial vehicles not road worthy.

The motorcycle's nimble mobility further enables the officer to swiftly traverse the city, providing valuable assistance to fellow officers during calls for service. This enhanced responsiveness and versatility contribute significantly to our overall law enforcement capabilities and community safety efforts. The addition of a motorcycle officer has proven to be an asset in addressing dynamic situations and optimizing our resources for effective public service.

## **Warrants Division and Bailiff**

Officer Abraham Diaz assumes a multifaceted role within the law enforcement department, serving as the Court Bailiff and the Warrants Officer. His contributions make him an indispensable member of our law enforcement team. As the primary point of contact for matters pertaining to the municipal court, convened biweekly, Officer Diaz ensures the seamless functioning of court proceedings.

#### **SORT Program**

Our SORT program is led by Officer Victoria Hernandez. SORT stands for "Sex Offender Registry and Tracking". The programs is designed to maintain a database of individuals convicted of sex offenses, providing law our agency with the tools to monitor and track registered sex offenders within our jurisdiction. Our program is currently under development and will empower our agency to monitor these individuals closely.



The communications manager and shift supervisors attended a virtual two-hour Responding to and Investigating Hoax Bomb Threats and Swatting. The training provided



attendees with a synopsis of the realities of bomb threats and swatting **hoax**es. The trainee provided statistics and current trends seen across the country. The training discussed characteristics of **hoax** calls, law enforcement best practices for assessment and response, and the decision-making process for evacuation or sheltering in place.

Elva Ramos and Irlanda Huerta attended a two-hour Civilian Response to Active Shooter Events




(CRASE) training at the Town of Horizon City Council Chambers. During the course, attendees were provided with strategies, guidance, and plans for surviving an active attack event. In addition, videos were demonstrated of past active attack events. Attendees learned the principles of what to do if an active attack event were to happen and how to increase your chance of survival by knowing: Avoid, Deny and Defend.

#### **Gold Out Fundraiser**

On Friday, February 2, 2024, officers from the Horizon City Police Department attended a fundraiser for the daughter of an El Paso Police Department officer who had been diagnosed with

cancer at the age of 7. Officer Sierra received the invite from a colleague in Socorro PD and was encouraged to share it with the department. The fundraiser was held at the EPPD Pebble Hills Regional Command. HCPD donated funds to Diana and were able to order shirts from her family with all donations going toward her cancer treatment. HCPD met up with other law enforcement agencies and got to eat lunch that was also put as part of the fundraiser. Officers were at the fundraiser for approximately an hour and spoke with the pediatric non-profit organization Gold Out, who they partnered



#### Polar Plunge 2024

On Saturday, February 3, 2024, police officers from HCPD joined the Special Olympics in their first event of the year, The Polar Plunge. The Polar Plunge is an event in which those that take part in it, swim in the cold weather temperature or slide down a water parks icy slides in an effort to raise funds for the Special Olympics' athletes. The Polar Plunge was held at Camp



Cohen Water Park in the Northeast side of El Paso. The weather for that day was a windy, cloudy and cold 46 degrees Fahrenheit. Chief Vargas, Sargeant Nunez, Patrol Officer Trevino, Officer Sierra and Hernandez were the officers to represent their department. It

was also the department with the most representation.



## TEXAS

#### **PIO Training in Houston**

On February 5-February 7, 2024, Officer H. Sierra and V. Hernandez assisted the Public Information Officer Course through LEMIT in The Woodlands near Houston, Texas. Officer Sierra



and Hernandez have taken the roles of PIO's since 2021 and traveled to obtain adequate training that would better prepare them for interactions with the media. The course was a fast paced training that exposed all attendees to the reality of being in front of a camera and being asked the unexpected. The class was formed by both law enforcement and civilians that worked

with local, state and federal law enforcement agencies. The first day consisted of watching real life videos in which there was an interaction between the public and law enforcement in both positive and negative scenarios. Once the video was viewed, PIOs were asked a series of questions regarding that interaction, and through the answers that were given, feedback was provided by both the instructors and the students of the class. The second day was a more hands on training on preparing for a press conference rather than a one-on-one interview. Students were able to prepare for an hour and come up with a press release which they'd present to multiple news media outlets. Limited time was given to the presenters to put them in the position where many times they don't have much time to come up with a press release and have to be ready to give a press conference. The press conference was given in an individual manner by all 20 PIOs and took over 4 hours to complete. On the third day, PIOs were given a review of the training material they had studied and applied the previous two days and provided them with the last project of the training. It consisted of four teams compiled of five PIOs. Every team had a different scenario that was given to them with information they had to separate between what should be released and what should be kept inside the agencies only to preserve the integrity of the investigation. Once again, The PIOs were given a time limit of two hours to work through the scenario, assign different roles amongst themselves and represent different law enforcement agencies. This exercise took most of the rest of the day but proved to be a challenge when it came to the mock questions they

were asked. Students learned how to articulate an answer without providing too much information, what to avoid disclosing, and how to bridge certain questions to ensure that the questions asked are consistent with what the interview is about. This training was a great way of preparing the department's PIOs for any upcoming situations where they are needed to represent the police department and Horizon City.



#### **MVA PIO Involvement**

On Wednesday, February 7, 2024, the STI team was called for a vehicle vs. pedestrian fatality at the intersection of Pawling and Darrington. During these types of incidents,



PIOs take on the role of updating the public through multiple means of communication. They handle the police department's social media pages which in this case include Facebook and Instagram. They have to handle the news media outlets in the sense of where they can stage to film, interviews that are conducted, and information that can be provided to ensure that accurate information is received and put out for the public. Due to both PIOs being out of town for training, they had to handle the situation differently. From 1900-0000 hours, Officer Sierra and Officer

Hernandez handled over 20 calls and conducted dozens of calls involving the news media in a different city from the location of the incident. This differentiated from other PIO callouts were they would meet with the news crews and do a face to face interview. Both PIOS coordinated with STI, and Patrol Lieutenant J. Ortega to see the development of the investigation and were able to get a spokesperson to handle the interviews in the vicinity of the motor vehicle accident.

#### **Press Conference**

On Friday, February 8, 2024, Officer Sierra Officer Hernandez landed in El Paso from the training in Houston and met with Chief of Police M. Vargas and STI members to have an update on the incident that took place the evening before. It was decided that the best course of action was to meet with multiple news media outlets and do a press conference with all of them at the same time. Officer Sierra contacted his point of contacts within the news stations and



informed them of the press conference and that it'd take place at 1400 hours. Officer Sierra was able to gather Telemundo, Univision, KTSM Channel 9, KFOX 14, ABC 7 news, and Channel 4 News for the press conference. Officer V. Hernandez and Lieutenant K. Valdez also streamed the interview live through their FB Page to allow followers and constituents to watch the press conference in real time. The press conference lasted approximately 5 minutes and was done in both Spanish and English followed by a series of questions that lasted approximately 10 to 15 minutes. The success of this conference was in part to the training that Officer Siera and Hernandez received in Houston and in the officers' confidence in being prepared for this type of situation.

#### **Coffee with a Cop**



On Monday, February 12, 2024, HCPD held their monthly Coffee with a Cop at Amber's Coffee Bar. This monthly gathering is done so that the community can come together and engage with their local police department. Since Valentine's Day was that week, Officer Sierra put in a request for pastries so that guests could enjoy more than just free coffee and great company. During this event, there were new faces to meet, and they also asked the department about questions they had in

reference to their jurisdiction, the size of their department, the growth of the city etc. They were also met with familiar faces like Alecia Conelly that took Valentine's Day treats for everyone who attended to enjoy. The event was held from 9:00am-11:00am yet ended past 11:30am due to the engagement with some of the guests. The next Coffee with a Cop will be held March 26, 2024 at the same location to help promote the local establishment.



#### **City Hall Presentation**

On Tuesday, February 13, 2024, Officer H. Sierra and Officer V. Hernandez attended the city hall meeting at HCPD's court room. Chief of Police M. Vargas, Assistant Chief Rico, Lieutenant Ortega Lieutenant Valdez, Emergency Communication Manager Elva Ramos, Officer H. Sierra and Officer V. Hernandez presented the annual report for the police department. The annual report is comprised of data and information that allows the city to compare and contrast the previous year's to one another. The presentation took approximately 30 minutes and was divided by division and allowed to be presented by the designated officer or employee. Officer Sierra was able to explain to city council the increase from 87 functions with the community in 2022 to 199 in 2023. These functions were divided into 4 sections. teachers) expressed their pain, reflected on the best memories they shared with him and honored his life by remembering him and letting those who attended the vigil know how much of a beautiful soul he had. Students were given the opportunity to write a note or a short letter to Miguel's family and

place it in a box as they gave their condolences to Miguel's family. Followed by that, family, friends, and school staff stepped outside the gym and released white and silver balloons in remembrance of Miguel. Miguel's family was reminded by school staff and friends that we are all a big family and if they ever needed any assistance, we are all here for them as a community.

#### **Oz Glaze Potluck**

On Wednesday, February 14, 2024, Officer H. Sierra and Chief M. Vargas swung by the Oz Glaze Senior Center for a surprise during their monthly potluck. #### **FEMA PIO Training Guide**



On Tuesday and Wednesday, February 27 and 28, Public Information

Officers H. Sierra and V. Hernandez attended the FEMA Public Information in All-Hazards Incident training at the El Paso Regional Communications Center. This was the second PIO training both officers attended with a



different approach. The FEMA training allowed for PIOs to learn and put their knowledge to the test on catastrophic scenarios that aren't so

common but must be handled at times. The training was made up of 22 PIOs from different law enforcement agencies and school districts. Just like the training in Houston, the PIOs were formed by both law enforcement officers and civilians. The training explained the roles of the PIO, what is needed from the PIO, and how to effectively manage an emergency situation in the case of hazardous incident. Being able to work together and in an effective manner was also taught by splitting all students into groups and having them discuss different mock scenarios. During those scenarios, PIOs managed to put a message together for the public in which they can feel safe, they discussed how to properly handle the media during the incident and how to perform the necessary duties at the same time. They were taught the stages of a Crisis Communication Life Cycle and how to approach each of those stages. During the second day, The class was broken up into 4 different teams and assigned a different scenario that would fall under a Hazard Incident. They were given detailed information as to what occurred, but again, the PIOs had to decide as a group, what entity they would play and what information would be provided. Although transparency is always encouraged it must be done in a cautious manner. They had approximately an hour to read, review the incident and decide on what was going to be presented in a mock press conference. After their press conference was given, the instructors and students followed up with difficult but necessary questions for the PIOs to answer with the goal in mind of being effective under stress and being able to still perform one's duties. After the training, Officer Sierra and Hernandez were able to understand their role in a different way that although not always needed, is necessary to have the knowledge on.

## **Youth Core Program Weekly Meetings**

On Wednesday, February 21 and Thursday, February 29, 2024, officers conducted their weekly meetings with those who are part of the Youth Core Program. On the week of February 21st,



officers took these young individuals to local Corky Park to conduct hands-on drills on how to unholster and re-holster their weapon, as well

as having their weapon in a low ready or ready position as they walked for a couple of yards. During the week of



February 29, officers had police explorers practice traffic stops inside of Horizon City Municipal Court. Police explorers took on the police officer roles and the officers took the role of being a communication specialist or the driver of a vehicle committing a traffic violation. Police explorers were provided with the information necessary to provide our communication specialists of the activity being conducted, which in this case was their traffic stop. Police explorers were being assisted by the officers by educating them on the proper steps that they needed to take as they made contact with the "driver" of the vehicle. Each police explorers had the opportunity to take on this hands-on activity and received feedback on how to improve their skills. Officers are looking forward in continuing with this activity to make the explorers feel more comfortable and confident when practicing their radio transmissions and traffic stops.
