




ITEMS OF INTEREST



- Chief McConnell held a fireworks planning meeting with city staff and other outside agencies.

















COMMUNICATIONS DIVISION

Together as One

The Socorro, San Elizario, Clint and Fabens Fire Departments responded to a structure



fire in Socorro involving a vacant mobile home. Upon arrival, the fire department advised of a fully engulfed mobile home. The fire was extinguished approximately 30 minutes later. The fire departments cleared the scene within an hour and a half. There were no injuries reported.

The Montana Vista, Clint, and Horizon Fire Departments responded to a structure fire in Montana Vista involving a mobile home. The caller advised she had visual of smoke coming from a

vent in the bathroom. The fire was extinguished within 30 minutes of arrival.

The Clint, Fabens, Horizon, San Elizario, Tribal and Socorro Fire Departments responded to a fully engulfed mobile home in Socorro. Prior to arrival, dispatch received several calls advising of area residents attempting to extinguish the fire. Once on scene, the fire departments found a fully-engulfed mobile home with exposures to three vehicles and two homes. The Red Cross responded to the location to assist due to the displacement of six occupants. One patient was taken to a local hospital.

The Socorro and Horizon Fire Departments responded to reports of a cotton field on fire. There was limited information due to the information coming from a 911 text call. Units had difficulty accessing the fire due to limited roadways in the area. Upon arrival, units found a large area of 50x50 with several small fires within that area. Units were able to extinguish fire and cleared after approximately 4 hours on scene.

The Socorro, Fabens, Horizon, Montana Vista, and Tribal Fire Departments responded to a residential structure fire in Socorro. Multiple callers advised of a home and two vehicles on fire at the same residence. Units on scene reported an active structure fire and two vehicles fully engulfed. Five additional vehicles in the area were reported to be damaged by the fire.

The Horizon Fire Department responded to a vehicle rollover on the Gateway West in Sparks. Once on scene, units advised of a heavily damaged vehicle and checked for injuries. The frontage road was closed off and the El Paso Sheriff's Office deputies assisted with traffic control. Fire crews assisted in clearing the roadway and they cleared the call about one hour later. The scene was then turned over to the El Paso County Sheriff's Office.

The Socorro and Horizon Fire Departments responded to a vehicle fire on I-10 West. Upon arrival, units advised of a semi-trailer fully engulfed and initiated attack. The interstate was closed off and the El Paso Sheriff's Office deputies assisted with traffic control. Fire crews assisted in clearing the roadway. The fire units cleared approximately three hours later. The scene was then turned over to the Texas Department of Transportation.

INFORMATION TECHNOLOGY

70 support tickets were completed and closed including five major projects. A ticket is pending due to issues needing to be further investigated and resolved. The issue is related to scanning in LaserFiche which sometimes gives an error message. The major projects included:

- WatchGuard Firmware Update
- Installation of monitor and power strip on the court room
- AT&T router removal
- Installation of office 2019
- FTO folder setup

In addition to the major projects above, IT staff responded to a variety of tech support requests throughout the month.

WARRANTS DIVISION & FLEET OPERATIONS

The warrants officer received 38 summons for service. All summons were served and none were returned to the court. Six people were arrested for traffic warrants. Collections were made on traffic warrants and those unable to post bond, were booked into the El Paso County Jail. The warrants officer reviewed ten child protective services cases. The cases were reviewed and closed, or filed with the corresponding case due to allegations of neglect. The warrants officer took three vehicles to the shop for oil changes and repairs. Bailiff duties were conducted during court proceedings. The warrants officer conducted one city ordinance violation.

CRIMINAL INVESTIGATIONS/EVIDENCE

Detectives were called to investigate an unattended death. During the course of the investigation, the case was closed as a natural death. The deceased person had an extensive medical history. Lieutenant Ortega signed 28 cases at the District Attorney's Office which were accepted for prosecution. Meetings attended by Lieutenant Ortega were SOCAP, JOIC, STARS and a gang meeting. To honor fallen officers, the Horizon City Honor Guard attended several memorials at Rogelio Sanchez Unit, Sheriff's Department, EPPD, and Border Patrol.

FORENSICS UNIT

The evidence technician conducted fifteen open records requests for video from the officer's body cameras. The District Attorney's Office submitted 10 requests for videos for criminal cases. Forty-two items of evidence were submitted to the Texas Department of Public Safety for drug analysis. The forensics technician assisted in processing 12 public requests for fingerprints.

CRIME PREVENTION ACTIVITIES

Coffee With A Cop

Our Coffee With a Cop event was held on May 25th, at the Whataburger. Sergeant Mitre met with various members of our community who stopped to have coffee and chat. Summer Festival, Movies in the Park and National Night Out were topics of conversation. Coffee With a Cop events happen monthly, dates and times are posted on our official website and social media outlets.

Child Seat Inspections

Sergeant Mitre attended a child safety seat event held at Bel Air High School in El Paso. The event was hosted by TXDOT. During the event, certified safety seat technicians inspected and replaced car seats for parents who had been either court ordered or referred to the TXDOT program.

- 36 total inspections were conducted
- 28 car seats were distributed
- Only 24 children arrived with car seats
- 23 car seats were found to be inappropriately used
- 96% of car seats were misused
- 18 car seats were deemed unsafe and replaced

Explorer Program

Enrollment and participants of the Explorer Program remained steady throughout the month of May.
