Horizon City Police Department Monthly Report

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

Demographics

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our Communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

Staffing

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Criminal Investigations Division overseen by the Assistant Chief
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police





Patrol Division

The Patrol Division is commanded by Lieutenant Jesus Ortega for day shift and Acting Lieutenants Sergeants Guillermo Rosas and John Rodriguez on night shift. Lieutenant Kaycee Valdez is at the FBI National Academy. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 14 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.

Month to Month Comparison









Officers talked about all the materials and paperwork that is needed to conduct each class. The location of the car seat classes was also discussed to provide a better and safer environment for the community and the technicians while providing the education. The goal for HCPD is to host two different car seat classes each month. Officers agreed to host classes on two different days at different times to have a variety of slots for parents to be able to attend.

Heat Awareness

On Wednesday, August 16th, CRO H. Sierra and V. Hernandez streamed a LIVE FB video about the dangers of leaving a child or pet in a vehicle. Officers partnered up with TxDot and borrowed equipment to assist with the video and show the changes between the temperature outside and the temperature inside while a vehicle is off without an air conditioner. The FB video lasted shortly of an hour and during the time on the unit, Officers provided information on the dangers that children left in vehicles face. Officers began the video with their unit being on and cool and proceeding to turn it off and remaining in the vehicle for an hour. Officers explained the way their bodies were handling the heat and demonstrated early signs of a heat stroke in the unit. Officer E. Delgadillo and HFD were on standby in case of any emergency. Officers also went over the consequences parents can face criminally if a child is left in the vehicle and of the consequences they can face if something happens to the child. This was the second year that HCPD brought awareness with one of these videos and will continue doing them in the future to bring awareness to all.





El Paso Child Crisis Center Race

The objective was to keep the public as informed as possible of the serious incident that occurred and to keep them up to date with the reopening of the road as it is one of the main arteries of the city.

Safe-Riders Car Seat Class

On Saturday, August 26th, 2023, Officers with Horizon City Police Department hosted their very first Car Seat Class for the community. Community Relations Officer V. Hernandez made appointments by phone two days prior to the event. General information such as first and last name, how many kids were being brough for the class, the child's full name and age were asked at the time the appointments were made. There are currently four officers that are certified as Child Passenger Safety Technicians and the goal is to be able to provide education to every single parent on how to safely transport their child in a motor vehicle. The event consisted of parents checking in and filling in a Checklist form. After the paperwork was completed, Chief M. Vargas went over a PowerPoint presentation and showed parents several videos that were retrieved from the Texas Department of State Health Services. Once parents completed the classroom portion, parents stepped out and got inside their vehicle along with their kids and technicians initiated their education. A total of 12 car seats were provided to 12 different kids, 4 kept the same cars seat they were in, and one expecting mother was educated on the proper car seat installation. As a department, the goal is to make a lifesaving difference by educating parents on how to properly buckle their children and reduce the number of injuries and deaths in motor vehicle accidents.





Pop with a Cop

On Tuesday, August 29, 2023, Officer Sierra and other officers from HCPD held their monthly community outreach gathering at Peter Piper Pizza for Pop with a Cop. The purpose of these monthly gatherings is for the community to attend and reach out to law enforcement and build rapport with the officers in their community. Operation Safe Streets

On Thursday 31, 2023 CRO H. Sierra and V. Hernandez assisted the El Paso County Sheriffs Office with the warrant roundup, operation Safe Streets. Multiple law enforcement agencies assisted in making the weeklong operation possible. 10 officers were approved for the weeklong operation in which subjects with outstanding criminal warrants were searched for and apprehended. The Thursday operation included a briefing, an area packet and with officers being given an assignment as to what their duties were for the day. Officers met at the El Paso County Detention Facility at 0500 and worked the operation until 1300 hours. During operation Safe, Officers Sierra and Hernandez searched for the last known residence of said subject in the Upper Valley Area. Officer Sierra and Hernandez were teamed up with 2 S.O. Deputies for that operation day. 30 residences were provided and 20 of those locations were searched leading to one arrest for a felony charge.





Youth Corp Program

CROs H. Sierra and V. Hernandez mentored the Youth Program 3 times out of the month in August. For the 3 meetings, Officers taught and revised the 7 Step Approach for Traffic Stops with their students. The students were first tested on their Ten Codes and phonetic alphabet to ensure proper radio procedures were followed during the traffic stop scenarios. The second meeting involved a PowerPoint presentation explaining the process and the importance of proper traffic stops. The second half of the meeting involved the students participating in a traffic stop scenario. Mentors provided the students with a list of locations and vehicle registrations to choose from to provide a more realistic scenario. During the interaction, One Officer role played a driver who had been pulled over and waited to see how the traffic stop was conducted while the other ensured the student was performing the scenario correctly. The third meeting of the month was a revision of the previous material provided with the scenarios becoming more difficult. Officers allowed the students to handle the ticket writer and taught them how they are used for the students to have a more realistic experience. Radios were provided for the students and were used to call out the traffic stop as well as to receive feedback from the other officer portraying dispatch. The event ended by having the community push Tiller 401 to its designated area to be put into service. Excellent Investigation Leads to Found Runaway

On Tuesday the 22nd of August 2023 Officer Nicholas Ortega worked up a case for a Runaway. Officer Ortega immediately started using his old connections from his prior employment and was able to identify the subject whom the runaway was staying with after being provided with a photo of him. Officer Ortega was then able to come up with a name, phone number and address for the subject. Officer Ortega then advised the family of her whereabouts and was later advised that a family member was on their way to pick her up.

Money returned to Elderly Individual

On Friday the 25th of August 2023 Officers Gustavo Chavez and Officer Christian Arredondo responded to a Walk-in at the station reference Theft. The victim, an elderly male further explained that he had gone shopping at the Walmart and selected cash back in the amount of \$100 at one of the self-checkout registers but forgot to take the money before leaving the store. He later remembered and went back to speak to the manager, who advised him that the person behind him had taken the money. Officers then conducted a follow up at Walmart and were able to identify the male subject who took the money via video surveillance footage and a credit card, but the victim refused to file and prosecute. Officers later conducted a follow up at the OF's residence and were able to recover the money and return it to the elderly male who was very grateful for their assistance in resolving the matter.

Outstanding Investigative Work Leads to arrest of 11 Juveniles.

During the month of July, we had two separate incidents in which individuals forcefully entered Frank Macias School and stole property. Along those issues, these individuals also damaged school property. Officers responded both times by taking the information on the call. The incidents were subsequently assigned to Detective Abel Labrado. Detective Labrado, using the information provided and using the networks he has built, was able to identify all 11 individuals responsible for this these crimes. He proceeded to work up cases and took all 11 into custody and processed them. Detective Labrado did an outstanding job in these cases and is commended for his work. Great job Detective Labrado.
