Horizon City Police Department Monthly Report

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

Demographics

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our Communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

Staffing

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Criminal Investigations Division overseen by the Assistant Chief
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police



Patrol Division

The Patrol Division is commanded by Lieutenant Jesus Ortega for day shift and Acting Lieutenants Sergeants Juan Nunez and Guillermo Rosas on night shift. Lieutenant Kaycee Valdez is at the FBI National Academy. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 14 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.







Progress with communications consolette project

The communications manager and her assistant continue working diligently with Motorola Solutions Program Manager personnel on the communications consolette project. The communications manager and her assistant continue meeting on a weekly basis with Motorola Solutions Program Manager personnel via Google Meet to discuss project updates.



Special Communications Operation was a Success!

Fourteen dispatchers, including the communications manager and shift supervisors, were scheduled to work on the 4th of July to meet the demands for high volume of radio traffic and calls for police

and fire. The communications division was split into two groups. Three dispatchers were assigned to call take at the El Paso Regional Communication Center located at 6055 Threadgill. The five consoles at the Horizon Police Department were assigned to dispatch police and county fire. Between the hours of 19:00-01:00, crisis radio procedures were in effect for the county fire departments. During these hours, the county fire departments responded to sixty-three calls. A total of eighty-seven calls were generated to include officer initiated and police response from 18:00-06:00.



Communications Training Officer Certification

Shift supervisor Anthony Dominguez attended the three day APCO Institute's Communications Training Officer Course. The course provides thorough training on the roles and responsibilites of CTOs in running an agency's one-on-one training program. The course focuses on performance-based training and the need for standardized training with documentation.



Leasdership Traniing

Shift supervisors Sheila Tarango and Leslie Duran attended the Lead for Tomorrow Training held at

the El Paso County Sheriff's Region VIII Training Academy. The course covered the need for strong and effective leadership. As leaders, it is essential to lead in all aspects of the profession. Some of the well-known causes of the failed system are toxic culture, poor leadership and supervision, failures of training, evaluation, oversight, accountability and so forth. Addressing these issues takes persistence, bravery, leadership, team work and police-community trust.


Child Vehicular Heatstroke Deaths Presentation

Followed by the studying, Officer Hernandez conducted an oral exam for every Explorer and asked them individual questions to assure Explorers are learning the ten codes and phonetic alphabet.



Excellent Investigation and Arrest

On July 15th Officer Lujan responded to a Credit Card Abuse at the Gordi Buena located at 494 N. Kenazo Ave. and conducted the investigation from beginning to end. Investigation revealed that Victim, after paying for his food using his debit card, he left his debit card on top of the counter and sat down at a table to eat. A female OFFENDER, who was behind Victim in line, is seeing through surveillance cameras, sliding the debit card towards her with her fingers. Officer Lujan did great investigative work and with the information at hand, she was able to obtain license plates from surveillance video at Walmart where OFFENDERS were purchasing items using the Victims debit card. Male OFFENDER was seeing using the card on camera. Using the license plate information she obtained, she was able to obtain OFFENDERS driver's license with an address in Horizon City. Using

WebRms, Officer Lujan researched the name of the OFFENDERS and confirmed the name, DOB and the address. The officer attempted to make contact with the OFFENDERS, but they were uncooperative. Officer then obtained a signed warrant for both male and female OFFENDERS and arrested both subjects for the charge of Credit/Debit Abuse 2 days later. Excellent work by Officer Lujan.

Stationary Vehicle Checkpoint

On July 14th, 2023, Officers with the Horizon Police Department held a driver's license checkpoint at 300 N. Kenazo Street in Horizon City, El Paso County Texas. With the assistance of Justice of the Peace Precinct 6 Constable's Office, Officer checked over 126 drivers. Only 6 citations were issued by the staff and 1 arrest for a JP-6 traffic citation was made. No major incidents were reported. Excellent work by our staff in extended efforts to keep our motoring community in Horizon City safe.
