#### **Horizon City Police Department Monthly Report**

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

#### **Demographics**

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our Communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

#### **Staffing**

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police


February 2023 to March 2023 Comparison

#### **Patrol Division**

The Patrol Division is commanded by Lieutenant Jesus Ortega for day shift and Lieutenant Kaycee Valdez for night shift. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 12 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.

#### **Data Driven Approach to Traffic and Crime Safety**






February 2023 to March 2023 Comparison





#### **Departmental Significant and Notable Accomplishments:**

#### **Certifications**

Seven telecommunicators attended the 24-hour mandated TCIC/TLETS Full Access Operator Training Course. This course is for operators who perform all TCIC/NCIC functions, including inquiry, entry, modification, clearing, canceling, and III functions. In addition, two recently hired communications specialists attended the four hour CPR course. The CPR course is a requirement prior to telecommunicators attending the Emergency Medical and Fire Emergency Dispatch training.





#### **Grant Presentation**

On March 6<sup>th</sup>, the communications manager and assistant presented the Portable Radio Enhancement Project grant proposal in front of several board members at the El Paso County 911 District. The grant proposal was sought to request 12 APX8000 multi-band handheld radios.

#### **MOTOROLA** SOLUTIONS

The police chief, communications manager and assistant met with Motorola Solutions Representatives regarding the Five MCC7500 Radio Consolette Project. During the meeting, the design review was discussed. The Radio Consolette Project was allotted through a state grant.

#### **Emergency Management Collaboration**

The communications manager and shift supervisors had a meet and greet with El Paso City-County Office of Emergency Management Lead Planner Leroy Granado. Several issues such as active shooter scenarios, immigration, assistance, and weather-related calls were discussed.



#### **Excellent Juvenile Arrest**



On March 30, 2023, Horizon City Police Officers responded to a Terroristic Threat at one Horizon Middle School. The patrol officers jumped on it and helped investigate as soon as school started. Detective Labrado was the detective assigned to the case. Through the collaborative effort of Cpl. Cameron Zeiger and Detective Abel Labrado, they were able to identify the suspect. Consequently they arrested one juvenile who was taken into custody and referred to J.P.D.

#### **Proactive Patrol**

The Horizon City Police Department 3<sup>rd</sup> Shift under the leadership of Sergeant Guillermo Rosas and his crew did an excellent job with their patrol tactics during the graveyard shift. This reflected on a lower crime rate. The Horizon City index crimes were low this month and a experienced a significant decrease for the month. Thanks to their proactive patrol techniques in checking businesses, subjects and city parks, their tactics played a significant role in the crime rate dropping for the month. Excellent work 3<sup>rd</sup> Shift!

#### **Productive Officer**

During this past month Officer Nicholas Ortega did an outstanding job on getting criminals off the street. He recorded the highest number of arrests superseding all staff for the month. Officer Ortega did an excellent job. He was very proactive which reflects on the number of arrests he made. Outstanding work Officer Ortega!

#### **Great Roadside Investigation**

On March 13, 2023, during the overnight shift, Corporal Vasquez, while conducting a roadside investigation during a traffic stop, discovered that the driver and were in possession of drug paraphernalia. During the interaction, Corporal Vasquez developed rapport with the subjects and did an outstanding job of being objective and professional when one of the subjects confided personal issues and their problem with substance abuse. Corporal Vasquez encouraged the subject to reconnect with his family and seek professional support.

#### Road Rage Investigation Leads to Great Arrest

On March 16, 2023, second shift officers responded to a report of road rage in the area of Horizon Blvd. and Darrington Rd. Officers located the suspect vehicle near the intersection of Kenazo Ave. and Horizon Blvd. During the investigation, officers developed probable cause to charge the driver, who was also in possession of a handgun, with DWI, Resisting Arrest, and Assault on a Peace Officer, as the subject was highly combative and violent.

#### **Outstanding Investigations**

During the month of March, officers investigated two separate events involving threats to school campuses. In each incident, the swift investigation conducted by responding officers uncovered probable cause to charge two juveniles for the threats they made to their respective campuses. Each juvenile was referred to the Juvenile Justice Center.

#### **Excellent Hit and Run Investigation**

On March 31, 2023, officers responded to a hit and run accident involving a pedestrian. Responding officers conducted a full investigation which resulted in the arrest of the suspected driver. Officers took statements on scene, reviewed home security footage of the incident with neighbors, and coordinated the preservation of evidence and complex process of creating a laser diagram of the crime scene with sophisticated equipment.

#### **Speed Trailer Deployment**

On Friday 03/02/2023, Officer H. Sierra and Officer Hernandez deployed the newly acquired speed

trailer to assist in heavy traffic areas in Horizon City. The purpose of the speed

trailer is for drivers to be aware of their speed and to see that areas are being monitored. Officers will be working with the software as they collect more data to get a range of speed in the area as well as lowest speeds, highest speeds, and the number of vehicles driving at those speeds in any period of time. The speed trailer was placed in the area of 17000 Darrington Rd. for a month and will be moving to a different location for the month of April. The speed trailer will be moved monthly.





#### **IDEA RUN**

On Saturday 03/04/2023, 3 HCPD Officers attended a 1 mile run for a Health Fair that IDEA Rio Vista Campus had invited them to the previous week. Although it had been short notice, officers participated to continue showing support for the school and continue to improve their close working relationship. Officers met with school staff, took pictures, stretched with Chico the mascot for



the Chihuahua's and ran the mile run.
Participants received a medal at the end of the race and snacks to enjoy. Officers from HCPD participated in 3 runs



during the month of March and CRO's are looking for ways to promote a healthier lifestyle within the department.

#### **S.O.R.T**



On Monday, March 6<sup>th,</sup> and March 20<sup>th</sup>, CRO Hernandez attended Sex Offender Registry and Tracking Unit with El Paso County Sheriff's Office (EPCSO). Every other Monday, HCPD continues assisting EPCSO in registering new sex offenders or entering any updated personal information to have the most accurate information on all individuals and know their whereabouts. Officer Hernandez and Officer Sierra continue learning how



to navigate through the County's and State's website. The goal for HCPD is to take up on the task of keeping track of the sex offenders that are within Horizon City jurisdiction.

#### **Walmart Donations**

On Tuesday, March 7<sup>th</sup>, 2023, Officer Sierra and Officer Hernandez met with Sam Mullins who is the Academy Team Lead along with other Walmart staff. Walmart donated HCPD over 16,000 Easter Eggs for the yearly Easter Egg Hunt that takes place in one of Horizon City Parks. Walmart mentioned to Officers, that the previous TV that was donated by them along with the TV mount could be raffled once the Easter Egg Hunt took place. #### **TXDOT In-Person Meeting**

On Thursday 03/09/2023, Assistant Chief Rico and CRO Sierra attended the quarterly in person meeting that is held at TXDOT El Paso District Headquarters. The topic of the meeting was how the state of Texas has been working to continue improving the sidewalks and roadways so that they fall within regulations under the Americans with Disability Act. They had special presenter Sandra Sierra, coordinator with the ADA for TXDOT provide this presentation. She demonstrated poor roads throughout Texas and how they've been affecting people with disabilities such as wheelchairs, or pedestrians who suffer from blindness. She spoke about how vehicles parking inadequately on sidewalks also pose an issue for those in wheelchairs and how peace officers are important to this issue. The goal for Texas is to be a state where every pedestrian can use sidewalks without having to worry about its condition or a person's disregard for others' needs.



# Wing Eating Competition

On Thursday 03/09/20023, CRO's Sierra and Hernandez sat down with the owner of Toro Burger/Wing Daddy's and SOTX Unified Champion School Specialist Nydia to discuss a wing eating competition during one of the Movie at the Park showings. Officers got to taste different wing sauces and came to an agreement where Wing Daddy's will be the Sponsor for the Wing Eating competition. The competition is still under debate whether it will be on who can eat the spiciest wing sauce or who can eat the most wings in a timed event. There's a second meeting that will take place in May to determine if the competitors will be the athletes from Special Olympics, the public, HCPD, or an integrated contest.



#### **RAIZ Grand Opening**

## Operation Mater Continued

On Monday 03/13/2023 and Tuesday 03/14/2023, CRO's and Patrol conducted a 6-hour area check for vehicles that were incapable of being operated, dismantled, or wrecked and parked on public property in Horizon City. Officers were given different sections to check individually. The 6-hour plan began on the South side of Horizon City. If officers noticed vehicles not in compliance with the city ordinance, officers "red tagged" the vehicles. Among all officers, there were 121 vehicles red tagged that were not within compliance with the city ordinance. Registered owners are given a 15-day period to remove the vehicles or have them within compliance and if owners fail to do that, the vehicles are impounded at the owners' expense. Both Community Relations Officers conducted a follow-up after a 15-day period and a total of 8 vehicles were towed at the owner's expense and the rest of the vehicles were removed. Officers we're not able to complete the full operation but will continue to follow up in the month of April. The purpose of the 6-hour plan was to have our city streets looking clean and have the city within compliance with our ordinance.



#### **TXDOT**

On Thursday, March 9<sup>th</sup>, 2023, Officer Sierra attended a meeting with the Texas Department of Transportation (TXDOT) and he was provided with TXDOT Click It or Ticket It flyers. On Thursday, March 16<sup>th</sup>, 2023, Officer Sierra and Officer Hernandez drove around Horizon City and spoke with several businesses as to whether they would be able to display the flyers for the public. The flyers encourage people to use their seat belt as vehicle crashes in the State of Texas are a leading cause of death among teens and young people between the ages of 15 to 20. The goal is to raise awareness and encourage everyone that gets into a motor vehicle to use their seat belt and attempt to prevent the death toll on motor vehicle accidents.



#### Coffee with a Bank

On Friday, March 17<sup>th</sup>, 2023, CRO Sierra and CRO Hernandez attended Coffee with a Bank event to support Raiz Federal Credit Union at local Amber's Coffee shop. Staff from Raiz Federal Credit Union has shown support to our Police Department on previous Coffee with a Cop events when they have taken place at local Amber's Coffee Shop. #### STI Training for Collision with Pedestrians

On March 20<sup>th</sup> through March 24<sup>th</sup>, CRO H. Sierra and the rest of the STI Team from HCPD attended 40 hours of training along with DPS, UTAH State Police, and EPPD on Pedestrian Collision Investigations training. The training consisted of officers learning mathematical formulas they could use during the STI investigations. Officers were presented with information on how to recognize crucial parts of the investigation during pedestrian collision. Whether it was the speed of the vehicle or the part of the vehicle that hit them as well as patterns that were seen over the years, officers learned a number of things to recognize what type of investigation they were dealing with. One of the training days included officers using actual vehicles to collide into a crash dummy so that officers can gather the calculations needed to determine the speed of the vehicle at the time of the collision. Agencies also shared the software and equipment they used to see the pros and cons of what their agencies used during STI call outs. HCPD had an in-house STI training the following Monday.







#### Safe Riders



On Tuesday, March 21<sup>st</sup>, 2023, Patrol Lt. Ortega, Warrants Officer A. Diaz and CRO V. Hernandez attended a virtual Safe Riders Distribution Program Partner Training. Lt. Ortega applied for a grant with Texas Health and Human Services to be able to form part of the Safe Rider's program and be able to serve as an education and training resource to

our community. The training consisted of showing officers the education and distribution options as well as in person and virtual training that can be provided to parents or primary caregivers to ensure their child's safety. HCPD is excited to form part of this program and be able to assist in reducing the number of unrestrained children in the State of Texas.

HCPD were also able to raffle out 3 gift cards and a coffee maker to those that followed their social media (Facebook) page. The event lasted 4 hours and was an opportunity for HCPD to show the community our involvement with schools in our area. Offices spoke with Clint ISD and shared their interest in being made a part of their events and show their support while at the health fair.

On Saturday, March 25th, 2023, HCPD was invited by the Women's Council of Realtors to their collaboration with El Paso Animal Services event that took place at Ponder Park in El Paso.
