Horizon City Police Department Monthly Report

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

Demographics

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our Communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

Staffing

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Criminal Investigations Division overseen by the Assistant Chief
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police



Patrol Division

The Patrol Division is commanded by Lieutenant Jesus Ortega for night shift and Lieutenant Kaycee Valdez for day shift. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 12 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.

Data Driven Approach to Traffic and Crime Safety







They handled high volume of radio transmissions, phone calls, and answered questions and complaints about the incident in a fast pace and professional manner. Well done ladies!



Our quest for full paperless continues

Our agency is moving away from paper business cards. Although the tangible business card is a long-time staple of the business world, they are often misplaced and can become obsolete the moment a phone number or email changes. Using a digital business card mobile application, the user will be able to present a QR code which will allow the receiver to save the officer's contact information along with links to information on domestic violence resources.



Violent Offender Coalition

Our agency partnered up with area agencies which include TxDPS, El Paso PD, Socorro PD, El Paso County Sheriff's Office, and the Juvenile Justice Department to name a few in order to analyze and develop strategies to reach at-risk youth before they become violent offenders. The amount of



violence in teen crime throughout the county of El Paso has climbed over the last few years and the reasons for that are many. This coalition will focus on identifying areas of opportunity to reach those young offenders and help them find the right path to a safe and successful life.

Partners with Schools and Community

Throughout the month of May, officers in the first shift received several complaints of parents

disobeying school crossing guards and an uptick in parents driving fast through the school zones. Officers conducted saturated enforcement in different area schools to provide the community with assurance that their safety is important to our agency. Our officers conducted traffic stops and assisted with morning traffic control. Aside from traffic complaints, our officers handled an increase number of incidents involving students in possession of vape devices. Our patrol officers and Community Resource Officers are developing a responsive strategy to curb the use of vape devices in our community.



Police Presence

During the afternoon hours, our evening crew responded to several complaints of students loitering at homes after school in the area of Ricardo Estrada Middle School. Our officers monitored the affected area and contacted several students who were addressed about staying off private property. Throughout the month, the number of student scuffles dropped significantly as the activity began to take place inside the school and those incidents were handled by the school resource officer. The homeowners in the affected area were grateful to the officers and relieved that the loitering at their homes has ceased.

Border Patrol "Dangers of Crossing the Border"

On Tuesday May 2nd, 2023, CRO's H. Sierra and V. Hernandez and Chief Vargas attended Border Patrol's annual presentation of "Dangers of crossing the Border". The focus of this presentation is bringing awareness to the public, discourage and deter illegal entry into the United States. There were multiple news media outlets present as well so that the information could be distributed across the city. The end of the conference consisted of how SRT performs wall rescues through a live demonstration of how it is carried out. For the fiscal year of 2023, there





have been 167 rescues and 29 deaths that are related to illegal crossings in the El Paso Sector. That same morning, 2 stash houses hiding 36 immigrants had been discovered and a total of 169 stash houses for 2023.

Ribbon Cutting Ceremony

On Wednesday May 3rd, 2023, CRO V. Hernandez, CRO H. Sierra and Chief Vargas attended a ribbon

cutting event for the new El Paso District Office at Casa Ortiz in Socorro, Texas. The location of the office is seen as a commitment from Congressman Tony Gonzalez to the region. At the ribbon cutting, there were performances by the Tigua Youth Dancers, Fabens



HS Mariachi Band, guided tours of Casa Ortiz and food/refreshment for those in attendance.





Famous Dave's Meet and Greet

On Thursday May 4th, CRO Sierra and CRO Hernandez had a Meet and Greet with Famous Dave's Bar-B-Que manager and staff. Officer Sierra was reached by the store manager Jackie and told him she was interested in providing some meals to the officers. Officer Sierra let her know he could visit the restaurant so that they could meet. At the Meet and Greet, Officer Sierra expressed his interest in working together with Famous Dave's for upcoming events in which Famous Dave's can attend them and promote their business while also bringing new vendors to Horizon City. Officer Sierra met some of the staff and their mascot while at the restaurant. After talking, the manager from Famous Dave's provided Officer Sierra with 18 brisket sandwiches at no cost for Patrol Officers and advised they would continue to support HCPD.

their duties were as police officers. They also gave them a demonstration as to how tourniquets are applied, why they are applied and where they are applied. Students were also quizzed



depending on their grade level as to what gear officers use, the names of the gear and the function of the gear. Officers were welcomed with breakfast at 0730 hours and lunch at 1300 for officers to join. This was the first time HCPD attended a Career Day at the school and met with the staff to let them know the police department is interested in attending future events for the benefit of the students.

Officer Smith offered his assistance to all the law enforcement agencies that attended the meeting in case they were interested in

integrating GASS and DARS into their department.

Sex Offender Registry and Tracking



On Monday, May 15th, 2023, Community Relations Officer (CRO) V. Hernandez visited El Paso County Sheriff's Office Sex Offender Registry and Tracking Office (SORT). The goal for CRO V. Hernandez and H. Sierra is to attend SORT on Mondays every two weeks to assist El Paso County Sheriff's Office with the entering of new sex offender registrants or to update

any information sex offenders report. Every Monday, officers working at SORT come across approximately 25 to 30 sex offenders from the El Paso Multi Use Facility. Officers register new sex offenders as they have been recently released from prison, or they register those sex offenders that have moved from out of jurisdiction. Officers are also in charge to de-register sex offenders when they advise they are moving to a different city. The goal is to keep track of every convicted individual to be aware of their whereabouts and keep them from reoffending.

Click It for Chicken

On Wednesday, May 17th, 2023, Lt. Valdez, Patrol Officer N. Ortega, Officer B. Campbell, Warrants Officer A. Diaz, and Community Relations Officers H. Sierra and V. Hernandez along with Pete Duarte Head Start hosted "Click It for Chicken" Event. Cane's Chicken provided Horizon City Police Department with hundreds of certificates for a free kids' meal. As parents picked up their kids from school, every officer that took part in the event ensured students seatbelts were fastened before the parents left the campus. Special Traffic Accident Investigation

On May 31 Patrol Officers responded to a major vehicle accident involving a police officer that was assisting with traffic control. The first shift patrol sergeant and his officers did an excellent job in securing the crime scene making sure all workable evidence was secured. STI team came in and did an outstanding job in recreating the collision and documenting all the statistical data. Our PIO also came into play and did an outstanding job in disseminating information to the media and the citizens of Horizon on alternate routes to take.

Title 42 Assistance

The El Paso Police Department along with the Texas Department of Public Safety held a local department head meeting to discuss the lifting of Title 42 and come up with a plan to deal with a possible influx of immigrants. During the meeting the Socorro Police Department reported several incidents in which they had little to no help in dealing with calls for service involving criminal trespass offenses. The Horizon City Police Department was tasked to assist the Socorro Police Department. This is another example of why our area is one of the safest in the country. It is our ability to assist each other in a time of need. This provided for continuing to strengthen our inter-agency relationships.

Socorro Police Meet and Greet

During the month of May, the command staff for the Horizon City Police Department met with Chief David Burton of the Socorro Police Department to share ideas and network. The Chief gave our department a tour of their new headquarters building and an overview of their operations. It was a great opportunity to meet with another agency and share ideas on how to address current trends. Networking is an important part of making progress and addressing cross city crimes.

Excellent Arrest

Officer Delgadillo, while working on a special assignment, encountered an individual that violated the Texas Transportation Code (Speeding) when attempted to conduct a traffic stop the driver fled the scene. Officer Delgadillo checked the general area and located the vehicle involved, he conducted his investigation and was able to identify the driver, a warrant was issued for his arrest. Ten days later the suspect was located during an additional investigation and a warrant was executed.
