Horizon City Police Department Monthly Report

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

Demographics

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our Communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

Staffing

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Criminal Investigations Division overseen by the Assistant Chief
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police



Patrol Division

The Patrol Division is commanded by Lieutenant Jesus Ortega for day shift and Lieutenant Kaycee Valdez for night shift. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 12 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.



Month to Month Comparison









The course is aimed to teach law enforcement professionals the significance of physical, mental, emotional, and social wellness, and to break down the stigma of mental health in the law enforcement profession.

The Active Shooter Exercise Development Workshop course provided participants with the knowledge, templates, and information to lead a Train-the-Trainer Active Shooter Tabletop Exercise.

The Facebook post received over 450 comments. Officer Hernandez with the assistance of Cpl. B. Avitia, conducted a Facebook livestream where Cpl. Avitia randomly picked three names and



the last pick was the final winner for both tickets. Officer Hernandez was able to get in contact with the winner and provided both tickets for her to enjoy the Music Festival with a plus one.

Safe Riders Britax Manufacturer Training



On Wednesday, September 6th, 2023, Community Relations Officer V. Hernandez attended an online Teams Meeting with Safe Riders. The training consisted of providing Child Passenger Safety Technicians with updated information about Britax products. Over 100 Child Passenger Safety Technicians attended the online training that was presented by Sarah Tilton, the Director of Consumer Advocacy from Britax Child Safety Inc. The presentation lasted about an hour and technicians had the opportunity to ask questions about the products and educate themselves more to be familiarized with the product a little better and be able to provide that information to parents in case they own Britax products.

Horizon High School Homecoming

On Wednesday, September 6, 2023, CRO H. Sierra met with Horizon High School Principal Mr. Trejo. The 2023-2024 school year is the first year Mr. Trejo will be at Horizon High School. One of the big things that Horizon High School does is their Homecoming Parade. HCPD has been able to provide



traffic control and security to the school parade for many years. Up until last year, the route used was from Frank Macias Elementary School to Horizon High School. This year, Officer Sierra proposed the school use an alternate route to prevent too many roads closure, less traffic congestion and hopefully, a safer environment for the students and participants of the parade. This year, the parade will begin at Horizon Middle School and go through all of Eastlake Boulevard, extending the parade route by less than a mile from previous years. Mr. Trejo and the organizers of the

parade agreed to try the new route and assist by creating enough advertising on the new route and safety measures for the following weeks up until the parade on October 18, 2023. Officer Sierra will follow up before the parade once again to make sure the school and HCPD are on the same page.

TxDOT Distracted Webinar

On Thursday, September 7th, CRO Sierra joined an online webinar on how law enforcement can keep drivers off the phone and their attentions on the road. The training had guest speakers from all around Texas who wanted the same thing: keep all drivers safe on the road. Presenters talked about the importance of paying attention while driving. Data presented in the webinar showed that 484 people were killed on the road in 2022 with a total of 24,543 crashes with distraction/driver inattention being the reason. Those that were invited to speak also mentioned that texting was just one small part of the problem. They explained other dangerous behaviors included checking emails, social media updates, GPS navigation, loading music and taking/posting pictures posed a threat as well. The Seminar included solutions to the problem. Promoting safer driving through social media, campaigns launched by law enforcement, face-to-face interactions and being able to educate drivers of all ages on the risks associated with driving were some of the solutions presented during the webinar.







9/11 Ceremony

On Monday, September 11, 2023, Horizon City Police Department joined the Horizon Fire Department in a ceremony to remember fallen first responders during the 9/11 attacks in 2001. The ceremony included bag pipes, the display of the American flag, HCPD's Honor Guard and a speech from Chief of Fire Menendez. Those in attendance were reminded about the importance of September 11, and how it changed us as a nation. The ceremony lasted 30 minutes and was followed by an invitation from HFD to join them in the building for breakfast and pastries. HFD and HCPD have continued working together throughout the years and shown the unity, solidarity and strength of both agencies, to the city of Horizon.





Safe Riders Meeting

On Tuesday, September 12th, 2023, Community Relations Officer and Child Passenger Safety Technician V. Hernandez, attended a private meeting with Safe Riders personnel to discuss details about conducting Car Seat Check Ups or Classes. Officers with Horizon City Police Department who are certified as Child Passenger Safety Technicians, conducted their first Car Seat Class during the month of August. Jorge Alday, who works for Texas Department of State Health Services – Safe Riders in the El

Paso Area, attended the very first class and provided technicians with some tips to improve the Car Seat classes. Some questions were raised from the technicians and Jorge advised he would get with

supervisors to clarify those questions. During this meeting, Jorge was able to provide answers to the questions technicians had and provided further details and tips for any upcoming classes Horizon City Police Department will be hosting for the community.

Eastlake High School Parade

On Wednesday, September 13, 2023, Horizon City Police Department assisted SISD PD and Eastlake High School with their traffic control for their Homecoming Parade. Followed by that, parents or guardians are welcomed and provided with documentation that needs to be filled and kept on record. Once parents are done with the paperwork, they are redirected to a lane where a technician is waiting for them to initiate the education and installations of the car seat. During this event, technicians were able to provide 18 Child Passenger Safety seats. The

goal is to be able to educate parents and kids the importance of safe transportation.

915 Heroes Night

On Saturday, September 23, 2023, Officers from HCPD attended the tailgate for the UTEP vs UNLV. The event was an all-day event where officers dropped off units in the morning for set up and detailing of the units as well as meet others in attendance. Officers from HCPD grilled burgers, hot dogs, steaks and spent time with their families for the entirety of the event. A total of 10 officers from the department attended the event and took part in watching

the football game. During the half-time presentation, Officer E. Officer Hernandez was the officer in charge of communicating with UTEP and had been assisting with the planning for the department since May by attending meetings.





Motor Vehicle Accident - Public Information Officer Call-Out

Diaz regarding a serious motor vehicle accident hit and run involving a bicyclist. Officer Hernandez responded to the scene as the Public Information Officer. Once on scene, Officer Hernandez conducted several interviews with different media outlets to include KFOX 14, CBS4, KTSM Channel 9, and Telemundo to let the public know of the incident that had occurred early in the morning. Officer Hernandez kept updating the public on road closures via Horizon City Police Department Facebook and Instagram page as multiple posts were created. The goal was to keep the public informed of the serious incident that had occurred and request assistance from the public in case anybody had any information. The goal was to also keep the public informed with the reopening of the road as Horizon Blvd is one of the main arteries of the city.



Commendable Actions

Grant Award

On September 16, 2023, our agency was approved to receive a state grant to outfit our patrol officers with rifle resistant plates for their existing body armor. Lt Valdez was directed to apply for this grant. Her initiative and concise reporting allowed for our agency to receive this grant. This award allows for the added layer of ballistic protection for our officers. Particularly, to have adequate defense when responding to violent active shooter incidents involving high power firearms.

FBINA Graduate

From June through September, Lt. Kaycee Valdez attended the prestigious Federal Bureau of Investigations National Academy. This program is crucial in the development of new leaders in the law enforcement profession. It is part of the expectation for our leadership team to continue with their professional development. Statistically, less than 1% of American law enforcement officers are selected to attend this prestigious program. The knowledge and skills obtained will empower our Lieutenant to become a better leader for our officers.

Outstanding Hit and Run Investigation

On September 25, 2023 our officers responded to a hit and run accident on Horizon Blvd. which involved a bicyclist who was struck by two vehicles. The tragic accident took the life of the bicyclist and the drivers responsible failed to stop and render aid. Our team of investigators was able to develop leads from debris left behind by those vehicles which fled. On September 29th, the investigation team took the two drivers charged with failing to stop into custody and booked them into the El Paso County Detention Facility. Solving this case took a contribution from every member of our patrol and administrative divisions. The investigation team is comprised of patrol officers with specialized training. Officers assigned administrative duties were placed in service to respond to calls for service. Other patrol officers worked extra hours to make sure that the agency was able to provide the city with the necessary coverage to handle the day to day needs of our city. Teamwork makes the dream work.

Excellent Preliminary Investigation Leads to Arrest

On September 18th, 2023, Officer Gustavo Chavez was dispatched to a motor vehicle accident on Maravillas Street in Horizon City Texas involving a pedestrian. Officer Chavez' outstanding preliminary investigative skills led to the identification of the vehicle and subject involved. With the assistance of the Criminal Investigations Division, the subject responsible for the hit and run was arrested and booked in to the El Paso County Detention Facility under a \$300,000 bond.

Great DDACTS work by Patrol Shifts leads to over 50% reduction in Part 1 Crimes

During the month of September, Officers assigned to Sergeant Rosas/Cpl. Vasquez and Sergeant Rodriguez/Cpl. Zeiger each reported a reported a 210% and 66% increase in traffic contacts. This resulted in a -58% reduction in Part 1 crimes from 29 to 12. Thanks to their pro-active approach and successful implementation of our Data Driven Approach to Crime and Traffic Safety patrol strategy, we were able to have a significant reduction in crime.
