

This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

Demographics

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

Staffing

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- Criminal Investigations Division overseen by a Lieutenant
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police



The Patrol Division is commanded by Lieutenant Jesus Ortega. It is comprised of 2 Lieutenants, 3 Sergeants, 3 Corporals and 12 Patrol Officers. They operate 24 hours a day 7 days a week on rotating shifts. The shifts rotate every 56 days while days off rotate every 28 days.




Community Outreach

Month to Month Comparison














2024 Case Priority





Notable Activities for CID, Traffic, Forensics & Warrants Section:

Traffic Division

Officer Eric Delgadillo assumes the responsibility of enforcing commercial vehicle regulations, conducting thorough inspections to address both minor administrative discrepancies, colloquially referred to as "paper" infractions, and more significant lapses in essential safety equipment maintenance.

His contribution is instrumental in mitigating potential risks that could result in severe accidents. Officer Delgadillo's efforts contribute significantly to upholding road safety standards and ensuring compliance within the commercial transportation sector, as evidenced by his commitment to addressing and rectifying regulatory violations.

Every detailed roadside inspection can take upwards of 2 hours to complete. During the month of June, Officer Eric Delgadillo conducted 3 inspections and found 2 commercial vehicles not road worthy.

Warrants Division and Bailiff

Officer Abraham Diaz assumes a multifaceted role within the law enforcement department, serving as the Court Bailiff and the Warrants Officer. His contributions make him an indispensable member of our law enforcement team. As the primary point of contact for matters pertaining to the municipal court, convened biweekly, Officer Diaz ensures the seamless functioning of court proceedings.

Just as in the month of May, another 7 traffic warrants for Horizon City Municipal Court were executed during the month of June. all of which were referred to the municipal court where the arrestees made bond and court arrangements.

Executing traffic warrants and referring arrestees to the municipal court benefits the community by enhancing public safety and promoting legal compliance. Addressing outstanding warrants ensures that individuals who might be driving illegally are held accountable, reducing the risk of traffic incidents and improving road safety. Additionally, this process encourages adherence to traffic laws, fostering a culture of lawfulness and responsibility among drivers.

All vehicles in the fleet are operational and in service.

SORT Program

Our SORT program is led by Officer Victoria Hernandez. SORT stands for "Sex Offender Registry and Tracking". The programs is designed to maintain a database of individuals convicted of sex offenses, providing law our agency with the tools to monitor and track registered sex offenders within our jurisdiction. Our program is currently under development and will empower our agency to monitor these individuals closely.

Departmental Significant and Notable Accomplishments



Independence Day

The Fourth of July is the utmost holiday of the year for the communications division as a result of the high number of fires and calls related to fireworks received. Three dispatchers were assigned to call

take at the El Paso Regional Communication Center located at 6055 Threadgill. The five consoles at the Horizon City Police Department were assigned to dispatch county fire and police. During the hours of 19:00 and 1:00, crisis radio procedures were in effect. Sixty-four fire calls and eighty-nine police calls were received between 18:00 and 6:00.



Interoperability between Departments



The communications manager and a communications specialist met with communications department heads from El Paso Sheriff's Office, Department of Public Safety, Socorro Police Department, Ysleta del Sur Pueblo and Border Patrol to discuss interoperability between departments. In the event of a major incident, it is vital agencies can speak to each other immediately without barriers. The department heads will be meeting again to work on Standard Operating Procedures and decide which channel will be assigned to major

incidents in the case it is ever needed. Responding units to a major incident will have a clear understanding of which channel they must respond on and will be able to communicate with other agencies.

Forthcoming Encryption

The communications manager is currently working with Communications America to have the Horizon City Police Department radio channels encrypted. With the police radio channels being encrypted, no scanner can monitor transmissions. Encrypting radio transmissions protects

to listen to the Horizon City Police Department radio transmissions. Currently, the El Paso Police Department and the El Paso Sheriff's Office have encrypted channels.



Mandated Training

Mirna Sierra and Robert Herrera attended the 24-hour mandated TCIC/TLETS Full Access Operator Training



Course. This course is for operators who perform all TCIC/NCIC functions, including inquiry, entry, modification, clearing, canceling, and III functions. In addition, five communications specialists attended the four-hour CPR course which is a requirement for the Basic Telecommunicator Course and the Emergency Fire and Medical Dispatch Certification.

Motor Vehicle Accident News Media Interviews

On Sunday, July 7, 2024, Officers from the Horizon City Police Department responded to a residence regarding a motor vehicle accident involving a pedestrian. Officers from the Special Traffic Investigation Divisions responded to the scene as well as detectives from the Criminal Investigations Division to conduct their investigations. Officer V. Hernandez also responded to the scene as the Public Information Officer to speak to

the media that showed up on scene. Officer Hernandez conducted an interview to release information that was known at the time to inform the public of the serious incident that occurred. The following day, Monday, July 8, 2024, Officer Hernandez conducted an additional interview through zoom to provide a summary of the incident to Univision 26 and give some safety tips to the El Paso community when they're driving and see a pedestrian.



915 Heroes Day (2nd Meeting)

On Tuesday, July 9, 2024, Officer V. Hernandez and Detective A. Labrado attended the second meeting at the University of Texas at El Paso (UTEP) regarding the 915 Heroes Day that will be taking place September 7, 2024. Officers from the El Paso Police Department, Socorro Police Department and Sunland Park Police Department attended the meeting along with other organizations. The meeting consisted of providing additional ideas for the day of the event as well as finalizing other ideas that were provided during the first



meeting. It is the second year that UTEP hosts this event to honor all first responders during a home football game. The event will consist of multiple agencies displaying their marked units as well as having personnel engage and greet the community as they arrive to the game. Officers will also greet the football players as they head over to the stadium. A multi-agency color guard will also be present and those agencies who wish to participate will be able to present their agency flag.



Traffic Safety Coalition Zoom Meeting

On Thursday, July 11, 2024, Officer V. Hernandez attended the monthly Traffic Safety Coalition Meeting that took place through Zoom. As always, the meeting started with the Pledge of Allegiance followed by a moment of silence. The meeting consisted of two different presentations; "El Paso District Safety Plan" by Jose Madrid a Transportation Engineer from Texas Department of Transportation and "Check to Protect" by Lonny Haschel, a Sr. Program Manager from National Safety



Council. The first meeting consisted of providing fatalities and fatal crashes. Different charts were shown to compare the number of fatal crashes by month between the years of 2021 through 2024. Charts comparing El Paso District vs. Statewide fatal crashes were discussed as well as whether the drivers and passengers were restrained or not when the crash occurred. During the second meeting, vehicle recalls were discussed, and statistics were provided. Recommendations were also given to always follow any special warnings.

13th Curbside Car Seat Class

On Friday, July 12, 2024, Officers from the Horizon City Police Department who are certified child passenger

safety technicians conducted their 13th curbside car seat class for the community. The class took place in the parking lot of Horizon City Hall. Officers conduct these



types of classes once a month and they do them by appointment only. Horizon City Police Department also takes walk-ins but only when a certified technician is available to conduct a car seat inspection or installation. The department can provide a car seat to families whenever is necessary at no cost to the parents or legal guardian. The officers' goal is to make appointments for approximately 10 to 15 kids per class. There are currently



three officers that are certified technicians, and two additional officers are

scheduled to attend the Child Passenger Safety Technician training that is coming up in October of this year to make it a total of five certified technicians.



VIN Etching at Walmart



On Saturday, July 13, 2024, Officers from the Horizon City Police Department along with the El Paso Police Department Auto Theft Task Force, El Paso County Sheriff's Office Peter John Herrera Patrol Station, and Constables Pct. 6

collaborated to organize a Vehicle Identification Number (VIN) Etching event at local Horizon City Walmart. The procedure for the VIN etching takes approximately ten to fifteen minutes to complete

and it involves permanently engraving the VIN onto the window surface of the vehicle. The VIN etching can help deter the theft of the vehicle and it may qualify for insurance discounts. During the event, all law enforcement officers provided the community with child fingerprinting services in case a child ever



goes missing. Complimentary hot dogs and non-alcoholic beverages were also provided to the community.

Texas Tech Dental Students Meet



On Tuesday, July 16, 2024, Lt. Valdez and Officer V. Hernandez met with multiple medical and dental Texas Tech students to answer health questions about our Horizon City community. Officer Hernandez and Lt. Valdez provided information to the students about their current duties within the department and allowed the students to introduced themselves. This is the second year that officers from the Horizon City Police Department meet with Texas Tech students to answer any questions they had. Officers enjoy participating in these types of projects that college students have to conduct during their time in school because it gives the

students an opportunity to learn more about the community in El Paso County. As for the officers, they are given the opportunity to educate the students on any matter that officers come across during their careers.



Back to School Haircut Voucher Giveaway

On Thursday, July 18, 2024, Lt. Valdez and Officer V. Hernandez worked together to create vouchers to give away to the community for kids to get a free back to school haircut. Last year, officers from the Horizon City Police Department collaborated with Trnd Setters in Horizon City to provide free haircuts to children going back to school. The goal was for the police department to collaborate once again and be able to fundraise money to provide those free haircuts to 120 kids. On this day, Lt. Valdez and Officer Hernandez announced through social media



that parents could stop by the police station and pick up free vouchers for a haircut. Officers remained at the police station until 7:00PM that day conducting live videos encouraging people to stop by. During that day most of the vouchers were given away to parents and secured children a free haircut. HCPD is determined to keep giving back to the community and continue to build great relationship with Horizon City residents.

The detective squad responded to a rash of vehicle burglaries by having investigators patrolling neighborhoods in plain clothes and unmarked vehicles. Although investigators did not uncover specific leads to the cases, suspicious activity was referred to those officers in marked vehicles who were able to essentially be in two places at one which helped our officers allocate resources and the thefts seemed to have stopped.

Surveillance was not the only method of crime deterrence. As these crimes were being reported to the police department, it was soon determined that most of the car break ins were due to the vehicle having been left unlocked. To raise community awareness, the three major facets of our agency came together and brainstormed a series of measures which surely contributed to educating our community.

Patrol Division contributed by contacting homeowners whose vehicles were found with open windows and doors during the overnight hours. For clarification these vehicles were found with rolled down windows, and doors swung wide open. Officers did not pull handles to test the security of the vehicle.

The detective squad and community resource divisions put their minds together and came up with a creative way to reach our community and spread the message about locking vehicles to prevent theft. Initially, a meme was created illustrating how vehicle burglary is often perceived as a perpetration of sophistication and precision — with the truth being that most incidents are the result of vehicles left unlocked. The second message was a short TikTok style video which tempts the viewer to see how a homeowner caught a young man breaking into his car only to be bait and switched to a video of the young man failing to open the locked doors. The message, self-aware of the bait and switch touts that the police department just got them to watch a video about locking their vehicle and encourages them to share the video with their friends. At the end of July the video has over 5k views.

Cpl. Cameron Zeiger welcomed a new baby boy to his family three months ago and left Officer Perez in charge of filing his position while he was on leave. Officer Perez assisted Sgt. Heli Sierra with the Corporal duties along with continuing to fulfill his Field Training Officer duties throughout the three months of Cpl. Zeiger's absence. We would like to recognize Officer Perez for taking on this role and for his continued dedication to his shift and the Horizon City Police Department.



Great Work
