This report is designed to provide statistical information illustrating the Horizon Police Department's operations and administrative functions. The statistical information reported will provide staff with guidance for operational planning, workload assessment and statistically compare our productivity to the previous year. It serves to make necessary adjustments in policies and procedures to meet state and national standards for accreditation.

#### **Demographics**

The Horizon City Police Department is comprised of 30 officers and 20 communication specialists. The Police Department are entrusted to patrol approximately 8.5 square miles and provide public safety services for approximately 22,000 residents. Our communications Division is charged with providing emergency phone and dispatch services to the Police Department and approximately 170,000 residents for Fire and Emergency Services under Emergency Management District #1 and Emergency Management District #2.

#### Staffing

The Chief of Police oversees the Assistant Chief and the Communications Manager. The Assistant Chief of Police oversees the 2 Lieutenants and oversees the Detectives and other investigative personnel. The Patrol Lieutenants oversee the Patrol Sergeants. The Communications Shift Supervisors report to the Communications Manager. The Department consists of primarily Four operational divisions.

- The Patrol Division is overseen by 1 Lieutenant.
- Criminal Investigations Division overseen by a Lieutenant
- Communications Division overseen by the Communications Manager
- Support and Administrative Functions overseen by the Chief of Police



The Patrol Division is commanded by Lieutenant John C. Rodriguez. Daily activity data is compiled and analyzed in conjunction with our criminal investigations and crime preventive divisions. The division is comprised of 1 Lieutenant, 3 Sergeants, 3 Corporals and 12 Patrol Officers. They operate 24 hours a day 7 days a week on 12-hour shifts. The shifts and days off rotate every 56 days.

Our Data Driven Approach to Traffic and Crime Safety is our patrol strategy designed to focus on the hot spot areas for accidents and criminal incidents. Below are the hotspot locations and number of contacts charts.






#### **Investigations**



#### October Cases By Category








#### Notable Activities for CID, Traffic, Forensics & Warrants Section:

#### **Traffic Division**

Officer Eric Delgadillo is responsible for enforcing commercial vehicle regulations and conducting thorough inspections to address minor administrative discrepancies, or "paper" infractions, and more significant lapses in essential safety equipment maintenance.

His efforts are crucial in mitigating potential risks that could lead to severe accidents. Officer Delgadillo's commitment to upholding road safety standards and ensuring compliance within the commercial transportation sector is evident in his dedication to addressing and rectifying regulatory violations.

Each detailed roadside inspection can take up to 2 hours to complete. During September, Officer Eric Delgadillo conducted 3 inspections and found 2 commercial vehicles that were not roadworthy.



# **Departmental Significant and Notable Accomplishments**



#### eGrants Training

The communications manager, assistant communications manager and patrol lieutenant attended an

8-hour eGrants Training session hosted by The Texas Governor's Public Safety Office (PSO) at the El Paso Regional Communications Center. The training provided attendees with the knowledge and skills essential to navigating the eGrants system when carrying out grant-related operations.



#### **Terminal Agency Coordinator (TAC)**



Shift Supervisor Anthony Dominguez and Communications Specialist Assistant Manager Irlanda Huerta attended an eight hour Terminal Agency Coordinator Training at the Tribal Communications Center located at 601 Tiwa Blvd. The TAC role is required by the FBI Criminal Justice Information Services (CJIS) Security Policy. A Terminal Agency Coordinator act as the liaison between their agency and the Criminal Justice Information Services (CJIS) Systems Agency, must be knowledgeable with the operations of TCIC/NCIC, and ensure agency compliance with TCIC/NCIC policy.

#### **Vision 2024 FirstNet Users Summit**

Communications Manager Elva Ramos and IT Josue Mendoza attended a weeklong Vision Summit conference in Las Vegas, Nevada. The conference aims to provide all individuals and organizations involved in safety, security, emergency, and crisis response with the necessary knowledge, tools, and technology to keep the community safe. The summit featured workshops, products, and applications tailored to the department's responsibilities and the needs of the Town of Horizon City.





#### **New Supervisor Training**

Shift Supervisors Stephanie Cortes and Anthony Dominguez attended a three-day New Supervisor Training Course at the Law Enforcement Training Academy. The course was insightful regarding the transition of entering into a role of authority over peers. The lesson included advice on how to handle the new duties with respect including techniques to identify areas to improve and motivate employees based on the type of employees they are. It also included pointers on how to conduct



yearly evaluations that are detailed, how to take responsibility of their actions, and how to provide discipline to employees when needed. The course also included information regarding the different types of leadership styles and the pros and cons of each.

#### ICS-300 Intermediate ICS for Expanding Incidents and ICS-400 Advanced ICS

Shift Supervisors Stephanie Cortes and Anthony Dominguez attended a weeklong ICS- 300 and 400 courses. The ICS-300 Intermediate ICS (Incident Command System) provides training and resources for personnel who require advance knowledge and application of ICS. The ICS-400 provides training and resources for



personnel who require advanced application of ICS. Both courses are for emergency response personnel in a command or general staff position during a large or complex incident. The courses build on the information covered in the ICS-100 and ICS-200 courses. Both courses included group exercises, discussions, simulations, and final exams.

#### **Vesta End-User Training**

Communications Specialist Ericka Gonzalez and Shift Supervisor Stephanie Cortes attended the four-hour Vesta End-User Training. The Vesta Essentials course provides attendees with information and utilization of Vesta's version 8.0. Users acquired knowledge about the available functions and layouts that Vesta provides while gaining insight into features that can better assist the Vesta user.





#### **National Night Out 2024**

On Tuesday, October 1, 2024, Horizon City Police Department celebrated National Night Out with thousands of community members and community partners. National Night Out is a nationwide event that takes place annually to promote law enforcement and community partnerships to make our communities safer and to create better relationships. Horizon City Police Department and Horizon City Fire Department personnel worked endlessly for multiple weeks, planning, networking and making necessary changes to provide a great event to those who attended. Just like last year, the event began by having Naval Air land their helicopter at the park. One of the changes the event had compared to last year is that Horizon City Police Department provided the opportunity to Horizon High School JROTC present the colors followed by Didi Mora Franco singing the National Anthem. Pastor Garrett Hiller provided everyone with a prayer and multiple speakers shared some words with the community to include District Attorney Bill Hicks and Horizon City Mayor Andy Renteria. Multiple presentations included Horizon High School Dance, Lucha Libre, Horizon City Athletics, Eastlake High School Cheer, Eastlake High School Dance, Drumlines (Horizon vs. Eastlake), Fire Department vs. Police Department Tug-o-War, Fire Department and Police Department Hot Dog eating contest. Over 15 law enforcement agencies, city, state and federal gathered for the event as well as fire departments. All these presentations have now become a tradition to the community and participants that everyone gets eager to see what the outcomes is every year. The night ended with a twelve-minute firework show, where everyone in attendance got to enjoy the beautiful view and great music next to their loved ones. There was an estimate of a few thousands of people in attendance. Horizon City, its police and fire departments are happy to continue building more relationships between the community and our first responders to better help protect and serve them.





#### Sex Offender Registry and Tracking (SORT) Unit

On Monday, October 14, 2024, Det. V. Hernandez attended Sex Offender Registry and Tracking (SORT) Unit with El Paso County Sheriff's Office (EPCSO). In previous months, Det. Hernandez would attend SORT every Monday to assist EPCSO in registering new sex offenders or entering any updated personal information to have the most accurate information on all individuals and know their whereabouts. Prior to that day, Det. Hernandez was reached out by one of the EPCSO deputies requesting assistance since one of them was going to be out of the office for that week. Det.



Hernandez along with another EPCSO deputy completed approximately 30 new registrants and updated information for individuals all combined. The goal for HCPD is to take up on the task of keeping track of the sex offenders that are within Horizon City jurisdiction therefore, it is a great



opportunity to work closely with other agencies and become familiarized with the process.

#### <u>City of Socorro Trunk or Treat / National Night</u> Out

On Friday, October 25, 2024, Commercial vehicle Enforcement Officer E. Delgadillo, Lt. K. Valdez and



Det. V. Hernandez attended Socorro's 2024 National Night Out at Rio Vista Center. Multiple vendors supported the event and promoted their services as people walked around informing themselves about the duties and/or responsibilities for other law enforcement agencies as well as Trick or Treating. The event took place between 6:00PM to 10:00PM and Officers greeted hundreds of kids and parents as they took

photos with their Halloween costumes. At the end of the night, Socorro PD hosted a Halloween costume contest. The contest was divided into different age groups and every participant was called to the stage where judges would rate the costumes. Each age group had a winner and received a prize. Horizon City Police Department continues supporting other law enforcement agencies to build better relationships amongst each other and most importantly with the citizens of our El Paso community.



#### **16<sup>th</sup> Curbside Car Seat Class**

On Wednesday, October 30, 2024, Officers from the Horizon City Police Department who are certified as child passenger safety technicians conducted their 16<sup>th</sup> curbside car seat class for the community. This class took place at local Golden Eagle Park. Horizon City Police Department certified technicians conduct these curb-side classes once a month. The department allows for walk-ins, but it is preferably to conduct these classes by appointment only. Officers are



only able to take a walk-in when a certified technician is available to conduct a car seat inspection or installation at the time of the walk in. There are currently five officers that are certified technicians, compared to only three last month. During this month's curb side car seat class, a total of 9 children were scheduled for an appointment. Officers were able to provide 8 car seats to all children and
