

# What is a Christian View of Halloween?

Although our modern celebration of Halloween has religious influences, there is nothing biblical about the holiday. It is affiliated with "All Saints' Day," but even this holiday is not supported by Scripture. The Bible does not tell us to pray for the dead. There is no purgatory the dead need to escape from. The spirits of the dead do not come back to visit us on earth. And although the Bible does not forbid us from remembering our loved ones, neither does it ordain the practice, and attempting to contact them was punishable by death (Leviticus 19:31). Christians can celebrate Halloween to the extent that they feel the freedom to do so and to the degree that the practices do not celebrate the occult. The various pieces of Halloween can be analyzed individually for their current cultural and personal significance. It is not biblical to endorse or represent demons, evil, sin, or anything that would lead another to sin. But there is no injunction in the Bible against making lanterns out of gourds, wearing superhero and princess costumes, and asking neighbors for candy. Many churches and Christian organizations have Halloween alternatives, like Harvest Parties. Others encourage their members to use Halloween to meet neighbors in hopes of getting a chance to witness. At the same time, if the origins of Halloween convict a Christian to reject the entire holiday, he or she should feel the freedom to do so, while giving others the freedom to act on their own beliefs. Within the church, we are not to judge anyone who uses their Christian liberty in a way that contradicts our personal convictions. Romans 14:5-6 says, "One person esteems one day as better than another, while another esteems all days alike. Each one should be fully convinced in his own mind. The one who observes the day, observes it in honor of the Lord. The one who eats, eats in honor of the Lord, since he gives thanks to God, while the one who abstains, abstains in honor of the Lord and gives thanks to God." Verses 13-19 say we are not to use our liberty to lead another into an act that he or she regards as sin. Our heart attitude should not be one that tries to justify the secular tradition of Halloween; nor should it be one that seeks out evil intent where there is none. Instead, we should strive to glorify God in all that we do. Whether we go trick-or-treating, attend a Harvest Party, or ignore the day altogether, our actions should reflect God's leading on our own lives.




### **OCTOBER 16<sup>TH</sup> is Pastor Appreciation Sunday!!!!**

This is what he wanted to do, and it gave him great pleasure. <sup>6</sup> So we praise God for the glorious grace he has poured out on us who belong to his dear Son. <sup>7</sup> He is so rich in kindness and grace that he purchased our freedom with the blood of his Son and forgave our sins. <sup>8</sup> He has showered his kindness on us, along with all wisdom and understanding. -Ephesians 1:3-8 (NLT)

One of the most beautiful aspects of being United Methodists is our connection to one another. It is a connection that is our human living out of the perfect connection to God that each of us was created into. We are not always perfect in our connection to God, and we are not always perfect in our connection to each other. Our United Methodist (and before 1968, our Methodist) connection has lived through stresses and strains in the past, and we are experiencing a time of stress in our connection with each other in the present. Because our connection with the Lord is eternal, we can choose how we navigate these turbulent times. I hope that all of us will remember that whether we are connected as United Methodists in the future or not, we are all brothers and sisters in Christ. Nothing changes that, because it is not from us, but is a gift of God to each of us and all of us together.

Indeed, we are in the midst of troubling times, both within our United Methodist connection and in the world at large. We know that we are in a time of rapid change, and we can't quite make out what it will be like when the "merry-go-round" stops. It is easy to feel out of control, and that can lead to anxiety, fear, and even anger. While there are many things we individually cannot change, we can choose how we live through these times. We can all lean into the Holy Spirit and double up on our prayer time. We can all be mindful and caring towards our neighbors, whether we agree or disagree with them. For me, it is also helpful to have good information that I can rely on.

I have had the blessing of visiting with several church families to share information about the VAUMC disaffiliation process. These church families have found it helpful to have this information to assist them with their prayerful discernment and to free them to move forward calmly. Whether they decide to go forward into the disaffiliation process or just wanted to know what was going on, information and conversation nurture our connection as sisters and brothers of Christ, and as United Methodists. As your District Superintendent, it is my responsibility and my ministry among you to equip you for living out these days. While I have shared with church families who may be curious, interested, or committed to disaffiliation, I feel it is critical that all of the Mountain View District have the benefit of accurate information about the disaffiliation process.

While I (and the Bishop, Cabinet, and Conference Leadership) would desire all of us to remain connected as United Methodists, making disciples of Jesus Christ for the transformation of the world, I do realize that there are some who are feeling called to a different path. I hope this information will be helpful in clearing up some confusion you may be experiencing and leave all of us equipped to focus on the Kingdom work we are ALL called to as God's family in Christ.

- No church is required to vote. No one is making anyone do anything
- If your church is curious, interested, or committed to disaffiliation, contact me (DS Denise or MV District office) to schedule an information meeting
- The process can be stopped by the local church at any time
- The process is the same regardless of what faith tradition you align with or become independent following disaffiliation
- There is no need to justify "why" to anyone outside of your church family. This process is centered on the discernment of the local church family
  - o Clergy are not to influence /pressure their church families—this is the church family's discernment
  - Laity are not to pressure/influence their pastor—they have their own discernment
  - Clergy and Laity are not to influence/pressure other church families or clergy
- Following the Disaffiliation Process and paying the Disaffiliation Costs relaxes the Trust Clause, allowing the local church to leave with ALL of their property, real and personal, tangible and intangible. The cost is in NO WAY related to the value of your property

Friends, I know this is a lot of information, but it is the information for these days and for disaffiliation. My desire is for everyone to have the correct information as we paddle through these times together. ~ *Denise Bates*


