Retainer Fee: A \$100 “good faith” retainer is required to reserve your order and will be applied toward the final balance. The first 24 hours after submitting the retainer serve as a grace period: if the client changes their mind within this time, the full retainer will be refunded. After 24 hours, the retainer is non-refundable.

Final Payments/Late Payments:

- **Accepted Payment Methods:** Retainers and early account payments may be made by check, cash, or debit/credit via PayPal invoice. **Final payments must be made by cash or debit/credit via PayPal only.**
- **Due Date:** The remaining balance is due no later than 14 days prior to the event date. Accepted forms of payment for the final balance are cash or debit/credit via PayPal.
- **Late Payment:** If the balance is not paid in full by 14 days prior to the event, a \$100 late fee will be added.
- **Returned Check (Retainers/Early Payments Only):** If a check for a retainer or early payment is returned for insufficient funds, a \$50 returned-check fee will apply. The total amount owed, including any returned-check fees, must be paid **within two (2) business days of notification** by cash or debit/credit via PayPal.
- **Payment Deadline:** All balances and applicable fees must be paid in full no later than 7 days prior to the event. Orders will not be prepared without confirmed payment. If payment is not received by 5:00 p.m. on the 7-day deadline, the order will be automatically cancelled. No product will be provided, and all payments made are non-refundable.
- **Ownership of Product:** All products remain the property of Nummy Crumb, LLC until payment is received in full.
- **Automatic Cancellation / Breach of Contract:** Failure to remit full payment and any applicable fees by the 7-day deadline constitutes a breach of contract. The client waives any right to claim damages or refunds from Christi Murphy or Nummy Crumb, LLC. Payments are non-transferable to another person, order, or event date.

Prices: Applicable sales tax will be added to all orders.

- Wedding Cupcakes - \$36/dozen
- Decorated Wedding Cookies - refer to separate quote
- 6” Wedding Cake (serves 10)/\$4 per slice - \$40
- 8” Wedding Cake (serves 24)/\$3.75 per slice - \$90
- 10” Wedding Cake (serves 40)/\$3.75 per slice - \$150
- Pre-boxed Anniversary Cake - \$45

Cancellation and Refund Policy:

- **30+ days before event:** Verbal notice & written confirmation required. All payments, excluding the non-refundable retainer, will be refunded within 7 days.
- **29 days or fewer before event:** All payments are non-refundable and non-transferable. **Retainer:** The retainer fee is always non-refundable.

Changes in “Event Date”: Any request to change the event date must be approved by Christi Murphy and is subject to availability. Once approved, the client must submit written confirmation within 24 hours. If the new date causes a scheduling conflict, the client agrees to pick up the order from 2808 Browns Lane, Louisville, KY, with no discount or price adjustment.

Change of Venue / Out-of-State Policy: If the event venue is moved to Indiana or any location outside Kentucky, the order must be picked up at 2808 Browns Lane, Louisville, KY. No discounts or price adjustments will apply. Due to Kentucky Cottage Food Laws, Nummy Crumb cannot deliver outside Kentucky.

Pick Ups: If the client or their representative chooses to pick up and set up the cake, cupcakes, or other items, the client assumes full responsibility and liability for their condition once they leave Nummy Crumb’s location at 2808 Browns Lane, Louisville, KY 40220.

Ingredients - Our products may contain or come into contact with milk, wheat, nuts, soy, or other allergens. You agree to notify your guests of this risk & hold Christi Murphy (aka Nummy Crumb, LLC) harmless for allergic reactions.

Use of Images - Nummy Crumb, LLC may use photos of products or events for promotional purposes, including social media, website, and marketing materials.

Acts of God/ Emergencies and Unforeseen Events: Being that weddings are a live, uncontrolled event, it is in the best interest of all concerned to have clear and acceptable plan of action should any unforeseen situation arise. Should Christi Murphy and/or Nummy Crumb, LLC not be able to fulfill order as agreed upon due to an extraordinary event beyond our control, we shall do the following. **Our responsibility to each event is as follows:** If Christi Murphy experiences a personal emergency, such as the death of an immediate family member or hospitalization, or if an event is impacted by inclement weather, natural disasters, civil unrest, or vehicle issues, the client agrees that a full refund of all payments, including the retainer, is the sole remedy. Refunds will be issued within two business days of notification or the event. The client releases Christi Murphy and Nummy Crumb, LLC from any further claims.
