New license fee due when license approved by Commission. Renewal fee due by September 30<sup>th</sup>. Late payments will incur a penalty of 10% in October & 5% each month after. A 25% penalty fee will be added if business is conducted prior to obtaining a Business Tax Receipt. Business Tax Receipts not paid within 150 days after initial notice are subject to civil action and penalties. Refer to Beverly Beach Ordinance 2011-01 for complete regulations, restrictions, and payment information.
