KNOW ALL MEN BY THESE PRESENTS, that we, William B.

Collister, President, and Virgil Davis, Secretary, officers of
the Crestmoor Park (2nd Filing) Homes Association, and residents
of the State of Colorado, desire to restate the Articles of
Incorporation of said Association pursuant to the general laws
of the State of Colorado, Article 21 of Title 7. Colorado Revised
Statutes 1973, as now amended. Further, the above-mentioned
officers of said Association desire that the Crestmoor Park (2nd
Filing) Homes Association continues to qualify as a Colorado
Non-Profit Corporation pursuant to the general laws of the State
of Colorado, Articles 20-29 of Title 7, Colorado Revised Statutes
1973, as now amended.

WHEREFORE, the above-mentioned officers, in accordance with the provisions of the laws of Colorado, do hereby make, execute and acknowledge, in duplicate, these Restated Articles of Incorporation:

ARTICLE I

Name

The corporate name and style of our said Corporation shall be Crestmoor Park (2nd Filing) Homes Association.

ARTICLE II

CORPORATE PURPOSES

The purposes of this Corporation are to advance the interests of Crestmoor Park (2nd Filing), a subdivision of the City and County of Denver, State of Colorado, and to maintain the same as a high-class residential subdivision and, in general, to initiate, promote and perfect any and all matters and things of mutual interest, benefit and advantage to said subdivision and

to the persons who from time to time may be owners of property within said subdivision.

ARTICLE III

BY-LAWS

The members of the Board of Directors of the Corporation shall have the power to make such By-Laws as they may deem proper for the management of this Corporation, not inconsistent with the laws of the State of Colorado.

ARTICLE IV

PERPETUAL EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V

MEMBERSHIP

Membership in this Corporation shall be restricted to such persons as may from time to time be the owners of a lot or lots within the Crestmoor Park (2nd Filing) Subdivision in the City and County of Denver, subject to such restrictions and limitations as may be imposed by the By-Laws of said Corporation.

ARTICLE VI

NON-PROFIT

No part of the net earnings of this Corporation shall inure to the benefit of any member of the Crestmoor Park (2nd Filing) Homes Association or any individual. No part of the income or profit of this Corporation may be distributed to the members, Directors or officers of Crestmoor Park (2nd Filing) Homes Association.

ARTICLE VII

DISSOLUTION

Upon the dissolution of Crestmoor Park (2nd Filing) Homes
Association, the Board of Directors shall, after paying and making
provision for payment of all of the liabilities of the Corporation,
dispose of all of the assets of the Corporation exclusively for

the purposes of the Corporation in such manner, or to such organization or organizations under Sec. 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VIII

BOARD OF DIRECTORS

The Board of Directors shall be selected as provided for in the By-Laws of the Corporation.
