

Health Warranty and Purchase Agreement

This contract is between "Mini Goldendoodles of NY" (Hereafter "Seller") and _____ (Hereafter "Buyer") and is entered on this date: _____.

Seller's Responsibility:

1. The Seller guarantees the puppy is in good health, is up-to-date on immunizations appropriate for the puppy's age and has been dewormed, at the time the Buyer takes possession. The Buyer has three business days to take the puppy to a veterinarian for an examination. If the puppy is found to be in poor health, the Buyer has the option of returning the puppy to the Seller, at Buyer's cost, for a full refund, or keeping the puppy, and the Seller will reimburse for all veterinary costs, up to the purchase price, related to treatment of any pre-existing condition. If the puppy is not taken to a licensed veterinarian within the three business days, the Health Warranty is void.
2. The Seller will provide a 21-day money back guarantee. The Buyer has three weeks from the date of purchase to introduce the puppy to their new home. If for any reason within 21 days the puppy is not a good fit, the Buyer may return the puppy for a full refund less the non-refundable deposit. This guarantee is void if the puppy was not examined by a veterinarian within three days of purchase or if the puppy's health has declined for any reason other than the health conditions covered by the two-year health warranty.
3. The Seller provides this warranty for two years after the date of sale against life-inhibiting genetic defects, including hip dysplasia, elbow dysplasia, eye conditions that are genetic in origin, von Willebrand's Disease, and genetic heart disorders that are serious enough to require treatment. In the event the puppy exhibits symptoms of one of these defects, the Buyer must contact the seller immediately and supply any requested veterinary records to the Seller.

4. This warranty does not include viral illnesses, infections, improper bites, hernias, hypoglycemia, Giardia or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.
5. If it is determined the puppy does have a covered genetic disorder that is identified within two years of purchase, the Buyer has the option of: (1) either a replacement puppy from the next available litter, or (2) reimbursement, up to the purchase price of the puppy, of all veterinary expenses related to the illness. Puppy does need not be returned to Seller. The deposit will not be refunded, and if it becomes necessary to ship a replacement puppy, those fees are to be paid by the Buyer.
6. If the puppy should die from a suspected congenital defect within 24 months of its date of purchase, an autopsy must be performed at the Buyer's expense by a veterinary teaching hospital or state licensed DVM acceptable to the Seller's own veterinarian. If the autopsy shows a congenital defect as the reason of the death, the Seller will provide another puppy of equal value to the purchaser. A written statement from the veterinarian must be provided. This warranty is void in the event of an indeterminable or inconclusive diagnosis.
7. Seller agrees to provide the number of the microchip that has been implanted in the puppy.
8. This warranty is non-transferable.

Buyer's Responsibility:

1. The Buyer agrees to pay the Seller a total sum of \$ _____, inclusive of a \$_____ non-refundable deposit.
2. The Buyer agrees that their Goldendoodle will be housed indoors.
3. The Buyer agrees to feed their Goldendoodle only a quality food.
4. The Buyer agrees to keep their Goldendoodle at a healthy weight.
5. The Buyer agrees to make and keep annual veterinary appointments for their Goldendoodle, keep all immunizations current according to the guidelines of the AVMA and properly administer heartworm preventative if recommended for your area.
6. The Buyer agrees to provide basic obedience training with their Goldendoodle puppy within the first year of owning their dog.
7. The Buyer agrees to postpone strenuous, repetitive exercise until after their Goldendoodle is over one year of age.
- 8. The Buyer agrees to contact the Seller immediately if the Buyer determines they are unable to keep their Goldendoodle for any reason. The Buyer and Seller will determine how the dog will be rehomed.**
- 9. The Buyer agrees to never place the Goldendoodle in a shelter, pound or similar facilities or research laboratory.**
10. The Buyer understands that the money paid for the puppy is non-refundable unless the puppy is found to have a debilitating congenital defect as stated in this contract.
- 11. Buyer agrees to spay or neuter the pup before it reaches the age of seven (7) months. Failure to do so will void this guarantee.**
