Monthly Meeting

October 4, 2023

The Keating Township Supervisors met on October 4th, 2023, at 6:00 pm in the Township Building with Chairman David McClain bringing the meeting to order and leading the Pledge of Allegiance. Supervisors Anderson, Spittler, Secretary Bowser and four (4) township residents attended the meeting.

OLD BUSINESS:

- 1) A motion was made by Supervisor Spittler/2nd Anderson to accept Henderson & Pee contractors quote of \$8,488.00 to do repairs on the building. Motion carried unanimously.

NEW BUSINESS:

- 1) A motion was made by Supervisor McClain/2nd Spittler to adopt Resolution 2023 – N for Code Enforcement. Motion carried unanimously.

- 2) Supervisor McClain gave an update on the West Valley Bridge and that we were able to get an emergency permit. Supervisor Anderson stated that we were offered a galvanized steel decking from another township for \$5,000.00.
- 3) Supervisor McClain stated we will receive \$188,448.94 for 2024 liquid fuels.
- 4) The municipal State Aid Allocation for retirement we received is \$19,137.01.
- 5) Assessor's Office – None

- 7) Cecil Gallup inquired about the life expectancy of a grinder pump. He also asked if the refinery was going to help from Rt 46 to railroad tracks on East Valley Road. No work will be done until Spring of 2024. Cecil also wondered if the excavator was up for sale. John Stratton voiced concerns with the W. Valley bridge being closed and wondering how long. John inquired about any future permits for repair work. John also expressed concerns with the injection well in cyclone and how it would affect the residents water wells.
