Speed Limit Sign Solar/Battery Operated: Harrisville Borough is going to provide Marion Twp with the specifications so battery can be ordered and permit can be obtained.

Entertainment Tax: No new update. Toni Marie Urbanek is upset about this and will work on it.

Richardson Inspection Services: Hilliard 210-S1-B4 - Violation notice has been sent and Richardson is providing enforcement. Burns 210-2F47-9A - Violation halted as he is making arrangements to have the home demolished and removed.

COSTARS Salt Contract for 2026-2027: Registration is open until March 15, 2026. Motion made by Craig Pierce, second by Dave Malinski, to apply for 50 tons of salt. All in favor, motion is carried and approved.

Michelle Marlowe: Donation request for the Community Easter Event that will be held at the Marion Township Park on April 4, 2026. Marion donated \$300 to this event in 2025. Motion made by Patrick Martino, second by Craig Pierce, to donate \$300. All in favor, motion is carried and approved.

Declaration of Disaster Emergency: Motion made by Dave Malinski, second by Patrick Martino, to ratify the Declaration of Disaster Emergency that was made on January 25, 2026, for the winter storm. All in favor, motion is carried and approved.

Kay Road Variance Agreement: Motion made by Patrick Martino, second by Dave Malinski (Craig Pierce abstained), to approve the Kay Road Variance and Compensation Agreement pending solicitor and PennDOT representative approval. All in favor, motion is carried and approved.
