

Airboat Addicts Privacy Policy

Effective date: July 15, 2026

Airboat Addicts ("we," "us," or "our") operates the Airboat Addicts mobile application (the "App") and the website airboataddicts.com. This Privacy Policy explains what information we collect, how we use it, and the choices you have.

Information We Collect

Account information. When you create an account, we collect your email address, name, and password (handled securely by our sign-in provider, Clerk). You may also add profile details such as a photo, location, and information about your airboat or interests.

Content you share. Photos, listings, posts, messages, and other content you choose to share in the App.

Location information. With your permission, we use your device's location to show nearby boat ramps, parks, tours, listings, and other members. You can turn location access off at any time in your device settings.

Purchase information. If you buy a subscription, the purchase is processed by Apple (App Store) or Google (Google Play). We use RevenueCat to manage subscription status. We do not see or store your credit card number.

Device and usage information. Basic technical information such as device type, operating system, and how you use the App, which helps us fix problems and improve the App.

How We Use Your Information

- To create and manage your account
- To provide App features such as the directory, tours, barter listings, and community
- To show you nearby content based on your location (with your permission)
- To process and manage subscriptions
- To respond to your questions and support requests
- To keep the App safe, prevent abuse, and comply with the law

Sharing Your Information

We do not sell your personal information. We share information only with:

- **Service providers** that help us run the App (such as Clerk for sign-in, RevenueCat for subscriptions, and our hosting providers), who may use it only to provide services to us
- **Other users**, when you choose to share content publicly in the App (such as your profile, listings, or community posts)
- **Law enforcement or authorities**, if required by law or to protect the rights and safety of our users

Your Choices

- **Access or update** your profile information at any time in the App
- **Delete your account** by contacting us at the email below; we will delete your account and associated personal information
- **Location** access can be turned off in your device settings
- **Subscriptions** can be managed or canceled through your Apple or Google account settings

Children's Privacy

The App is not intended for children under 13, and we do not knowingly collect personal information from children under 13. If you believe a child has provided us personal information, contact us and we will delete it.

Data Security

We use reasonable technical and organizational measures to protect your information. No method of transmission or storage is 100% secure, but we work to protect your data using industry-standard practices.

Data Retention

We keep your information for as long as your account is active or as needed to provide the App. When you delete your account, we delete your personal information except where we must keep it for legal reasons.

Third-Party Content and Links

The App may display content from or link to third-party sites and services (such as videos or social media). Their privacy practices are governed by their own policies.

Changes to This Policy

We may update this Privacy Policy from time to time. If we make significant changes, we will update the effective date above and notify you in the App or on our website.
