New Mexico Drug Recognition Expert Program

To whom it May Concern:

Your employee is applying for the 2025 Drug Recognition Expert Certification Program. The program is broken apart into three phases:

PHASE 1: The DRE training consists of a **pre-school (16 hours)**. This is a two-day, classroom training in which students are introduced to the term "Drug "as it pertains to drug impaired driving. Students are also given a proficiency exam on Standardized Field Sobriety Tests, as well as a written test which they must pass to continue to the second phase of training.

PHASE 2: The 7 or 8 school (which is taught at a later date after the pre-school) is 56-64 hours of classroom training. During this classroom training, the DRE candidate is taught the techniques of the drug evaluation, each drug category and signs and symptoms associated with them and physiology. The student must pass a comprehensive test at the end of this section to move on to Phase 3. Both Phase 1 and Phase 2 will be held separately all dates will be announced once they are planned.

PHASE 3: This phase includes the field certification, which will be done at the California Highway Patrol Office in Sacramento, California or at the Mesa Arizona Police station.

Evaluations are done on "live" drug impaired subjects and the DRE must formulate opinions for twelve subjects. After certifications are complete another comprehensive exam is given before the student can become a certified DRE. The trip will set a short time after the completion of phase 1 and 2. Students that are successful in phases 1 and 2 will know the dates of their Field Certification trip prior to returning to their department. The student should plan to be gone 5 days (which includes travel days) for this portion of training.

To become certified as a Drug Recognition Expert, attendance is mandatory in all three phases of training. There can be no exceptions to this. Signing below indicates the student will be able to attend all phases of training. The NMDRE program makes every reasonable effort to pay for all expenses related to the students travel up front, to avoid the student having to wait for reimbursement. If travel expenses are furnished by the NMDRE Program on behalf of your employee, and the employee does not continue with all phases of training, attempts will be made to cancel reservations. If the NMDRE program cannot be reimbursed by the companies providing the travel accommodations, the student or agency may be responsible for reimbursing the NMDRE program, depending on the circumstances surrounding the cancellations.

*As you can see, the certification process requires travel (in Phase 3, possibly also Phases 1 and 2 depending on your location). Please note that the program is funded in full by a grant and comes at no monetary cost to your agency. Lodging for Phase 1 and 2 (for students traveling 50 + miles to attend) and lodging and airfare for Phase 3 will be paid for up front by the grant however, Per-Diem must be paid for up front by the student. The student will be reimbursed at the Federal Per-Diem rate.

Please note that reimbursement checks will be made out and paid to the student and not the agency.
