VII. YTD Stats:

- a) There have been 106 Evaluations entered into the System to date for 2019
- b) Marijuana and Xanax are on the rise
- c) Request for National Statistics
- d) We are currently at 7% No Impairment and 6% Medical R/O. Can we see where the 7% are coming from?
- e) Joel Holt advised that If a DRE is called out and it is determined that the subject is not under the influence educate the Officer on what they see to make that determination to release.
- f) The Toxicology report may come back with no substance detected but SLD does not test for every substance that may cause impairment (Spice)

VIII. 2019 DRE School:

- d) Can we utilize our resources within Albuquerque to get the needed evaluations to be proficient. Possibly set a 3 day window for DRE's that are out of town to give the opportunity to get them done Contact APD Chain Of Command to set up. What would the cost be associated with this.
- e) Can we utilize APPO to do Evaluations?

X. DRE Retention

- a) We need to go out and promote the Program, possibly visit Department in person
- b) Get more support from Prosecutors and offer more training opportunities
- c) Can we utilize the Grant money to Pay for Overtime if the DRE is Called out
- d) Put out a Media release for each ARIDE and get the word out through the media
- e) Get More cases into the courtroom and increase presence of DRE Program

- b) We need to offer constant yearly training and also pull Prosecutors aside and show them frame by frame to make them understand.
- c) Possible get with Admin over at the UNM Judicial Education Center
- d) Get with Supervisors of the ADA's there is less of a turn over rate
- e) Contact the Defense Bar
- f) Get in contact with the National Association of County Sheriffs. They meet twice a year
- g) Get in contact with the County Commissioners

XIV. Open Discussion

- a) Provide encouragement for DRE's to push forward and do not back down from ADA/Prosecutors
- b) Can we look into more online classes?
- c) Can we provide Webinars for ADA's?
- d) Can we look into the Funding from DOT for our DRE's to be On-call?

- f) Offer class On the Federal bases their turnover rates are low
