Policy Statement:

- Eliminate gender disparities in education and ensure equal access to all levels of education and vocational training for the vulnerable, including persons with disabilities, indigenous peoples and children in vulnerable situations
- Ensure that all youth and a substantial proportion of adults, both men and women, achieve literacy and numeracy
- Ensure that all learners acquire the knowledge and skills needed to promote sustainable development, including, among others, through education for sustainable development and sustainable lifestyles, human rights, gender equality, promotion of a culture of peace and non-violence, global citizenship and appreciation of cultural diversity and of culture's contribution to sustainable development.

The key aspects of the quality of education:

- Further improvement of study success during the Bachelor's and Master's phases;
- Emphasis on academic development;
- Linking teaching and research in the Bachelor's and Master's phases;
- More ambitious academic culture;
- Room for both differentiation and specialization.

RESPONSIBILITY

LUC maintains huge governance and strategic changes that are helpful to fulfill policy objectives.

- Every faculty in LUC should propel a battle to bring issues to light of the UN Sustainable Development Goals and how they give an outline to both our institutional exercises and furthermore our individual practices.

✚ **Quality improvement work is to concentrate on the following criteria.**

1. University does not support any type of discrimination like

- Age
- Carer and parental status
- Disability (including physical, sensory and intellectual disability, work related injury, medical conditions, and mental, psychological and learning disabilities)
- Employment activity
- Gender identity, lawful sexual activity and sexual orientation
- Industrial activity
- Marital status
- Physical features
- Political belief or activity
- Pregnancy and breastfeeding
- Race (including colour, nationality, ethnicity and ethnic origin)
- Religious belief or activity
- Sex
- Expunged homosexual conviction
- Personal association with someone who has, or is assumed to have, one of these personal characteristics.

2. Library Facility for Common People

Lincoln University College campus library and e-library facility is open for all. With minimum charges anyone can take membership to access library and e-library services.

3. Conference Room for rent

If any college, university, or any study community has the lack of space to conduct any workshop or seminar, LUC provides campus Conference Room for rental against minimum charges.

4. Regular Workshop/Seminar

Lincoln University College conducts workshop, seminars on different notes in regular basis. Renowned Professors from different Universities and from foreign countries enriched students with their presence and intelligence.

5. Outreach Classes

Each faculty of Lincoln University College has to conduct at least 1 class or workshop every month for under privileged pupil.
