Please do not make a commitment for the course during a week you have another appointment. So please check your calendars so there are no discrepancies. Florida Department of Agriculture Division of Licensing requires 40 hours of learning and 2 hours for testing. So, it is imperative that you make it to every class. If you have an emergency and must leave class or cannot come to class, you must reschedule to take the next class to avoid interruptions in your training lessons. Do not bring anyone else to the class with you unless they are also signed up and have paid their tuition to take the course.

If you believe you are running no more than 30 minutes late, please call the Academy office at 941-893-4164. If you are too late, you must stay late for what you have missed to make up the 42 hours required. If you are absent, an evaluation of your excuse with the document presented will be made to determine your eligibility for another scheduled class. Your tuition will not be refunded but will be applied to the next class. Please note that you can only be rescheduled two times after your first absence. After the second attempt, you must pay another tuition of \$200, so please try to make the first class, if possible.
