The purpose of the show is to allow artists to display, compete and sell their work in an exhibit of the highest quality gourd artwork and weaving in a formal gallery venue and to promote and encourage public appreciation of each work of art.

Who: All fine art gourd and fine art fiber artists are eligible to apply.

When: Exhibit will open on Thursday, May 27 and run through Saturday, July 2

Opening reception and awards ceremony will be Saturday, May 29, 2 - 4 pm

Delivery: Work may be delivered at the Main Street Entrance (across from the Kerr County Courthouse) Monday, May 24, 9 am - 2PM or shipped to the Art Center, 228 Earl Garrett Street, Kerrville, TX 78028 for delivery no later than May 24, 2021. Return shipping of unsold work is the responsibility of the artist.

Pickup: Pick up work on Monday, June 25th between 9 AM and 2 PM. Shipped artwork not sold will be repacked and shipped via Federal Express by July 10th 2021. Artists must pay return shipping fees. Artists must include self addressed labels to be attached for return shipping.

Specifications: In gourd art, the gourd must be the dominant feature (at least 50%) of the entry.

All artwork -fiber and gourds must be original (i.e. no copyright infringement) in design and execution.

Artwork previously submitted must not have been shown at KACC.

Not-for-Sale Restrictions: 80% or 4 out of 5 of the gourds entered must be for sale.

Gourd Awards: The competition will be professionally judged and ribbon prizes will be awarded. The following awards will be given: **Best of Show** and **People's Choice**. **Best Newcomer Award** (awarded for best work among those artists participating in the show for the first time). **Category Awards** will be at the discretion of the judges. Some will be cash awards.

Gourd Categories: *Southwest/Western Theme* (any medium and inspired by southwest, western or Native American art), *Contemporary Theme* (any medium and inspired by abstract or contemporary art), *Basket/Fiber Works* (to include coiling, basketry, weaving), *Mixed Media* and *Sculptural/Figurative*. Artist will not designate the category of the piece. Category adjustments and placement is up to the judges.

Fiber Art Awards: The competition will be professionally judged and ribbon prizes will be awarded. The following awards will be given: **People's Choice**, **Best of Show**, **First, Second and Third Place**. **Judges' Special Awards** will be given the judges' discretion. Some will be cash awards. Categories may include: Tapestry, Basketry, Sculptural, Hand Weaving, Felting and Coiling, depending on the entries received.

Entry Fees: Each artist may exhibit up to 5 pieces for a **fee of \$50** due March 15, 2021. *Make check payable to KACC.*

General Conditions: KACC will use utmost care while handling your work, but will not be responsible for loss or damage.

KACC will handle sales during this event. KACC will collect and report sales tax to the State of Texas Comptroller. KACC receives a 30% commission on sales resulting from the Southwest Gourd & Fiber Fine Art Show. Payments will be made to artists by check within the current payment policy of KACC. KACC reserves the right to use images of your work for KACC and/or exhibit promotion and publicity. In order to maintain the integrity of the exhibit, KACC reserves the right to refuse any entry that does not meet the standards of the show or that is not consistent with the juried images.
