



LIABILITY RELEASE AND EXPRESS ASSUMPTION OF RISK

Please read carefully fill in all blanks and sign and date below.

1. I understand and agree that neither Steve Matthews, nor Canine Adventure nor any of their respective employees, agents or assigns, nor any licensor or property owner related to walk destinations (hereinafter referred to as "Released Parties") may be held liable or responsible in any way for any injury, death or other damages that may occur as a result of my dog's participation on the walks, or as a result of the negligence of any party including the Released Parties, whether passive or active.
2. I hereby personally assume all risks in connection with the dog walks, including transport to and from, for any harm, injury or damage that may befall my dog including all risk connected therewith, whether foreseen or unforeseen.
3. I hereby personally assume all risks and responsibility for any harm, injury or damage that my dog my cause including all risk connected therewith, whether foreseen or unforeseen.
4. I further save and hold harmless Released Parties from any claim or lawsuit by me, my family, estate heirs, or assigns arising out of my participation.
5. I also understand that the walks are physically strenuous activities and that the dog(s) will be exerting themselves during this activity, and if they are injured as a result, that I expressly assume all risk of said injuries and that I will not hold the above listed individuals or company responsible for the same.
6. I understand that these walks are conducted with several other dogs in locations where other animals (dogs, cattle, deer, coyotes, etc.) of unknown personality may be. I assume all risk and will not hold the Released Parties responsible for any injuries that may occur involving my dog either as instigator or victim.
7. I understand that the terms herein are contractual and not a mere recital and that I have signed this document of my own free act. I affirm that this release is binding for all claims, including but not limited to, those claims in tort and contract.
8. I understand that occasionally Steve Matthews is not able to perform contracted services. On these occasions, I authorize Canine Adventure to provide a qualified substitute individual to conduct walks or drop-in visits. I release and hold harmless this substitute individual from any liability as stated above.
