Public Hearing on unanticipated funds

Judy made a "Motion to accept the unanticipated funds in the amount of \$20,000 from Whitefield's Official Library Friends, (WOLF), in accordance with RSA 202-A:4-c. These funds are unrestricted funds to be used at the discretion of the library trustees and are accepted with deep gratitude to WOLF." Cathy seconded the motion and all were in favor.

Update CD status

We voted, via email, to renew the \$100,000 CD for 9 months at 4.16% and will mature November 20, 2025. We will renew the others as they mature. Katie thanked everyone for their quick response.

- Investment Policy update and DOJ report on private trust funds
 After reviewing policies from Littleton and Bethlem, we adopted
 this investment policy drafted by Suzy.

WHITEFIELD PUBLIC LIBRARY INVESTMENT POLICY

Whitefield Public Library invests funds received from fines, lost books, gifts, non-resident fees, book sales and income-generating equipment are invested in bank savings accounts. These funds and the income earned on them are used to fund library operations as directed by the Board of Trustees.

Funds acquired as gifts where the principal is restricted (invested to generate income) are invested with the NHPDIP through the Whitefield Trustees of the Trust Fund. The income generated from these investments shall be used in accordance with the directive established by the person donating the funds.

Funds acquired as gifts where the principal is unrestricted are invested in CDs at local banks. The income generated from these investments is used to fund library operations as directed by the Board of Trustees

The Treasurer will issue a report, quarterly, showing for each donation, the amount of income earned and the accumulated income available to be spent.

The Board of Trustees, with a majority vote, can change the selection of investments as long as the new investment avoids speculation, preserves principal, and emphasizes stability of returns.
