How do we sign up for a class?

You will need to get a Temporary Instructional Permit (Tip) from the Office Of Motor Vehicles before you can attend any class.

Temporary Instructional Permit

- Issued by Office of Motor Vehicles
- Age Requirement (14 Years Old)

Identification to Obtain A Temporary Instructional Permit

Adults:

- Certified Birth Certificate
- Social Security Card - Acceptable verification includes your W2 form, or a print out from the Social Security Administration verifying the number.
- Proof of Residence (Two documents)

Minors:

- Original Birth Certificate
- Social Security Card
- Letter of Enrollment from the school you are attending. Must be signed in Blue Ink. Can not be copied. Enrollment letter is only good for 90 days.
- Home School Students must be registered with the Board of Secondary Education of LA
- Driver's License for Domiciliary Parent giving parental consent

NOTE: Original Birth Certificate will prove who the parents are.

If there are custody arrangements with the student you may have to bring custody documents showing you are the legal domiciliary parent.

Only the domiciliary parent can sign documents at the OMV or Driving School.

Fees - \$32.25 is the Basic Temporary Instructional fee.

\$0 - \$6.00 service fee may be accessed at certain field offices

There is no additional cost to convert from the TIP to a Learner's Permit or License.

Once you have your Temporary Instructional Permit you are ready to register for a Driver's Education Course



The State of Louisiana requires a 38 Hour Course for students 15, 16 and 17 years of age before they can obtain a driver's permit.

- Students must complete 30 hours of classroom instruction
- 8 hours of behind the wheel training. The behind the wheel training is scheduled once the 30 hours of classroom instruction has been completed.
- Students that are 14 years and 9 months old can now take our 30 Hours of classroom instruction. You must wait until your 15th Birthday for your Behind The Wheel Training.

If you are 18 or older you must complete a minimum 14 Hour Course

- A Minimum of 6 hours of classroom instruction
- 8 hours of behind the wheel training.
- 18 and 19 year old students may take full advantage of our 38 Hour Course so that you can get all the experience that you need to be a safe driver.

Most insurance companies give discounts for the full 38 hour course.

30 Hours of Classroom Instruction

Your 30 hours in the classroom will consist of 4 days of training from 8:00 am - 4:00 pm with a 30 minute lunch at 11:00 am.

You can expect to learn:

- All about signs and why are they so important
- Traffic laws for Safety – Right of way laws, Speed laws, Traffic Signals and Pavement Markings
- Controlling your space and why you need a space cushion
- Basic driving maneuvers
- Nature's Laws – Understanding Stopping distances – Thinking Distance, Reaction Time and Braking Distance and how the weather can affect them
- Driving in City Traffic
- Driving on the Interstate and Highways
- Sharing the road with others
- Road Hazards
- Driver Fitness – How to avoid driver fatigue
- Alcohol and the affects it will have on you. How to recognize if the other driver is under the influence
- Owning and maintaining a vehicle

We enhance our course with videos that compliment many segments of our course. These videos show real life situations and how they can affect your everyday life.

We provide work sheets that will be used as study guides. After completing the course, students will be tested and a score of 80% is required to pass. Once the student has passed we will schedule them to drive. To make it fair for everyone, and to boost the performance level of our class, we schedule driving time by the highest grade. Whoever has the highest score drives first.

How to reserve your class?

You must attend all 4 days of class.

We will need:

- Original Birth Certificate
- Temporary Instructional Permit
- Driver's License for Domiciliary Parent giving parental consent
- Minimum \$100 Reservation Fee - (Cash or Check) No Credit or Debit Card

NOTE: Original Birth Certificate will prove who the parents are.

If there are custody arrangements with the student you may have to bring custody documents showing you are the legal domiciliary parent.

Only the domiciliary parent can sign documents at the OMV or Driving School.

Once your 30 hours of classroom instructional is complete and you passed your test with an 80% or higher, we will give you an appointment card with 4 sessions of 2 hours each session for your behind the wheel training. You must bring your Temporary Instruction Permit everytime you come to class and drive.

Once we complete the 8 hours of Behind The Wheel Training, A sealed envelope with documents needed to go to the OMV will be issued to the parent. OMV is very serious about this envelope. If it is opened everything is voided. You will also receive a Certificate of Completion to give to your insurance company. Most insurance companies give discounts for completing the 38 hour course. Now you will go to the OMV and swap the Temporary Instructional Permit for a Learner's Permit.

Learner's Permit

You will need:

- Original Birth Certificate
- Letter of Enrollment from the school you are attending. Must be signed in Blue Ink. Can not be copied. Enrollment letter is only good for 90 days.
- Home School Students must be registered with the Board of Secondary Education of LA
- Driver's License for Domiciliary Parent giving parental consent
- Temporary Instructional Permit

With a Learner's Permit they are authorized to drive with a licensed adult at least 21 years old or licensed sibling at least 18 years old. Must maintain learner's permit for a minimum of 180 days and cannot change to intermediate license until 16 years old.

Continuing Training by Parents

We can't make them drive perfect in only 8 hours but we can lay down a foundation then hand them over to you and you need to continue driving with your students. You get to build lifelong habits. You are the one getting in the car with them and making sure they are building their experience.

It is a waste of time to put a child through Driver's Education and prevent them from driving for the next year. Some people do it and the kids that did not spend the time behind the wheel forget everything. When you go back to the OMV to get their intermediate license you will have a checkoff box in the parental consent swearing to the government you did this.

Parent Training Techniques

When you get in the car with your student, you may find they are not doing things as you want and a parent may have a tendency to raise their voice. When you raise your voice to them it takes their attention away from the road and focuses their attention on you. You have to remember they are young and still building their driving experience. You need to keep your cool so they can keep theirs.

Most parents do not want to touch the steering wheel. You may have to break that habit. Place your left hand on top of your console and reach under if they start to drift and bring it back.

In a Driver's Ed car we have a passenger brake. If your child goes into a dangerous situation you can throw the car in neutral and pull the emergency brake and you should be able to stop that car.

Pay attention to where they are looking. They may not have good visual scanning patterns. Example: When you are coming to a green light, most adults will look around the intersection making sure no one is running the light or a right turn on red or doing something wrong. Kids will stare at the light making sure it does not turn yellow and when they are sure it will stay green their eyes will drop in front of them and they never look side to side.

Your Child is now 16 years old and has been training for 180 days with their Learner's Permit. You are feeling really good that they are ready for their intermediate License.

You will call All Star Driving Academy to schedule a Road Skills Test.

For the Road Skills Test we will need:

- Original Birth Certificate
- Driver's License for Domiciliary Parent giving parental consent
- Learner's Permit

Once they pass their Road Test, A sealed envelope with documents needed to go to the OMV will be issued to the parent. OMV is very serious about this envelope. If it is opened everything is voided.

Intermediate License

You will need:

- Original Birth Certificate
- Letter of Enrollment from the school you are attending. Must be signed in Blue Ink. Can not be copied. Enrollment letter is only good for 90 days.
- Home School Students must be registered with the Board of Secondary Education of LA
- Driver's License for Domiciliary Parent giving parental consent
- Must have a minimum of 50 hours driving with a licensed adult driver. (35 Day - 15 Night)
- Learner's Permit

Your Intermediate License:

- Gives Full Driving Privileges from 5:00 am - 6:00 pm
- Prohibits you from Driving between 11:00 pm and 5:00 am unless accompanied by a licensed adult 21 or older.
- Must be maintained until 17th birthday.
- Between the hours of 6:00 PM and 5:00 AM an intermediate licensee may not transport more than one passenger under the age of 21 that is not a member of the immediately family.

There is a Direct Link with kids getting killed on the highway and teenage distraction in the car. Even though the law states they can, one of the things you can do to prevent your kid from getting into a major traffic collision is to restrict who is in the car with them.

The Law states they can carpool to school between the hours of 5:00 am and 6:00 pm but they don't tell you driving in the morning before school is one of the high points of drinking and driving. It is not like people are drinking at 5:00 am but they were drinking the night before and when they get up to go to work they still have alcohol in their system and are still legally intoxicated. Mixing people like that with teenagers pulling their attention away from the road can lead to disaster. Even though the law states they can have full driving privileges between 5:00 am and 6:00 pm, you have to make sure they survive the learning process. You should restrict who they have in their car on a 24 hour basis.

At 17 your intermediate license will become a Full Class E License

License Renewals

Your driver's license will expire in 6 years from your nearest birthday. License may be renewed any time within 180 days before the expiration date. You must pass the vision exam and be required to show proof of insurance if you have a vehicle registered in your name.

Real ID Compliant

Starting October 1, 2020 the following will need a REAL ID-compliant license.

- Every air traveler will need a REAL ID-compliant license for domestic air travel.
- Visitors seeking access to military bases
- Visitors entering Federal Facilities

A REAL ID driver's license will display a gold circle with a star cutout.

A NON-REAL ID driver's license will display "NOT FOR FEDERAL IDENTIFICATION".

Distinguishing Real ID from regular license



In order to obtain a REAL ID driver's license or identification card the following five items must be verified:

- Valid Louisiana Driver's license
- Original or Certified copy of your Birth Certificate
- Social Security Information
- Proof of residence (two documents)

Unless you are changing your address, your valid Louisiana Driver's license can be one form of proof of residence, a second form could be a utility bill in your name with that same address.

Testing

As of August 2014, the Office Of Motor Vehicles assigned all testing to be conducted by the driving schools. As a result , the Office of Motor Vehicles does not conduct testing for a Class E Driver's License, Learner's Permit, or Intermediate License. The Driving Schools perform this service for their customers. This is an added benefit to the public as they don't have to wait in line to take a test. The Knowledge Test is given at the end of the 30 hours of classroom Instruction. The Final Road Skills Test is given to 17 year old students after completing training, and to 16 year old student upgrading to an intermediate license. While the Office Of Motor Vehicles did not perform Road Skills Test in the rain, we are not bound to that rule. The Road Skills Test is an additional \$40.00 fee that is not covered in the cost of training.

School Letter of Enrollment

The State Of Louisiana requires that no driver's licence can be issued, upgraded or duplicated without proof that the student is not in violation of the truancy law. So, each time a new license is printed they must have a new letter from school. An example of what the letter looks like is shown here. This is the only form that you will have to attain on more than one occasion.

- Letter of Enrollment from the school you are attending must be signed in Blue Ink.
- Can not be copied. Enrollment letter is only good for 90 days.
- Home School Students must be registered with the Board of Secondary Education of LA

What do I need to bring to class?

- Temporary Instructional Permit (You must have it on you every time you attend class or drive)
- 2- Adjustable Lead Pencils
- 1- Large Pink Eraser
- 1- 8-1/2X11 Legal Pad for notes. We provide work sheets.

What should I bring for lunch?

- A small lunch box to keep food items cool.
- Most students bring chips, hot pockets or lunchables. We have a microwave.
- Bottled drinks only for lunch. Only bottle water is allowed in the classroom.
- Lunch is at 11:00

What happens if I have to change my dates for a class?

- Your \$100 reservation fee is to reserve a seat in the class you agree to.
- If you decide to change your class date you must notify us at least 7 days before your class starts.
- Less than 7 days before your class starts you will forfeit your \$100 reservation fee.
- Students are required to attend all 4 days of the selected class.

What happens if I miss a day of class?

- Once you start a class you have to finish in that class.
- If a student misses a day of class, they will be rescheduled to start over in the next available class.
- If they attend part of class and drop out they will be billed an additional \$62.50 for each day attended and will have to start over in the next available class.
- He/she will not be eligible to receive a Certificate of Completion until the full course is taken.

When will I take my test?

- After completing 30 Hours of Classroom Instruction, students will be tested.
- A score of 80% is required to pass.
- If you fail your test, for an additional \$25 we will give you another test.

When will I drive?

- Once the student has passed their test, we will put the grades in order from highest to lowest and schedule their driving time.
- Their behind the wheel training will consist of 4 sessions at 2 hours per session.
- They will be required to arrive 10 minutes before their scheduled time to drive.
- Someone must be here to pick them up at least 10 minutes before their scheduled return time.
- If a student fails to show up for their driving time without at least a 24 hour notice they will be charged \$50.00 for every session that he/she fails to show up for.

What happens if I forget to bring my Temporary Instructional Permit, Glasses or contacts when I drive?

- Students must have their Temporary Instructional Permit to drive.
- If they wear glasses or contacts they must have them to drive.
- If they show up without their Temporary Instructional Permit, glasses or contacts they will be charged \$50.00 for that missed session.

Leaving the Property

- We do not allow them to walk off the property. Please have someone here to pick them up.

Cell Phone

- We treat our classroom just like the car. Cell Phones are not allowed during class time. If they sneak their cell phone during class, we will pick up the phone and give it to the parent at the end of the day and that student will not be allowed to bring the cell phone back.
- We allow them to use their cell phone during lunch only.
- When we get in the car, students should place their cell phone in the basket on the back seat.

Drop Off and Pickup Procedures

Dropping Off

Parking is limited. As you arrive, the student should get out of the car immediately. Parents should wait until they are inside the building and then leave to clear the parking lot for others to arrive.

Picking Up

You should arrive 10 minutes before their return time. If you are running late for any reason, your child is welcome to wait inside until you arrive. On a rare Occasion we are closed at the same time our instructors are driving. If we are closed and you are running late, we can not leave your child in the parking lot. We will get them to come ride with our next student and hopefully meet up. The problem occurs when we don't know the level of the next person driving. We could be in a parking lot, in Lafayette or on the Interstate.

Family Contract

The idea of this contract is you will go over the Cost of the Vehicle, Fuel, Monthly Maintenance, Insurance and talk about what it takes to drive your vehicle.

You will set rules such as Seat Belts, Alcohol & Drug Use, General Vehicle Use, Fuel Levels, Accident, Permission to Drive.

You make them understand that driving is a privilege which will be linked to performance at home and at school, such things as Making the bed, Cleaning their room, Mow and Weed the Lawn, Showing Respect for parents, siblings, Obeying a Curfew and making good Grades at School.

Driver's License becomes Greater Independence. Greater Independence means Greater Risk.

Your child could end up where they are not suppose to be. Maybe you can make a deal with them. If they end up in a situation like the person they are riding with was drinking or they were drinking. They may think, I don't want to be in trouble, I will risk it. You should make them understand that you will do anything to prevent that knock on your door in the middle of the night, saying they are never coming home again. You have to let them know you rather go pick them up at 2:00 in the morning instead of letting them risk it. If you decide to use this contract, Put it on your refrigerator, It is your contract with them. Hopefully it will help them make good decisions.
