We do our best to keep the number of merchants in each category to a minimum and that we make the prices for the merchant to participate affordable no matter what their budget.

The Bridal Spectacular is held in the spacious and beautiful Convention Halls A & B at the Century Center conveniently located in downtown South Bend, IN. The show time is from noon to 4 pm. We allow set up time the morning of the show. More details on setup will be sent prior to the show.

The fashion has always been a treat for the brides to-be we will be incorporating the fashion show element back into the Bridal Spectacular this year. We are planning for one fashion show to take place at 2:30 pm.

We offer two ways for the merchants to market their business:

Option 1: 10' x 10' booth piped and draped on 3 sides and includes an 8' skirted table and 1 chair. This is a typical trade show booth set up. This space is suitable for vendors with high backdrops, lights, signage or elaborate displays. More merchandise, literature, and samples can be displayed in a 10'x10' booth and there is a place to hang a large sign on the booth backdrop curtain. Additional table can be rented from Burns Rental for your booth space. Booth prices vary based on booth location and traffic flow. Prices are listed on the third page of this letter along with the show layout.

Option 2: 8' skirted table and 1 chair.

The 8' table is perfect for people who have just a small number of items to display or just have literature to hand out. This is a great way for a new business to get started. If you have a tall display an 8' space would not be a good fit for your company. Table prices vary based on booth location and traffic flow. Prices are listed on the third page of this letter along with the show layout.

As a participant in the Bridal Spectacular vendors receive the lead list of brides and grooms to-be that attended the show as well as those who pre-registered online. This list has their name, wedding date, email, address, & phone numbers. This list will be sent to you by mail or email approximately 3 days following the show. Please not we will never charge extra for this list please be aware of scammers.

Vendors planning to hand out food samples must obtain a one-day permit from the St. Joseph County Health Department at least one week before the show. Samples must not be greater than 2 oz and must be distributed by exhibitor.

Bridal Spectacular will have complete control of all aspects of the 38th Annual Bridal Spectacular. Which includes, but is not limited to, show date, time, setup, and tear down and booth assignment. We will also handle the advertising of the show. Merchants may advertise as they see fit above and beyond what the Bridal Spectacular advertises to promote their own specific company, to generate business for their business at the show. We will provide vendors with an ad for social media. If possible, please post on your social media pages.

This contact is not transferable. Merchants may not sublet their booth. No goods, literature or signs from other merchants may be displayed at the show. No literature from other bridal shows may be displayed. Merchant agrees to hang posters, & layout fliers in their place of business to help promote the show. Bridal Spectacular will supply these items around the first of December 2022

Merchant agrees to supply a door prize valued at \$25.00 or more. This must be one gift not several that add up to \$25.00. This may be a gift certificate but not a discount certificate. The certificate must allow the winner to receive something free of charge. Please turn this gift in at the emcee table at the show.

Bridal Spectacular will supply merchants renting a space with a lead list of brides and grooms that attend the show. This list may not be sold, lent, or given to anyone other than the participating merchant.
