Sanctuary Cove Memorial Service Information

The cost of a memorial service held at Sanctuary Cove varies, depending on the number of attendees. The fee is designed to buffer the environmental impact on this fragile desert environment. Fees collected by events are used to offset maintenance expenses and serve to protect this natural area for future generations.

A Deposit and Usage fee shall be required for the event. This deposit is variable, depending on the number of anticipated attendees.

A full refund will be made if event is cancelled.

The deposit will be fully refundable if Sanctuary Cove premises are left exactly as found, as determined by an official All Creeds representative. The deposit shall be refunded within a month after the event is completed. If additional charges are levied on the renters, this shall be deducted from the deposit. Any remaining deposit funds will then be returned to the renter.

Upper parking lot is available for guests, with four cars max parked at the chapel for unloading. The parking area at Sanctuary Cove, (with upper parking area opened), can hold around 50 cars. The amphitheatre can easily accommodate 150 people. The Chapel will seat about 45 people. **CAR POOLING IS ENCOURAGED** Additional car pooling parking: Coyote Trails Elementary School on Silverbell. The Community Park on the corner of Silverbell and Coachline Roads.

Music/Sound: Acoustic or portable boom box style amplification may be used. No large speakers or heavily amplified sound that could be disruptive to the environment, other visitors to Sanctuary Cove or neighborhood is allowed.

Care must be taken by the renter to keep the ceremony quiet and respectful to the meditative nature of Sanctuary Cove. Yelling, screaming or public displays of drunkenness shall forfeit the entire deposit amount.

Littering of any kind, by anyone attending the service shall forfeit the entire deposit amount.

Set up may occur no earlier than sunrise and all activities and persons must be off the property by sunset.

Deposits shall be refunded after a site inspection. The renter has the option of accompanying the ACB representative on the inspection. The refund shall be made no later than one month after the event is completed.

You will forfeit your entire deposit if you or one of your guests harms any animals or plants here.

The event coordinator must designate and have ready at least 1 person from their party prepared to meet and greet any florist, guests, or persons delivering materials for service. Sanctuary Cove staff will not be responsible for such activity prior to the service. This person must be introduced to and briefed by Sanctuary Cove staff prior to the event day.

No permanent attachments of ANY kind will be allowed at amphitheater, chapel or anywhere on the property. Portable backdrops, free standing props and substantial flower arrangements are allowed. Please check with your Sanctuary Cove contact person before making plans.

The event representative is responsible for supplying guests with directions to the Cove. Sanctuary Cove staff will supply an appropriate map for their use. The <u>Sanctuary Cove</u> phone number is not to be used as a general information line.

You have one hour maximum Cove time for your event. (Unless additional time is approved by an authorized Sanctuary Cove representative in advance.)

ALL trash and articles used for service must be properly disposed of and removed from premises or deposit will be forfeited.

I have read the above and fully understand and agree to abide by the rules as set forth by All Creeds Brotherhood. I understand that I may loose my entire deposit if I or anyone in my party violates this agreement.

Sanctuary Cove information and Release from Liability

- 1. No telephone, unless there is an emergency. Telephone is located at the caretakers house.
- 2. This is a wild place. Many creatures live here and many can harm you. Rattlesnakes, Scorpions, Javelina, Bees, and Gila Monsters all live here and are protected. <u>Remember, this is their home, you are the visitor.</u> You will forfeit your entire deposit if you or one of your guests harms any animals or plants here. Sanctuary Cove and All Creeds Brotherhood will not be held responsible for any injury sustained due to the native environment.
- 3. Electricity is available at the outdoor podium and in the chapel only.
- 4. Your event must be quiet, and respectful of other guests that may be visiting here.
- 5. Renting the Sanctuary Cove does not give you any exclusive rights to any part of the property. You cannot regulate who may walk right through your event. We are open to everyone, even during your time here.
- 6. Sanctuary Cove and its representatives reserve the right to remove anyone from the property at any time, wholly at our discretion.
- 7. Before you arrive we have cleaned and inspected the area you will be using. If you have any problems, please contact the All Creeds Wedding Supervisor. This is especially important if you find any damage to the property upon arriving. You will be held responsible if you do not bring it to our attention before your event!
- 8. These rules and conditions are intended to help preserve this beautiful spot for generations to come. Sanctuary Cove and places like it are becoming harder to find in this world. Keeping the Cove here for the enjoyment of all is our top priority. During your time here, try to make yours as well.

I have read the above and fully understand and agree to abide by the rules as set forth by All Creeds Brotherhood. I understand that I may loose my entire deposit if I or anyone in my party violate this agreement. I also release All Creeds Brotherhood and Sanctuary Cove from any claims of liability from injury, inconvenience, annoyance, or death that occur during our event at Sanctuary Cove. I understand fully that Sanctuary Cove is a wild place and therefore subject to the whims and realities of the natural world. *Event representative*
