- A Cove Rep will unlock the "upper" parking lot adjacent to the Chapel at dawn and lock it at dusk.
- Renter has access to the property for the entire day. Renter has use of the Chapel and/or amphitheater from dawn to noon or from noon to dusk.
- Please note, the Cove is open to the public, so we cannot guarantee that there won't be others present on the property during your event.

# Cove Managed means renter is provided with an on-site event manager the day of the event.

#### \*\* NOT full service event planning

- The manager will provide assistance as needed with equipment and services that have been contracted by the renter (does not include event planning services.)
- The Cove can supply the renter with PA equipment and seat pads for the amphitheater as well as parking assistance. Additional Information on Weddings at Sanctuary Cove
- The capacity of the upper parking lot is approximately 50 cars.
- Additional cars must park in the lower lot or on Scenic Drive. (We encourage ridesharing or livery for very large events)
- Rental of the Chapel and/or Amphitheater does not include use of the Cottage for wedding prep or after event reception. (These can be added on as a package.)
- All events require a refundable \$450 deposit. Deposits are returned 5-7 days after check-out via credit/debit card refund.
