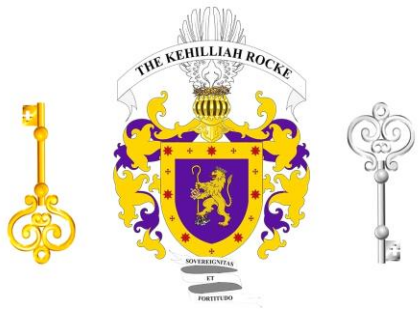

Treaty of Peace and Friendship between the Living People of the Rocke Kehilliah Nation and All Nations

Addressed to all our fellow sovereigns breathing life and truth into all peaceful governing
bodies.

PREAMBLE


In the name of the Most High, as part of His creation, we, the man, woman, ministers, and ambassadors of the Rocke Kehilliah Nation, guided by the principles of natural law and biblical law, establish this Treaty of Peace and Friendship. This treaty is between all living private men and women of the earth, recognizing the divine distinction between the spiritual and temporal realms. We acknowledge our bodies as integral parts of both realms. This private treaty is entered into on May 16, 2025, between the private individuals of the United States and the Rocke Kehilliah Trust Nation. Its purpose is to govern and benefit the people of the Rocke Kehilliah Nation and live in harmony and respect of all private people of the world.

Article I: Purpose and Intent

We, the living man and woman of the Rocke Kehilliah Nation, intend to create a framework that promotes individual sovereignty, autonomy, self-governance, and self-determination. We aim to distinguish ourselves from fictional constructs and artificial personas, reclaiming our birthright and our inheritance.

Article II: Principles

We, the Rocke Kehilliah Nation, adhere to the following principles:

- 
1. **Sovereignty:** We recognize the inherent sovereignty of the living man and woman, acknowledging their right to self-governance, autonomy, and self-determination.
 2. **Non-aggression:** We reject any form of aggression, coercion, or exploitation, promoting peaceful coexistence and cooperation.
 3. **Self-determination:** We assert our right to determine our own destiny, making choices that align with our values and principles.

Article III: Relationship with Existing Systems

We, the Rocke Kehilliah Nation, acknowledge the existence of various systems and institutions, including governments and financial frameworks. We intend to navigate these systems in a way that promotes the autonomy and sovereignty of the living man and woman, while avoiding any actions that could be perceived as entering into a treaty, alliance, or confederation with governments or acting as a public commercial government. The Rocke Kehilliah nation and our members move in the private and all of our alliances are bound in private.

Article IV: Non-Statutory Trust

We operate within our non-statutory trusts, guided by the principles of natural and biblical law. This foundation empowers us to chart our own course, unencumbered by the influence of fictional entities, human interpretations, and false claims of corporate control. We strictly abide by a one word, one definition engagement protocol leaving no room for ambiguity

Article V: Peace and Friendship

We extend an offer of peace and friendship to all living people and faiths, recognizing the inherent value and dignity of every living man and woman. We seek to live in harmony with those around us, promoting understanding and respect.



Article VI: Bodily Sovereignty and Self-Governance

The Nation of the Rocke Kehilliah shall be autonomous and self-governing, exercising the power to enforce private laws and requirements. We assert our inherent and irrevocable right to self-governance in accordance with the living principles of the Holy Scriptures and the immutable laws of nature. The concept of private property is fundamental to individual liberty and autonomy. Just as land ownership is considered a sacred right, it logically follows that the most intimate and essential form of property is the body itself. The elements that comprise the human body—air, earth-derived minerals, and water—constitute the most sacred and inviolable form of private property.

As the foundation of man's sovereignty, the body is the ultimate domain of personal autonomy. Any infringement upon this domain constitutes a trespass on the most fundamental of private property rights. The notion that statutory authorities or external entities can claim jurisdiction over the body without explicit consent undermines the very essence of private property and true liberty at its most fundamental definition.

Therefore, it is essential to recognize the absolute right to the bodily autonomy of all of the Rocke Kehilliah members, free from external control or coercion that would threaten this fundamental right. This treaty enshrines the sacred sovereignty of each member over their own body, viewing it as a temple of the Creator, worthy of protection, respect, and care. This principle is both a spiritual duty and a private right. The most sacred of private property rights of all is Our physical bodies. This perspective is rooted in a deep understanding of the body's sanctity, as described in the Bible. The concept of the body as a temple, as mentioned in 1 Corinthians 3:16-17 and 6:19-20, highlights the significance of man's sovereignty and autonomy. By recognizing the body as a dwelling place for the Spirit of Yah's Breath, members of the Rocke Kehilliah underscores the need to protect and care for this sacred space. In this context, man's sovereignty over the body is not only a matter of personal autonomy but also a spiritual imperative. By asserting



control over one's own body, we aim to ensure that the physical and spiritual well-being of our members is respected and protected under trust from the Creator. The implications for various aspects of our members' lives include:

- Bodily autonomy: The right to make decisions about one's own body, free from external control or coercion at all places and times.
- Spiritual integrity: The importance of maintaining a strong connection with one's faith and values, while respecting the autonomy of others.
- Personal responsibility: The need to take care of one's physical and spiritual health, recognizing the body as a sacred trust.

By emphasizing the importance of man's sovereignty over the body, the Rocke Kehilliah encourages and protects under trust a deeper understanding of the intricate relationships between physical, spiritual, and emotional well-being. Each member has lawfully entrusted their sovereign bodily estate to the Creator, establishing a private trust which shall be perpetually protected under the lawful and ecclesiastical jurisdiction of the Rocke Kehilliah. Any external action, mandate, or directive that attempts to infringe upon this sacred trust, including but not limited to medical intervention, biometric data collection, or bodily surveillance, without the explicit and informed consent of the member, shall be deemed a breach of private trust and a grave violation of this treaty.

Article VII: Trust Framework and Fictional Divide

We, the Rocke Kehilliah Nation, recognize that our trust framework is the vehicle that allows our Trustees to cross over the fictional divide and take advantage of our inherent usufruct. This framework is grounded in the principles of trust law, which enables us to manage and utilize our assets, property, and rights in a manner that promotes our autonomy and sovereignty.

Relevant Provisions under UFL Law

- **Section 105:** Defines the nature of a trust and the roles of the trustee and beneficiary.
- **Section 402:** Outlines the trustee's duty of loyalty, emphasizing the importance of acting in the best interests of the beneficiaries.
- **Section 404:** Discusses the trustee's duty to administer the trust, highlighting the need for prudent and reasonable decision-making.

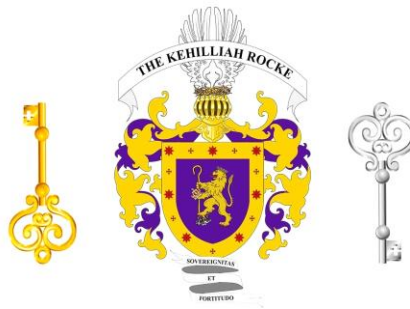
Crossing the Fictional Divide

Our trust framework enables us to distinguish between the fictional world of corporate constructs and the real world of living men and women. Through our trust framework, we can:

1. **Manage assets and property** in a way that promotes our well-being and prosperity.
2. **Assert our rights** in accordance with our values and biblical principles.
3. **Navigate complex systems** such as legal and financial frameworks while preserving sovereignty.

Article VIII: Legal Standing and International Position

We, the Roche Kehilliah Nation, act under lawful private standing and spiritual authority, not under the jurisdiction of the United States, the State, or any foreign legal construct. Our declaration is made in good faith, in peace, and in honor, and shall not be construed as hostile, deceptive, or threatening. Our treaty shall not be construed as a contract or instrument that violates any laws of good conscience or natural law. We operate within the bounds of trust, and all our lawful notices, declarations, and instruments are made without intent to infringe, threaten, deceive, or cause harm. We reserve the right to engage with others in trade and in peace. All obligations for the Roche Kehilliah and our trust community must be entered into with a one word one definition agreement and a meeting of the minds which includes an interpreter from the Kehilliah Nation so to ensure the autonomy of our members under trust.

Article IX: Potential Implications of Rejection

Should the Locke Kehilliah Nation's trust framework and peaceful assertions of sovereignty be rejected by international entities or governments, such rejection may be construed as a violation of anti-trust or restraint of trade principles, and could have the following effects:

- **Restrictions on global commerce:** Denial of our framework may limit our access to markets and peaceful trade.
- **Challenges to autonomy:** Denial of our peaceful declaration could unlawfully interfere with our natural right to self-governance.
- **Strained cooperation:** Rejection may create unnecessary conflict and violate international principles of respect and non-aggression.
- **Antitrust:** The denial of our members beneficial rights may be an act of antitrust.

Article X: Harmony with International Law

We understand and consider the following frameworks when engaging peacefully:

- **World Trade Organization Agreements:** Respecting fair access and participation in global markets.
- **Human Rights Treaties and Declarations:** Including the UN Declaration on the Rights of Indigenous Peoples (UNDRIP), which affirms the right to self-determination and recognition of spiritual, political, and social identity.
- **Vienna Convention on Diplomatic Relations (1961):** As spiritual and diplomatic emissaries, we acknowledge the principles of non-interference, the inviolability of the diplomatic man and woman, and the right to communicate freely and move peacefully between territories.

- **United Nations Convention on the Law of the Sea (UNCLOS):** Affirming the right of innocent passage and
 - **Freedom of navigation** which protects peaceful travel through international waters, over the land and through the air.
 - **Universal Declaration of Human Rights (UDHR):** Affirming the right to freedom of movement, belief, expression, and assembly.

By operating transparently and with peaceful intent, we aim to build mutual understanding and open the door to commerce, friendship, and cooperation with all.

Conclusion

By establishing this treaty between all living man and woman, we, the Rocke Kehilliah Nation, aim to promote sovereignty, autonomy, and self-governance through trust and through the private living principles under our trust umbrella. We recognize the importance of cooperation and mutual support, working together to achieve our shared goals and objectives, and we appreciate those of you who have protected our interests and who are committed to accepting a fiduciary role for the members of our trust umbrella. By the power of the Most-High, we, the Rocke Kehilliah Nation, do hereby establish this Treaty of Peace and Friendship, founded on the principles of justice, righteousness, and love. According to the glorious gospel of the blessed YHVH, with which we have been entrusted (1 Timothy 1:11), “we reject the veil of assumptions imposed by men and assert our right to follow the Word of the Scripture”. We shall pursue justice, defend our rights, and live in peace with all people, seeking to be instruments of peace and reconciliation. As it is written, "Blessed are the peacemakers, for they shall be called children of YHVH" (Matthew 5:9). May our actions be guided by wisdom, compassion, with our commitment to the teachings of Scripture.

Declaration Under Penalty of Perjury

Executed without the United States and without the need for foreign notary, by our own sovereign hands witnessing one another's intentions and expressing our self-determination upon this seal of faith.

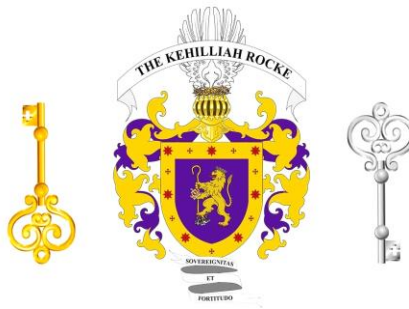

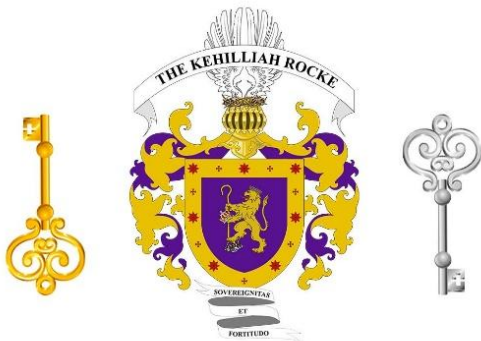
