

NOTICE OF STANDING, ASSERTION OF RIGHTS, AND DEMAND FOR ACCOMMODATION

To Whom It May Concern,

I, Cynthia-Lugo, a living woman and an ambassador of the Rocke Kehilliah Nation, hereby serve this notice upon you, the members of Rockwall County Courthouse, and all associates involved in the handling of my affairs. This notice is intended to affirm my status as a living woman, to assert my rights over my security interests, and to demand reasonable accommodations due to my communication-related disability as defined under applicable laws.

1. Affirmation of Status:

I affirm that the government has jurisdiction only over security interests, minor estates, and the estates of the disabled. I am neither a minor nor ward of the state and therefore do not fall under such jurisdiction. As a living woman, I cannot be named or treated as an entity or legal fiction.

2. Assertion of Rights:

I understand that courts and banks have, through a complex web of forms, certificates, licenses, and registrations, systematically disallowed living individuals from asserting their rights. This behavior constitutes a gross violation of my rights and perpetuates a system of fraud. I assert my lawful authority to operate in the corporate fictional world as a trustee over my private trust and affairs at all places and times under the Cynthia Felan Family Trust of Yah.

3. Notice of Conversion and Peonage:

Should you or any representatives of Rockwall County Courthouse continue to act in a manner that disregards my status and treat me as a trustee de son tort over my own estate, I will consider this a clear case of conversion and peonage. This notice serves to inform you that such actions will not be tolerated and will be met with appropriate legal response.

4. Notice of Disability and Demand for Accommodation:

As a trustee of the private property held in trust to the Rocke Family Trust of Yah, I hereby provide notice of a communication-related disability as defined under 42 U.S.C. § 12101 et seq. (Americans with Disabilities Act) and other applicable laws. As a private, non-citizen woman, I do not consent to stand under the laws of any public or corporate venue without a proper meeting of the minds and under proper treaty.

I require reasonable accommodations in all interactions with public actors claiming authority. Specifically, we demand that all communication be in writing and include:

1. Proof of lawful authority, including a valid oath and a self-paid surety bond on file for all involved in any action.
2. Acknowledgment of our disability status and accommodation request.
3. Documentation of compliance with all disability rights laws under ADA and applicable federal and commercial statutes.

We, as members, do not consent to verbal or presumed communications with any actor, individual, or entity that has not lawfully verified their authority in writing to members of the Rocke Kehilliah Nation and has come to a meeting of the minds with the Rocke Kehilliah Nation on all words and definitions in all contracts both written and presumed.

5. Right of Subrogation:

We assert our inherent right of subrogation, which empowers us to operate in and out of any roles necessary to meet our needs without interference from the fictional realm. This right allows us to assume the capacity of a trustee or any other role as required, ensuring that our actions remain aligned with our status as a living man while allowing us access to our estate as trustees. We reserve the right to exercise this authority freely, without hindrance from any corporate or governmental entities that seek to impose restrictions or limitations on our lawful activities.

6. Liability Notice:

Failure to comply with this request constitutes intentional discrimination, a violation of due process, constructive fraud, and a breach of our international treaty of peace and friendship on file with the Secretary of State. You are hereby placed on notice of liability in both your private and public capacities for any injury, deprivation, or retaliation resulting from your refusal to accommodate, honor, and protect our rights under international law and the laws of the Rocke Kehilliah Nation.

7. Requirement for Acknowledgment:

Please provide a written acknowledgment of receipt of this notice to confirm that you have recognized our standing and the implications of your actions moving forward.

Failure to comply with this notice may result in further legal action to protect our rights and interests.

Thank you for your immediate attention to this matter.


