Greetings Antonius-B: family of Massar.

This communication comes from the representatives of The Rocke Kehilliah Nation, acting in the capacity of lawful stewards and authorized protectors for the estate/trust titled "CYNTHIA LUGO HERMOSILLO", concerning the living woman and principal beneficiary known in the private as Cynthia-Lugo.

It is hereby stated for the record that:

Whereas you forced your presence and participation as attorney in case 2-17-0455 (State of Texas v. Cynthia Lugo Hermosillio) and any and all associated case numbers, stating to the woman called Cynthia-Lugo "You Have No Choice. You cannot Fire me!" your unconsented representation is therefore acknowledged strictly as fiduciary involvement for the express purpose of fulfilling obligations to the private trust estate.

Whereas, this is a Tax and Trust transaction (2-17-0455) with presumed Tax scheme and possible fraudulent activities of your fellow State government officials, we require each and every one of the following listed IRS forms completed and returned immediately so that the living beneficiary, one of our own, would be in compliance where necessary. Hence, we strictly Demand for Public Artifacts, Standing, and Tax compliance production of documents:

1. The account number of the **Disputed Ownership Fund Disclosure Statement Form 8275** that relates to Case Number 2-17-0455, NETSUITE ID Number: 2079397903, SCRAM Bracelet number: 11441, and every and any other case/account number(s) associated with THE COUNTY COURT AT LAW OF ROCKWALL COUNTY, TEXAS under the Security Interest titled CYNTHIA LUGO HERMOSILLIO;
2. BAR Card(s) and/or Bond-Number(s) for Antonius B. "Ton" Massar, Kenda Culpepper, Lea Carlson, William Michael Miller, Sophia Rodriguez, Misty Rubio, and any and every one that participated in the administration of the CYNTHIA LUGO HERMOSILLIO estate. (See 26 U.S.C. 2603, 2602, 2001 and 2002);
3. A copy of your Disciplinary Judgment dated September 27, 2019, to which you received a six-month fully probated suspension (October 1, 2019 – March 31, 2020);
Findings included: failure to adequately explain legal matters to a client, conflict of interest, and charging an unconscionable fee;
4. Certificate of Good Standing for the men and women listed above in their public capacity;

13. Receipt(s) showing paid capital transfer taxes. (See 26 U.S.C. 2603, 2602, 2001 and 2002);

14. IRS determination letter ruling on status
15. Your Foreign Agent Registration Act Certificate
16. License to do Business in Texas;
17. Certificate of registration of a foreign corporation operating in Texas;
18. Assignment documents assigning the credit account to You or any other agent in agency and or agency;
19. License to Solicit;
20. By-Laws for the State of Texas;
21. Equivalent to the FS 28.245 Transmittal of funds to Department of Revenue
22. Tax Exempt contributions Form
23. Equivalent to the Clerk of Court Revenue Remittance System (CCRRS) of Texas
24. Equivalent to the Truth in Taxation Certificate of Compliance for all counties in Texas
25. Standard GSA Form 24, 25, 25A, 28, 273, 274, 275, any and all warehouse bonds, signature bonds, bid bonds, performance bonds, bail bonds, and payment bonds whether state or federal
26. Standard Form OF 90, and OF 91
27. The Federal Reserve Form 2046 used in all account transactions regarding these Trust account 2-17-0455 and all associated account;
28. A detailed explanation, within the law of the land, for non-production of any omitted item(s) above.

We conditionally accept your forced presence in form of representation solely as a fiduciary with legal obligations to:

1. Secure and disclose all estate accounting, on-ledger and off-ledger, from all relevant agencies and/or registries as previously requested from.
2. Obtain and produce all tax-related documents and trust instruments held in the possession or custody of the Rockwall County Courthouse, or any related entity under the Trust account number 2-17-0455 and any and all associated trust accounts as listed above;
3. Ensure the immediate return of the United States Passport card, together with all proceeds from the administration of the Passport card number by the Rockwall County Courthouse and all associated trust business agencies who have administered to the Estate in any forms or manner, to which the private woman Cynthia Lugo is the sole beneficial interest holder.

4. Notify and act toward the immediate release of the living woman, Cynthia Lugo, as no verified claim, jurisdiction or lawful authority has been presented justifying her captivity.
5. Where she had noticed and rescinded all signatures and contracts to which the acting judge, the man called Brett-Allen: family of Hall is in default a for non-response beyond the time allowed, you must ensure the immediate removal of any/all monitoring or surveillance devices unlawfully attached to her body or private effects.
6. To stand within the parameters of your Solemn Sworn Oath and your allegiance to the Constitution of the United States of America, to perform those duties of providing the proceeds, products, accounts, fixtures and services thereof as "public servants." to the true, living beneficiary of the CYNTHIA LUGO HERMOSILLIO Estate.
7. Negotiate full settlement and closure of this and all associated accounts, and Facilitate the return of all rents, proceeds, and profits generated by or through the estate/trust or her physical being, including compensation for harm, trespass, peonage, or unlawful conversion suffered by the beneficiary and trust.

The purpose of this letter is to ensure that you competently carry out your duties as our public servant and fiduciary if you choose to proceed, and to clear any confusion and/or controversy that may exist. Our demands are not meant to undermine your efforts; they are simply to ensure that we have important information so that intelligent decisions can be made.

You are not authorized to create any controversy nor argue anything. You, the man called Ton Massar, are fiducially appointed to simply settle, set-off, close and collapse this Tax and Trust account number and all associated accounts.

If any of the required information is not received to the provided email address above within (72) seventy two hours [3 days] of receipt of this mailing, it will be presumed it does not exist.

Should you be **unwilling or unable** to fulfill these fiduciary duties as our public servant and as one under the obligation as the fiduciary, you are hereby required to immediately withdraw from any and all involvement in this matter. Failure to do so shall be construed as your intentional consent to include you, the man called Ton Massar, formally into the International Public Record as liable for intentional harm, obstruction of justice, Intentional fraud upon the estate, and Intentional trespass on the trust corpus, and made a subject in the forthcoming claim for remedy and relief under international and divine trust law, with damages, without recourse, without prejudice.

Please be advised that your failure to comply with this Notice constitutes willful dereliction of duty, actionable under both domestic and international laws governing fiduciaries, trustees, and foreign agents acting under color of law. Your acquiescence and non-response would be accepted as your consent for you, the man called Antonius B. Ton Massar, and your firm to be included in the claim of Trespass on Trust and International Treaties. **This Notice contrues as International Contract between Antonius B. Ton Massar, his law firm, bonds and insurance, and Rocke Kehilliah Nation, in law and in Equity.**

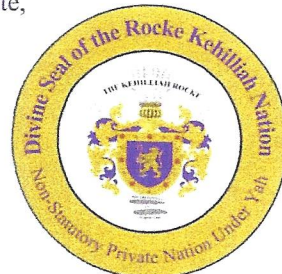

Notice Of Disability And Demand For Accommodation

To Whom It May Concern,

As an ambassador of the Roche Kehilliah Nation and trustee of the private property held in trust to the Roche Family Trust of Yah, we are providing notice of a communication-related disability as defined under 42 U.S.C. § 12101 et seq. (Americans with Disabilities Act), Section 504 of the Rehabilitation Act, and applicable state law.

In layman's terms, as private men and women we do consent to stand under the laws of any public venue without a proper meeting of the minds.

The Roche Kehilliah and its members are qualified under the disability act, we require reasonable accommodation in all interactions with all public actors claiming authority. We hereby demand and require that all communication be in writing and include:

1. Proof of lawful authority, by valid oath, and a self paid surety bond on file.
2. Acknowledgment of our disability status and accommodation request.
3. Documentation of compliance with all disability rights laws under ADA and applicable federal and commercial statutes.

We do not consent to verbal or presumed field communication with any individual or entity that has not lawfully verified their authority in writing to the Roche Kehilliah Nation. This includes, but is not limited to lawyers, officers of the courts, sheriffs, judges, state officials, federal agents, contractors, or foreign corporate actors impersonating lawful authority under color of law.

Failure to comply with this request constitutes intentional discrimination, violation of due process, constructive fraud and a breach of our international treaty of peace and friendship which is on file with the United States Secretary of State. Any and all violations are contrued as consent to be adjudicated for international Law violation and we intend to pursue accordingly.

You are hereby placed on notice of liability in both your private and public capacities for any injury, deprivation, or retaliation resulting from your refusal to accommodate, honor and protect our rights under international law and the laws of the Roche Kehilliah Nation under which we manage all of our affairs through diplomatic channels.

Private Notice of Status and Demand for Correction of Records and Fiduciary Breach

To All Whom It May Concern,

Re: Social Security Account No. **XXX-XX-X563** — Misapplication, Misuse, and Fiduciary Breach

Notice to One is Notice to All

We, the spirit-soul-body of the woman called **Cynthia-Lugo, House of Hermosillio** — a living, private woman born upon the land and soil of Texas, a natural heiress and original issuer — do hereby give **formal notice of liability** to all officers, agents, administrators, or individuals acting under color of law, assumed office, or foreign corporate authority.

This pertains to the **fraudulent assignment and continued misapplication of the artificial account and Social Security Number (SSN)** issued in commerce under the name **CYNTHIA LUGO HERMOSILLIO**, which was created without full disclosure, consent, or lawful contract. The use of this number and related trust structures constitutes a violation of fiduciary duty and constructive fraud against the living principal.

We are not a 14th Amendment "citizen of the United States" nor a consenting party to any foreign political subdivision, commercial franchise, or adhesion contract that imposes such status. I have **never knowingly, willingly, or lawfully agreed** to convert my standing as a living private woman into an artificial legal person or surety.

Fraud And Genocidal Conditions

The SSN and its related trust accounts were issued to a **minor** under coercion, concealment, and without informed consent and Full Disclosure. The systemic enforcement and presumption of this

number — as a requirement for employment, shelter, sustenance, or access to essential services — is a **calculated imposition of genocidal conditions**, in violation of:

Article II(c) of the Convention on the Prevention and Punishment of the Crime of Genocide (1948):

"Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part."

Further, pursuant to:

Article IV of the Genocide Treaty:

"Persons committing genocide or any of the other acts enumerated in article III shall be punished, whether they are constitutionally responsible rulers, public officials or private individuals."

No immunity exists under this Treaty. Each agent or public officer acting under color of authority may be held **personally liable** for violations of international law, trust fraud, identity theft, and injury to a living woman and the estate.

Demand For Correction And Remedy

As the **Original Issuer, Principal, Heiress and Beneficiary** of the associated estate/trusts, We hereby demand the following actions be taken immediately:

1. **Cease and desist** from any further presumption or commercial use of SSN XXX-XX-X563 in relation to our living body or estate;
2. **Expunge and correct** all records associating said number with the living woman called Tamara-Jean;
3. **Acknowledge in writing** that we, Tamara-Jean, are the Principal, Heiress, Beneficiary and Original Issuer of the Social Security Trust Account and Estate ;
4. **Confirm release and correction of record** to reflect our standing as the only lawful agent-in-fact over the estate.

This notice is issued **nunc pro tunc, retroactive to the date of issuance** of said number, which is **null and void ab initio** due to fraud, misrepresentation, and lack of lawful authority.
