It is pleasing to see that a number of Swimming Clubs are working collaboratively with their Councils in seeking funds to carry out much needed developments to their pools. Pools within SISA are like the majority of swimming pools within NSW. Following Australia's success at the 1956 Melbourne Olympics many NSW Councils constructed swimming pools. The majority of these pools are now over 60 years old and having provided a valuable service to the community are now old and tired, in need of replacement or major redevelopment.

Swimming like all sports within NSW must adhere to Legislation pertaining to adults and their interaction with young persons. This legislation as well as the procedures dictated by Swimming NSW detail the responsibilities that Swimming Clubs must comply with and follow. The main responsibility of Clubs is to ensure that all volunteers within the Club have a current NSW Working With Children number. Clubs must ensure that this number has been verified and recorded on the Clubs' Working With Children Register. DEVELOPMENT CONVENOR REPORT –(Billy Nicholson)

Firstly, a big kudos to Piper Stewart from Griffith for putting her hand up to shadow the development convenor's position! Piper's passion for the sport has already been proven and I am certain she will be an asset for the area moving forward.

Secondly, I apologise for not sending this information through sooner. Attached to this report is the invoice from Allen's coaches.

Now – there was a bit of miscommunication on both my end and on some of the family's ends. When calculating the price to charge swimmers for the bus, I mistakenly added 3 from Albury who had not actually confirmed their spot (this was missed with my change of email addresses). I then had a few pull-out last minute, and I believe these did not pay either. Therefore, we do not have the bus costs covered

As I never set a due date for payment and/or made a note of non-refundable terms, I never contacted swimmers who did not utilise the bus to ask for payments. I am not sure what you all think of this situation – again, I have been away on a SNSW camp and therefore have not had the chance to properly review this until now.

So, we had the following:

- Originally 14 accounted for on the bus:
 - o 3 from Albury are my fault (sorry!)
 - o 2 from Young pulled out on the Wednesday prior
 - o 1 from Cootamundra called in sick on the Friday afternoon prior
 - o 1 from Griffith who was already in Sydney but joined the bus from SOPAC to the accommodation

Please let me know your thoughts and what we should do about this. Again, I apologise and will not allow this in the future. I am happy to raise the prices of upcoming blue/green squad clinics (note that the predicted costs on the budget were an overestimate).

For the future, if we do something similar, I will implement the following process to eliminate financial problems:

- Pay to confirm a spot on the bus & for the stay at accommodation (SISA will not be able to cover as much if any next year...I have raised this with others at SNSW as I believe the location for this development meet should be changed as it is not fair on regional areas to travel all the time)
- Have a cut-off day where refunds will not be given These are the things I would have liked to have known...but hindsight is always nice!

Thirdly, we have the National Rep squad clinic this weekend. The following swimmers & coaches from our area will be attending and staying overnight (\$92.00 each ... I will pay for myself though):

CLUB SUPPORT OFFICER –(Billy Nicholson)

Clubs are beginning to gear into action now heading into the upcoming LC season. Most clubs who I have communicated with are sorted on Swim Central and have begun taking registrations. However, I have had clubs question the Southern Inland membership component on swimmer membership categories where they cannot compete in SISA events. As it currently stands, both full and club only swimmers must pay a \$2 fee to SISA on top of their registration fee. Whenever clubs have queried me on this, I have said I will check with the committee to confirm why this is the case. Also, Lockhart will be hosting a development clinic. As I am now employed by SNSW, the cost of my transport is covered and therefore we do not need to have funding for this clinic (or charge the swimmers a rego fee). I may look to do something similar at other development meets (i.e., Coleambally and Ariah Park). Chris Myers from SNSW will be doing a clinic in January (location TBC) where surrounding clubs will be invited to join in – both Chris and I will rarely do a clinic where it is exclusively for one club. We would like to have as many clubs involved as possible, and therefore I invited 6 small clubs to register for the Lockhart development day.

I have begun booking club visits around the area now that it is starting to warm up and outdoor pools are opening. Please let clubs know that I am willing to visit them, whether it is for a club night or a chat poolside while training is on.

I will also be visiting various meets over the summer. I am happy to assist with things such as set up/pack up, marshalling/check starting and even being a runner if required or you are short. So please let me know!
