Frank – cleaning looking for more \$

Can we add baseboard heat in the shack? Residual heat will cost small \$; Frank to donate baseboards and has electrician to cover about \$300; we have had leaks every year; if we kept it at even 45 then it would save the issues we are having in leaks opening; next mtg to make request for additional funds to cover

We need to put the nets in bags to prevent the rodents form getting at them; going forward in black bags; they got into bag of power nets and age through them as well; we can also set traps We must treat for the rodents causing issue in snack shack as well

Will we move forward with who we have used (NE Sports Photo – small company out of Methuen; get it done in one day; spoke with Craig who is owner); has May 14th available (but would be tight) or June 4th (more time available); usually 2-3 photographers Rich to talk to Craig about different options for organization Move forward with NESP for Spring Intown ends June 4th; weekend before is Memorial Day weekend Another option Nicki Jamison local woman with photography company; don't know her bandwidth; Rich P. suggested we ask her for proposal to know; Dennis brought up that softball going exclusively to Nicki Jamison We get kickback from NE sports and they do all the work Rich W. suggested we work on better organization

Darwin – can we schedule June meeting; Date TBD (July board meeting for placement); June 22

Rich – alternate uniforms; we have a HS team that ordered alternate uniforms that didn't receive what they expected (they are white with grey accents; historically they were white/navy); they reached out to score thinking it was a mistake; we confirmed that not mistake; teams wearing uniforms even when there wasn't a conflict; board voted to allow alternate uniforms provided they were score branded but they had to be brought to the board and approved by them; not published on website or minutes; this team would like to order a different alt uniform than our current alternates; they want white/navy blur or royal blue rather than white/grey ... we have a home and away jersey that is set; team wants to
