## Membership Class

**Founding Member** - Those persons assigned or attached to the 91st Strategic Reconnaissance Wing between the dates of 10 November 1948 and 8 November 1957 and who joined the Association between the dates of 7 September 1995 and 5 May 1996.

**Active Member** - Those persons who were assigned or attached to the 91st SRW between 10 November 1948 and 8 November 1957 and those persons assigned or attached to subsequent Air Force units designated "91st." This includes, but is not limited to, the 91st Bombardment Wing (15 November 1962 - 25 June 1968), the 91st Missile Wing (originally, Strategic Missile Wing and Space Wing) (25 June 1968 - Still Active), 91st Air Refueling Squadron, 91st Intelligence Squadron, 91st Network Warfare Squadron, 6091st Reconnaissance Squadron, etc. Also, Associate Members convert to Active Members after 2 years.

A member who has been dropped for non-payment of dues may be reinstated upon reapplication for membership.

**Associate Member** - Those persons who find kinship with the Association and support its goals and purpose. Associate Members shall be entitled to participate fully in the affairs of the Association with the exception of holding office and voting privileges. Associate Members convert to Active Members after 2 years.

**Life Associate Member** - Widows(ers) of Founding, Active, and Associate members. There are no dues for this class.

Life Associate Members whose spouse had been paid-up-for-life are automatically PUFL Active Members; other Life Associates may become Active Members by paying bi-annual dues or Life Membership dues.

**Honorary Member** - There are no dues for this class.

### Dues

**Dues: Bi-annual, \$30** - Payable no later than the month of June of even numbered years. New members' dues will be prorated, but not to less than \$15. (See table below.)
