2. **The Attic Addict** is a retail store /consignment store and agrees to make his/her best effort to sell the Consignor's goods. **The Attic Addict** will at their discretion advertise items on social media.

3. **The Attic Addict** agrees to return to Consignor, upon demand, any unsold merchandise, except under item #7 condition. The goods must be returned in the same or similar condition, unless this is impossible due to shopper damage or theft. **The Attic Addict** is not responsible for loss due to theft, damage, fire, water or any other hazard. **The Attic Addict shall not be liable for any loss, damage or diminution in value of any item(s) under this Agreement , regardless of fault.**

4. **The Attic Addict** reserves the right to price items left for consignment, based on what our shoppers are willing to pay. Even after accepting items for consignment. we reserve the right to further reject any items we feel our shoppers would unlikely purchase for any reason.

5. **The Attic Addict** accepts consignments anytime during normal business hours.

6. **The Attic Addict** agrees that all proceeds due, minus _____ commission, will be available to Consignor at the beginning the month after the item has sold. Consigner will be paid by check and can pick up at the store at the beginning of the month.

7. **The Attic Addict** will display items in the store for thirty(30) days. After thirty(30) days if your item(s) have not sold you must pick up within (5) days. If item(s) are not picked up by (5) days they become the property of The Attic Addict. **You will get a reminder by email. Please make sure you provide a legible email.**

8. Clothing and/or accessories accepted must be smoke free, odor free, pressed(if needed), in season , in style and ready to be displayed. Brands accepted may include: **Keen, North Face, Columbia, LL Bean Duluth Trading, Eddie Bauer, Alegria, Dansko** to name a few. If unsure what items we will consider, please call or message ahead of time.

9. We will at **The Attic Addict** discretion accept other items for consignment depending on space available. This may include, small pieces of furniture, knick knacks, home decor. **We also take handmade items.**

10. This agreement can be terminated by either with Consignor or **The Attic Addict** at any time.

11. Please limit amount of items you are consigning at two laundry baskets each visit or 20 items total.

12. If consigning "Holiday " items please pick up within 5 days after the Holiday. Items not picked up will become property of The Attic Addict and can be donated.

13. We ask that you make a list(inventory) of the items you are consigning at The Attic Addict for your own purpose. Otherwise, we take your items and price them, with no inventory keep. **When the item sells, you will know the item, the selling price and your pay out amount.**
