### Parent Permission for Publication of Student Photo

### Parent Permission for Trail Exploration and Water Play

Water play takes place in the form of a water table. Typically, this is a stationary table at waist level filled with 3-5 inches of water. We also fill watering cans from our rain barrels on the playground to use in watering our gardens. By undersigning I give my child permission to participate in Trail Exploration and Water Play.
