

INFORMATION ABOUT THE HUNGARIAN CULTURAL KNOWLEDGE EXAM

For applications for a National Residence Card or EU Residence Card, third-country nationals must successfully pass the Hungarian Cultural Knowledge Exam (hereafter: the exam) to demonstrate compliance with social integration requirements.

Social integration requirements do not apply for applications for a National Residence Card issued for national interest.

Unless proven otherwise, a person is considered a third-country national if they are not an EEA citizen and:

- a) They use a valid travel document issued by a third country (recognized by Hungary as a document permitting border crossing, such as a passport, identity card, or certificate confirming identity and nationality or statelessness).
- b) They cannot reasonably prove their right to free movement and residence, or
- c) No state recognizes them as a citizen under its own laws (stateless).

Applicants must take the exam before the person responsible for organizing the exam and demonstrate in writing their knowledge of European and Hungarian history and culture.

The exam language is Hungarian.

APPLICATION PROCESS

Applications for the exam can be submitted to the Government Office of Budapest. The application form must be accompanied by:

- A copy of a travel document recognized by Hungary for border crossing, confirming the holder's identity and nationality or statelessness.
- Proof of payment of the exam fee.

Applications and attachments should be sent to **kepzes.budapest@bfkh.gov.hu** or by mail to **Budapest Főváros Kormányhivatala**, **1364 Budapest**, **Pf. 234**. It is recommended to fill out the application electronically for better legibility.

EXAM SCHEDULING

Exam dates are assigned in order of application, considering the number of applicants and costefficiency.

Applicants are notified of the exam date in writing at least 15 working days before the exam via the contact information provided during registration.

The exam organizer reserves the right to change the exam dates.

Only applicants who present a valid travel document recognized by Hungary or a certificate confirming statelessness, and have paid the exam fee, are allowed to take the exam.

EXAM FEE

The exam fee is **20,000 HUF per attempt**, payable exclusively by bank transfer to the account number **10023002-00299592-00000000** at the Hungarian State Treasury, held by the Government Office of Budapest.

In the payment reference, please include: "name, magyar kulturális ismereti vizsga".

EXAM REQUIREMENTS AND TOPICS

The exam covers the following topics:

- National symbols and holidays of Hungary (coat of arms, flag, crown, National Anthem, National Song, national holidays)
- Key events in Hungarian history (foundation of the state, 1848–49 revolution and war of independence, Treaty of Trianon, 1956 revolution, 1990 regime change)
- Influential figures in European and Hungarian literature and music history
- Fundamental institutions of the Constitution (Parliament, President of the Republic, Government)
- Basic citizen rights and obligations (freedoms, citizen duties, and protection of rights)
- Europe and Hungary in everyday life

Study materials for the exam are available on <u>our website</u> and on the official website of the Government Office of Budapest. Please note that the language of the exam is Hungarian. The unofficial English study guide aims only to assist you in better understanding the material. The official material is, and should be learnt, in Hungarian.



EXAM LOCATION

EXAM DAY SCHEDULE

• 8:30 – 9:00: Registration and document verification

• 9:00 – 10:00: Written exam

• 12:00: Announcement of results and distribution of exam records

EXAM FORMAT

The exam consists of **12 questions**, with a duration of **60 minutes**.

There are **2 questions** from each of the **6 topics**, totalling **30 points**.

To pass, a minimum of **16 points** (50% plus 1 point) is required, resulting in a "pass" rating.

Scores between **0-15 points** are considered a "failure".

If an applicant fails the exam three times, they will be denied registration for another attempt.

NO-SHOW OR CANCELLATION

If the applicant does not attend or cancels the exam for reasons attributable to them and does not provide an official document justifying their absence within **2 working days** after the exam, the paid exam fee will not be refunded, and the exam will be marked as a "failure". If a valid justification is submitted within the deadline, a new exam date may be assigned.

EXAM RESULTS

The Government Office of Budapest will issue an exam record, which will be handed over to the applicant after the conclusion of the exam.
