I respectfully submit this request pursuant to principles of constitutional accountability, administrative transparency,

and the common law right of the governed to understand the lawful foundation upon which executive, legislative,

and judicial authority is exercised within the Commonwealth of Australia.

This communication is not a refusal of any lawful direction, nor is it a political allegation. It is a formal request

for clarification of constitutional instruments that underpin the continuity, validity, and scope of public power as exercised under the Commonwealth Constitution.

# 1. Constitutional Oath - Requirement for Referendum Under Section 128

Kindly provide documentary evidence confirming whether any referendum has ever been held pursuant to Section 128 of the Commonwealth Constitution to amend or alter the constitutional oath sworn by Commonwealth officers. If such a referendum occurred, please provide the date, the referendum question, the result, and the enabling legislative instruments including assent records.

### 2. Legal Foundation for the Title "Queen of Australia"

Multiple FOI responses from the Royal Archives, the UK Parliamentary Archives, and the Attorney-General's Department indicate.no records of any: (a) transfer of sovereignty; (b) enabling legislation; (c) Royal Instructions; or (d) referendum authorising

the creation or substitution of the title "Queen of Australia".

If such foundational documents do exist, kindly identify and provide them. Under the Commonwealth Constitution.

#### 3. Evidence of the Consent of the Governed.

Under constitutional convention and democratic principle, all changes affecting sovereignty or foundational structures must derive from the consent of the Australian people. Please provide the records that demonstrate when, and in what form, such consent was obtained for alterations relating to the Crown, the oath, or constitutional identity.

## 4. Lawful Basis for Current Oaths of Office.

If no referendum or transfer instruments exist, please clarify the precise legal authority under which current oaths of office are administered to Members of Parliament, Ministers, Judges, Governors, and public officers. If this authority is statutory, please identify the specific head of power relied upon.

## 5. Request for Confirmation of Lawful Authority.

As a citizen subject to Commonwealth law, I am entitled to understand the constitutional origin of the authority being exercised. I therefore request confirmation of the constitutional provisions, legal instruments, and archival documentation establishing the continuity and legitimacy of the current governmental structure.
