

# Minutes of the Annual General Meeting: RHGS 2026

## 1. Opening and Apologies

The Secretary, Howard Tonge, opened the meeting by thanking the 40 members in attendance.

- **Apologies:** 43 apologies were received. 11 Members did not respond.
- **In Memoriam:** The room stood for a minute's silence to honour the passing of **David Yadoo, Steve Pepperell, and Mark Dix** during 2025.

## 2. Minutes of the Previous AGM

The minutes of the 2025 AGM, held on 26th January 2025, were formally approved. It was noted that the increase to £30 subscriptions and the revised Knockout format introduced last year were successfully implemented.

## 3. Captain's Address

Outgoing Captain Matt Flack reviewed a successful year:

- **Participation:** Average attendance rose to 32 players (up from 28).
- **Fixtures:** All matches were well-received. The Betchworth postponement is now rescheduled for 26th March 2025 as Marcus' Past Captains' Day.
- **Socials:** Successes included the Captain's Cheam Curry and the Summer Lunch at Cuddington.
- **Membership:** The roster stands at 86 members; six new members were officially welcomed.
- **Legacy:** Development is underway for a new "Family Affair" competition in 2026.
- **Thanks:** Matt thanked the Members and the Committee for the support throughout the year.

## 4. Treasurer's Report

Bob Tisdall presented the 2025 accounts:

- **Financials:** Income of £20,563 against expenses of £17,033, resulting in a net contribution of **£3,529**.
- **Credits:** The Society currently holds £3,445 in member credits (primarily from the Betchworth postponement).
- **Resolution:** A proposal to maintain the annual subscription at **£30** for 2026 was **carried unanimously** by a show of hands.
- **Mrs Tonge:** The Treasurer said that he was indebted to Mrs Tonge for managing the Railway Hotel Golf Society accounts and proposed that the Society give her a £100 gift voucher. This was carried unanimously.
- **Accounts approval:** *"Ladies and Gentlemen, I'm pleased to report that the society is in its best financial shape for several years. Despite rising costs elsewhere, we managed to triple our surplus this year to over £3,000. This was driven by a healthy intake of new members and very tight control over event costs. We have over £6,000 in the bank and our 2026 bookings are already being secured. I move that the accounts be approved."* By a show of hands, the accounts were approved.

## 5. President's Address

Adrian Blows formally concluded his three-year term as President.

- **New President:** **Len Singh** was ratified as President (2026–2029). Len addressed the room, reflecting on his journey with the Society since joining in the 1980s.
- **New Role:** Adrian Blows continues in the role of Society Auditor and is currently researching a potential European Away Trip.
