## **Assumption of Risk and Hold Harmless Agreement.**

Studio Steeds, inc. and/or FSEC/Fire Storm Equestrian Center and/or Water Tenders, Inc and/or West Coast Water Tenders and/or West Coast Rentals and/or Coulombe Family and/or any and all of their affiliated Trusts and/or Sarvis Family and/or Simons Family and/or Gros Family and/or their corporate officers and/or shareholders and/or parent companies, and/or affiliated companies and/or handlers and/or subsidiaries and/or named above subcontractors and/or named above employees and/or named above helpers and/or volunteers and/or other persons acting on their behalf and/or in concert with them (hereinafter ~LESSOR~).

I, on behalf of myself and my personal representative, heirs, guardians, guest, next of kin, future in-laws, spouse, spectators, planners, coordinators, venue, vendors and assigns, and on behalf of my minor child (ren), (hereinafter ~ LESSEE ~) **DO HEREBY AGREE THAT:**

(a) In consideration of the use of the rental / use / barrow / lease / purchase of horse / livestock / equine / carriage / carts / services / handlers / wranglers / costume / tack / equipment / vehicles / tractors and trailer the undersigned recognized and agrees that participation in horse / pony / livestock / caring for / exercising / grooming / tacking / putting in and out of trailer / trailering / tying to trailer / training / learning / instructing / assessment of ability / sports / being led / riding / carting / driving / games / handling / helping / inspecting /coordinating / stunt coordinating / wedding activities / being in presence of / interacting with / feeding / photographing / filming / displaying and any and all related activities (hereinafter ~ HORSE (s)~) is **DANGEROUS AND HAZARDOUS, AND MAY EVEN LEAD TO INJURY, PERMANENT INJURY, OR DEATH.**

(b) **I RELEASE AND FOREVER DISCHARGE LESSOR, FROM ANY AND ALL CLAIMS, LIABILITIES, AND LOSSES BASED ON NEGLIGENCE PASSIVE OR ACTIVE, STRICT LIABILITY, FAILURE TO WARN OR OTHERWISE, AGREES TO HOLD HARMLESS, REGARDLESS OF NEGLIGENT ACTS OF OR OMISSIONS,** the LESSORS for injury, permanent injury, death, losses of any kind, damages to LESSEE or any other person, property, directly or indirectly arising out of or resulting from HORSE and all other HORSE sports/activities (whether or not under the supervision of parents and/or wrangler, and/or trainers, and/or handlers and/or instructors and/or assessment of skills personnel and/or LESSOR and/or HORSE) (whether owned, rented, leased, borrowed, using, acquiring property and/or HORSE of LESSOR, or otherwise) The LESSEE shall indemnify and hold harmless the LESSOR from any and all liabilities, claims of any kind, damages, costs, expenses, losses of any kind including any and all liabilities claims of any kind, damages, costs, injury, permanent injury, fatal injury, judgment, claim expenses, losses of any kind incurred as a result of contributory negligence of the LESSOR and/or the sole negligence of the LESSOR.

(c) LESSOR may NOT assess correctly the skills and/or experience of ability of HORSE(s) and/or LESSEE (1) HORSE(s) present in the area may have been known to bite, buck, rear, kick, bolt, become uncontrollable or misbehave without warning. In consideration of acceptance of HORSE, LESSEE authorize the LESSOR to market, transfer, assign, or otherwise make use of any photographs, likenesses, films, broadcasts, cable casts, audio tapes, or video tapes taken of the HORSE(s) and/or LESSEE and/or participant(s) in any way they see fit or promotion, coverage, or benefit of the event, or service, and hereby expressly and irrevocable waive and release any rights in connection with such use, including any claim to invasion of privacy, right of publicity, or to misappropriation, **LESSEE VOLUNTARILY ELECT TO ASSUME ALL RISKS, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS,** connected with the entry and/or deposit and/or hired by production company and/or HORSE activities of ME and/or MY HORSE(s) and/or my property onto the premises of the LESSOR and/or adjacent areas, and/or job site, and/or offsite location and/or wedding venue and with participating ACTIVITIES involving HORSE(s) LESSEE accept all responsibility for the safety of everyone in their party.

(d) LESSOR highly recommends to possibly help mitigate severity of bodily injury and/or permanent injury and/or fatal injury to LESSEE. LESSEE should bring and wear their own fitted personal certified riding helmet and safety gear at all times while participating in HORSE ACTIVITIES. **LESSEE VOLUNTARILY ELECT TO ASSUME ALL RISKS, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS,** connected with LESSEE use of LESSORS tack / costumes / helmet / safety gear/ HORSES and LESSEE should inspected and immediately cease use of any and all prior to their use. LESSEE inspection of tack / costumes / helmet / safety gear / HORSE(S), LESSEE does so voluntarily at their own risk of tack / costumes / helmet / safety gear/ HORSE(S) malfunction/failure and/or not fitting properly and/or it's failure and/or its fitness and/or it correct and/or incorrect certification to help mitigate severity of possible bodily injury and/or permanent injury and/or fatal injury to LESSEE. If LESSEE chooses not to wear any or all helmet and/or safety gear, LESSEE does so voluntarily against LESSORS recommendations.

(e) If any portion of this agreement is held invalid, the balance shall continue in full force and effect . I have not signed or agreed to this agreement in reliance of any representation or inducement of the LESSOR.
