## **Glamping Tent Terms and Conditions**

The Client, by placing an order via email, phone, social media messaging systems, or [www.fairytaleforts.com](http://www.fairytaleforts.com) agrees that they accept the conditions of the rental agreement.

Rental Charges - Unless prior arrangements are made, rental charges are for the evening of the agreed booking date.. The rental charges are for the agreed period at the time of booking. If the equipment is unavailable for collection, Struble Enterprises Incorporated reserves the right to charge the client for extra time (\$25 per hour extra).

### **Booking**

The client will be supplied an email confirmation of their booking. A \$50 deposit is due at the time of booking to reserve the requested date.

A travel fee of \$0.60 per mile X 4 will be charged for bookings outside a 10 mile radius of Hampton Township.

### **Use of Equipment**

Please ensure that all guests respect the equipment supplied and treat it with care. No pens, pencils, markers, or sharp objects that could puncture the sides or floor of the tent or the air mattresses are allowed.. If you choose to provide your guests with refreshments, we ask that tomato-based foods, pasta, greasy or messy foods are not served on or around the pillows and blankets. Please, no jumping on the air mattresses. It is requested that shoes be left outside the tent to help prevent dirt/mud from getting on the rug and tent floor. The tent is waterproof, but if portions of the tent/roof are touched during a rainstorm, it is possible that water may enter the tent.

**If adding the movie option to your glamping experience, the client agrees to provide the streaming device and streaming provider.** A Roku does accompany the projector. The client is responsible for wifi connection. A

speaker will be provided and plugs into a headphone port. The client is responsible for wifi connection and movie streaming.

**We require a smoke-free environment.**

### **Payment**

Payment is due 3 days prior to the event via cash, Venmo, PayPal or check.

### **Cancellation**

Fairytale Forts understands that inclement weather can affect the ability to carry out a comfortable glamping experience. If the client cancels due to weather, there will be no charge to the client. Fairytale Forts reserves the right to cancel due to extreme weather.

### **Set-up Times**

We require a 2 hour set-up time. We request that you help make this time as uninterrupted as possible. Arrival set-up and collection times will be arranged at the time of booking subject to Fairytale Forts availability.

### **Positioning/Setting up of Equipment**

Movies work best at dusk/dawn. It may be difficult to view the movie on the screen during daylight hours. Please have the designated party area clear of furniture and clean prior to our arrival. The Client is responsible for indicating clearly the location of the assembly or dismantling of the equipment. Struble Enterprises Incorporated will take every care but shall not be liable for any damage to the site, site access, furniture or personal belongings.

### **Cleaning**

The client does not need to sanitize any rental equipment, but any spillages should be wiped up immediately. Please let us know if there are any stains that may require extra attention. (Stains that cannot be removed may result in a replacement fee.) Everything will be dismantled by Fairytale Forts. A \$25 cleaning fee will be incurred for soiled linens. Great care is taken by Fairytale Forts to sanitize every piece of equipment after each use.

### **Insurance**

Insurance is the Client's responsibility during the rental period. Struble Enterprises Incorporated is not liable for any accidents that occur during said rental period. The Client accepts all liability when booking a rental from

Struble Enterprises Incorporated. The Client is responsible for the security of the equipment at all times during the rental period. Any lost, broken, damaged or destroyed equipment will be charged to the client at full replacement value.

### **Liability to Third Parties**

Struble Enterprises Incorporated will not be liable for any claim of personal injury, death, loss or damage to the property.
