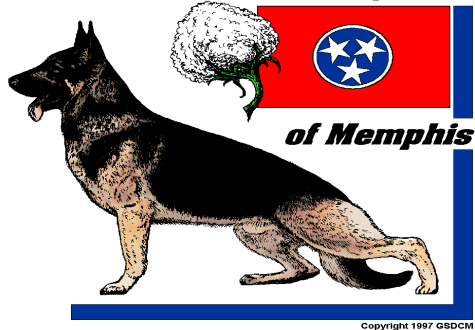

## Trial Information

### Trial Site Hours:

Saturday and Sunday: 7:30am until 30 minutes after the conclusion of the last Trial.

**CRATING** Due to limited space, please crate from your car.

**No Un-Entered Dogs.** Exceptions will be made for handlers with multiple dogs in the same class, mobility and other issues.

**Both Trials Combined Limited to 8.0 Hours of Judging Per Day.** Trials will run concurrently. Entries will close when limit is reached, even if this occurs before the official closing date. **A wait list will be established** to fill openings created by entries that are withdrawn prior to the event closing day.

Bitches in Season are not allowed on the show grounds.

Entry confirmations/arm band numbers and judging program will be sent via email, unless otherwise requested by the exhibitor.

Obedience Classes will run in HEIGHT ORDER from tall to small

Transfers **DAY OF transfers WILL NOT be allowed.** Transfers close at 5:00pm on the day prior to the trial. Request must be in writing prior to the event. It is recommended that transfer requests be sent by email to the Trial Secretary prior to day of show. If an email address is provided with your request, an email confirmation will be sent.

Recording Fee of \$0.50 cents and a \$3.00 AKC Event Service Fee will be required for the first entry of each dog and a \$3.00 Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC Licensed or Member Club Events. (Chapter 11, Section 2 of the Rules Applying to Dog Shows).

Entries must be signed and include the full page AGREEMENT on the back of (or attached to) the entry form. Incomplete entries are not valid and WILL BE RETURNED.

### **PLEASE NOTE – WARM UP INFORMATION**

To avoid unnecessary distractions to the dog showing, **no warmup allowed in room with the ring.** Only the *next dog in the ring* is allowed in the room with the ring.

## Notice to Exhibitors

**The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 48 hours, please re-send your email.**

The safety of the dogs and exhibitors is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport. Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules and COVID waiver. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries..

Post Dated and Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Since bitches in season are not allowed to compete in AKC Obedience/Rally Trials, the club will refund all but

\$5.00 of each entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such a claim before judging commences.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children.

Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on lead or crated at all times except when in the ring. All 'warm ups' MUST be done ON LEAD. That means the lead is attached to the dog's collar and the handler is holding the lead.

Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. German Shepherd Dog Club of Memphis has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date other than change from A to B with written request. No refunds for duplicate entries.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

German Shepherd Dog Club of Memphis, Inc. its Board, Members and Training on the Square/Vicki Harrison and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs at this event.
