Trial Information

Trial Site Hours:

7:30am until 30 minutes after the conclusion of the last Trial.

CRATING Crating under cover is extremely limited. Please crate from your car.

Both Trials Combined Limited to 8 Hours of Judging Per Day. Trials will run consecutively. Entries will close when limit is reached, even if this occurs before the official closing date. A wait list will be established to fill openings created by entries that are withdrawn prior to the event closing day.

Bitches in Season are not allowed on the show grounds.

Entry confirmations/arm band numbers and judging program will be sent via email, unless otherwise requested by the exhibitor.

Course maps will be send out on Saturday evening, after 6pm. Please bring them with you to the trial.

Rally Classes will run in HEIGHT ORDER from tall to small

Transfers will be allowed for these trials until Thursday, April 10 at 5:00pm.

Request must be in writing prior to the event. It is recommended that transfer requests be sent by email to the Trial Secretary prior to day of show. If an email address is provided with your request, an email confirmation will be sent. **NO TRANSFERS AFTER THIS DATE. NO TRANSFERS AFTER THE FIRST TRIAL IS COMPLETE.**

Recording Fee of \$0.50 cents and a \$3.00 AKC Event Service Fee will be required for the first entry of each dog and a \$3.00 Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC Licensed or Member Club Events. (Chapter 11, Section 2 of the Rules Applying to Dog Shows).

Entries must be signed and include the full page AGREEMENT. Incomplete entries are not valid and WILL BE RETURNED.

Lunches on Site

Lunch is available PRE ORDER ONLY for \$12. This includes mixed sandwiches, chips and desert/cookie. A signup form is attached. Please include lunch payment with your entry check. Please bring your own beverages.

Notice to Exhibitors

The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 48 hours, please re-send your email.

The safety of the dogs and exhibitors is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport. Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entries must be made on Official AKC Entry Forms. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries..

Post Dated and Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Since bitches in season are not allowed to compete in AKC Obedience/Rally Trials, the club will refund all but

\$5.00 of each entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such a claim before judging commences.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children.

Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on lead or crated at all times except when in the ring. All 'warm ups' MUST be done ON LEAD. That means the lead is attached to the dog's collar and the handler is holding the lead.

Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. German Shepherd Dog Club of Memphis has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date other than change from A to B with written request. No refunds for duplicate entries.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

German Shepherd Dog Club of Memphis, Inc. its Board, Members and Chartam Farm/Tammy Ellis/Charlie Ellis and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs at this event.

German Shepherd Dog Club of Memphis, Inc. does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION.
