

KEY SAFETY CONCERNS

- DNA CONTAMINATION CONFIRMED. Laboratory testing by virologist Dr David Speicher and nine independent labs worldwide confirmed all tested vials were heavily contaminated with synthetic DNA.
- At least one of the contaminated Australian batches was administered to New Zealand children.
- Lipid nanoparticle encapsulation may allow synthetic DNA to integrate with our own DNA, with potential to cause permanent genetic changes and heighten cancer risk.



UNPRECEDENTED ADVERSE REACTIONS

Pharmacovigilance reporting systems worldwide immediately showed unprecedented numbers of safety signals which have been ignored:

- Significant increases in death and disability following vaccination campaigns, particularly among younger people.
- Acceleration of cancer diagnoses, including rare and rapidly progressive cancers ("turbo cancers").
- Rising reports of sudden deaths in previously healthy individuals.
- Pervasive immune system damage.

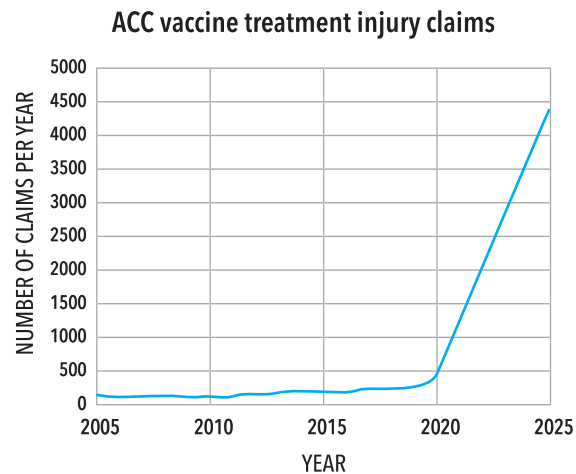


Why is Health NZ/Te Whatu Ora continuing to promote the Pfizer jabs for use in pregnancy when there is NO long-term safety data?

Did you know?

mRNA is a novel technology. Pfizer jabs are not usual vaccines and are actually classed as genetic therapies.

Pfizer stopped the one and only randomised control trial that would have definitively shown if their mRNA 'vaccine' was safe in pregnancy.

There has been no follow-up of vaccinated mothers and their babies. A Liggins Institute (NZ) study was abandoned after a few months. **Why?**

Pfizer wanted all information from its Covid vaccination trials to remain hidden for 75 years. US courts ordered that their data be released, revealing 9 pages of side effects. These include myocarditis/pericarditis, blood clots, strokes, heart attacks and autoimmunity.

The AstraZeneca Covid-19 jab was withdrawn worldwide because it was causing (fatal) blood clots.

How many people know that the Pfizer jab is a gene therapy with no long-term safety studies?

INFORMED CHOICE requires full information disclosure, including risks.

NEW DATA IS RAISING MORE RED FLAGS

Increased rates of fetal loss

A recent analysis of Israeli data has shown evidence for a substantially *higher-than-expected* number of eventual fetal losses associated with Covid-19 vaccination during gestational weeks 8-13.

Reduction in ovarian egg supply

A study published in the journal *Vaccines* has shown a significantly detrimental impact of Covid-19 vaccination on ovarian reserve in rats prompting a call for further investigations into the vaccines' effects on human ovarian reserve.

Increased rates of thrombocytopenia associated with vaccination

A Pakistani study has shown a significant relationship between Covid-19 vaccination and thrombocytopenia and the authors suggest the need for a wider study to investigate further.

Adverse effects on fertility

Analysis of data in the Czech Republic has shown a significantly lower rate of successful conceptions (conceptions leading to live births), for women vaccinated against Covid-19. The authors call for further studies into the potential influence of Covid-19 vaccination on human fertility and fecundity.
