In addition, all Food Vendors that are cooking or heating that produces grease laden vapors or utilizes open flames are required to have an approved and up-to-date tagged Class K fire extinguisher in their assigned booth area and readily accessible. For all other cooking operations, a 2-A:10BC extinguisher is the minimum requirement.

All Booths / Area Spaces must be paid for -- **NO LATER THAN September 7, 2018** to ensure availability and confirm your concession stand or space.
