

# No Work, NO Pay Guarantee Trial

## Terms & Conditions

**The Trial Company/Person/Farm** - is the company/person/farm undertaking the No Work, NO Pay Guarantee trial on a nominated farm.

**Retail Supplier** - is the nominated supplier to The Trial Company/Person/Farm

**Advanced Nutrients® Pty Ltd** - Supplier of the trial product AquaMate®

1. Promotion Date
  - 1.1. The commencement date of this - No Work, NO Pay Guarantee trial, is the November 1, 2024, and will finish on March 29, 2025, or on the date the nominated quantity of promotion product is used prior to his date.
2. Max Quantity of Trial Product
  - 2.1. A maximum of 4L of AquaMate® concentrate per company/person/farm will be supplied for the trial.
  - 2.2. The nominated Retail Supplier of the company/person/farm will be sent a wholesale quote and company/person/farm will be sent a quote including freight to closest town of the trial product
  - 2.3. The trial must be completed within 2 months of product shipped to the trial site, if not product must be sent back to Advanced Nutrients® Pty Ltd at the cost of the trial. company/person/farm.
  - 2.4. If required Advanced Nutrients® Pty Ltd can supply a small sample of AquaMate® to test plant and product efficacy and safety prior to trial.
3. The Trial
  - 3.1. Before a trial is agreed to and product sent, an Advanced Nutrients® Pty Ltd representative must view pictures of the issue on the farm and or undertake a site visit.
  - 3.2. Determine mode of measurement that is currently undertaken to monitor irrigation system. Take photos of pipes or system prior to and after application.
  - 3.3. Determine water application rate on the farm to determine the application rate of AquaMate® per hour across the area of the trial site.
4. Product Stock
  - 4.1. Advanced Nutrients® Pty Ltd holds the right to refuse a No Work, NO Pay Guarantee trial at its own discretion.
  - 4.2. If the product AquaMate® is not available Advanced Nutrients® Pty Ltd holds the right to not accept an offer for a No Work, NO Pay Guarantee trial.
5. Payment
  - 5.1. Account Prior to commencement of trial, the trial company must be approved or have its retail supplier approved for an account with Advanced Nutrients® Pty Ltd.
  - 5.2. The trial company or its retail supplier will be invoiced the amount payable for the 4L of AquaMate® Concentrate and freight ex Brisbane with extended terms based on one week after the trial ends. Once it is determined the trial was successful the company or its retail supplier will pay for the product AquaMate® with a Maximum of 4L. If it is determined the trial failed the invoice will be cancelled.
