



# 2025 Non-Profit Application

The Hinesville Farmers Market offers a unique opportunity for non-profit organizations to fundraise, create awareness, and promote their causes. The Market is conducted Thursdays (3 to 7 p.m., March through October) at BRADWELL Park/107 S. Commerce St. Non-profit space is limited to two (2) agencies per week at no charge. The non-profit booth has become a beneficial and popular outlet for several local groups. Early requests are recommended while free booth dates are available.

**SET-UP HOURS, REGULATIONS & UTILITIES:** Set-up time is 2 p.m. Non-profit booths are generally set-up in a prime area. Booth staff/volunteers must follow the same guidelines as the vendors and may not enter the market area before 2 p.m. unless approval is received. Market staff will communicate via e-mail for booth placement prior to market. The Booth must be completely set up by 3 p.m. and remain set up until the Market closes at 7 p.m. Early tear-downs are not permitted! Vendors arriving late to the Market **MUST** check in with the Market management before entering the event area and may be denied permission to set up. Vendors are responsible for all set-up items such as tables, chairs, canopies. All activities must occur in the assigned booth area. Shade during the summer months is highly recommended. Tents/canopies must be secured to sustain wind gusts as required by the City of Hinesville Inspections Department and is a condition of our event permit. They must have 25lbs per leg consisting of a tent weights or sandbags, not bricks, water jugs, or stakes. **Only whisper-soft/quiet generators such as the Honda EU series inverter models or equivalent are allowed and must be pre-approved by HDDA staff.**
